STARKE. Douglas Starke, planter, Revolutionary soldier, at fall of Charleston 1780, Justice Peace 1787. Reuben Starke, probably son of Douglas, State Senator from Kershaw County 1812. Wyatt W. Starke, son of Reuben, attorney at law Camden, member Legislature 1816, died about that time, a young man. Turner Starke, Sheriff of Kershaw County 1810.]

ALEXANDER.

Dr. Isaac Alexander was of a distinguished North Carolina family. His father, Abraham Alexander, enjoyed the honor of presiding over the famous Mecklenburg Convention of 1775, at Charlotte. The family had migrated to North Carolina from Cecil County, Md., in the early part of the 18th century. Dr. Isaac Alexander graduated from Princeton College in 1772, in the same class with James Madison and Aaron Burr. On his return to Charlotte, he entered upon the practice of medicine, and served for one year as first President of Queen's Museum. He removed to Camden about 1784, where, for nearly 30 years, he was a leading physician and citizen. He had been a surgeon in the American army during the Revolution, and was a participant in the disastrous defeat of Gates at Camden, rendering important aid to the wounded and attending the Baron DeKalb in his mortal illness. Although not an officeseeker, Dr. Alexander was called upon to do public service. He represented the county in the Legislature in 1786, was Intendant of Camden, and served as one of the first Trustees of the South Carolina College. He was also for many years an elder in the Presbyterian Church. He died in 1812, and is buried in the Presbyterian graveyard.

Dr. Alexander's first wife was Margaret, daughter of Dr. William Brisbane, of Charleston. This excellent woman, one of the builders of the first Presbyterian Church erected in Camden after the Revolution, died in 1801, at the age of 44. She left one child, Amelia, who

married Wm. Adamson, Esq.

His second wife was Sarah Thornton, of New York, a sister of Phineas Thornton. This marriage took place in 1807. Of it there were two children, Isaac B. Alexin 1807.
