Byers' grandson, ex-Congressman FINIS EWING McLEAN, said that Byers' wife was ELIZABETH WALTON of Rockbridge County, Va. and that they lived 30 miles from Natural Bridge. Rockbridge was not formed until 1778. Byers' survey was granted in 1760 by Virginia to Edward Sharp, he Byers evidently moving on to what is now York County, S. C. This was a lucky find. I had been hunting it for about 20 years. It is nice when some of these stories can be checked out.
