A large land owner of James City, north of the James River, was Richard Bell, who, with Christopher Lawson, patented 500 acres in J. C. May 23, 1637 "at a little Indian field over against John Dansey" (C. P. 58). Christopher Lawson, on May 1, 1638, patented 400 acres in James City, south of the River, at the head of Rolfes Creek (later called Smith's Fort Creek) (C. P. 89). On Dec. 25, 1642, Thomas Wombell patented 650 acres next to Richard Bell (C. P. 141). Thomas Wombell next patented 1100 acres in Isle of Wight and Richard Bell was a headright (C. P. 176). Often old settlers returning from England sold their headright. Robert Holt, Jan. 20, 1650, patented 1560 acres, "560 acres being granted unto Richard Bell, April 10, 1642, and by John Waddington who purchased it from John Allison and Dorothy, his wife, sold unto Holt" (C. P. 215).

Sir William Berkeley patented 2090 acres in James City, "300 acres upon head of land of Richard Bell", x x 1090 acres known as "Green Springs" (C. P. 415). Both Christopher Lawson and Thomas Wombell settled in Isle of Wight. It is not known what became of Richard Bell. He may be the ancestor of the Surry family. The James City records were burned in Richmond.

The first one of the name from whom the Surry family descends is John Bell who was born in 1668. He testified in a law suit in Surry, July 9, 1705, that he was 37 years old. John Bell married Ann Bennett, daughter of Richard Bennett, Jr., of Isle of Wight. On August 30, 1694, Richard Bennett, Sr., of Isle of Wight, made a deed of gift to Ann Bell "the now wife of John Bell, lately Ann Bennett, daughter of Richard Bennett, Jr., Isle of Wight" (Surry W. & D. Bk. 1693-1707). John Bell died intestate in 1713 and an inventory of his estate was filed by Ann, his wife, as administratrix.

- I. Joseph, of Lawnes Creek Parish, made his will Jan. 5, 1731/32, probated July 18, 1733. He gave a legacy to cousin (nephew) BURRELL BELL 150 acres, residue to brother JOHN BELL, he to be executor. Wits.:Gregory Rawlings, John Clark (1730-38, p. 311)
- II. John, mentioned as a brother of Joseph, made his will in Albemarle Parish, later Sussex, April 19, 1746, probated June 18, 1746. His wife was Hannah who made her Will in Sussex in 1768. Children mentioned in their Wills were:

- 4. Balaam, m. Mary. He and wife Mary had one daughter shown in A. P. R. Phoebe bapt. Nov. 8, 1755. Sponsors: Abraham Brown, Lucy Johnson, Phoebe Lofting. Balaam died in 1755, inventory of estate filed by wife Mary in that year.
- 5. James, m. Mildred, dau. of George Robinson. He was given a plantation of 500 acres N. side Spring Swamp by his father. James was a Baptist Minister. He made his will in 1778 as follows: Executors, friends and brother in the ministry David Tinsley, John Williams, Jeremiah Dargan. to son GEORGE the plantation where John Williams live. Wife MILDRED; son BENJAMIN 5 years schooling at least; son BALAAM, dau. REBECCA; two youngest daughters MILDRED LUCAS BELL and SALLIE WILKES BELL; my brother in Christ, BUCKNER LANIER to assist with authority over BALAAM. Exrs. son GEORGE, and friends Sylvanus Bell and Gray Juakins. Wits. Robert Jones, John Bell, Silva Nusum, Ann Field.

Anne Bell of Southwick Parish made her will Nov. 11, 1776, probated Sept. 23, 1777, as follows: All estate to be sold and money divided equally among the children my daughter may have by SAMPSON CLARKE when they are 21, remaining three parts to my children MICAJAH, LUCY and BENJAMIN BELL. two sons exrs. Wits. William Hart, Wm. Pleasant.

John Bell, son of John and Hannah Bell, inherited 135 acres on the s.s. of Spring Branch from his father. He married Phoebe, daughter of Sylvanua Stokes and wife, Cecilia Walker. John Bell died May 25, 1748, reported by Gregory Rawling (A. P. R.) His children from A. P. R. and mentioned in the will of their grandmother Hannah Bell were:

Benjamin, son of John and Hannah Bell, is mentioned in the will of his father, John, in 1746, and in the will of his mother, Hannah, in 1768. He married Martha, daughter of Robert Wynne. (See VHG-). After the birth of his first three children, Benjamin moved to the 96th District of S. C. and settled in what is now Edgefield County. There are several land plats for him there, one was for 100 acres on Gills Creek in Craven, 1764. Three children are shown in A. P.R.:

 of Shreveport, La., has a diary of her great great grandmother,
 Elizabeth Watson Ogilvie, who lived to the age of 92 and who
 stated in her diary:

"My mother's maiden name was HANNAH BELL who, with her parents, came from near PETERSBURG, Va., and first settled in Congaree, from thence they moved to Edgefield District (S. C.) several years before the Revolutionary War. I have no recollection of my father (ARTEMUS WATSON) as he died when I was an infant. My mother was left a widow with three children. Sister Rebecca (Mrs. Lowe), Benjamin and myself. She then married Burdett Eskridge, by whom she had one child, a daughter, Martha. Escridge, my stepfather, was a true Whig, and volunteered on a scouting excursion under Capt. Starling Turner down the country against the Tories at a place said to be Orangeburg. Capt. Turner with his entire command was surrounded and butchered in cold blood. My step-father and a maternal Uncle (BENJAMIN BELL) were of the number. This was the bloody work of Bloody Bill Cunningham, the Tory Captain. Several years afterwards, about five I think, my mother married Daniel Bullock, a Virginian". Later in her diary. Elizabeth Watson Ogilvie states; "James Ogilvie and I were married Sept. 1, 1797, by Uncle WILLIAM DANIEL. We lived with my brother. BENJAMIN WATSON (who fell heir to the land on which I was raised by virtue of the law of primogeniture) for one year. The year 1799 we lived with old Mr. John Douglas. The year 1800 we lived with old Mr. Z. S. BROOKS".

Burdet Eskridge was a soldier in Captain Sterling Turner's company shown on page 17 V. H. G. He fell in the Cloud Creek Massacre which is related on page 11 V. H. G. Several of the Watsons fell in that massacre. Jacob Smith and Enoch Grigsby, who were brothers in law, the first having married Sarah Butler and the last one Mary Butler, were appointed administrator's of Artemus Watson's estate (File Box 100, Pkg. 2462, Probate Office, Abbeville (See V. H. G. 32). They were probably related to Mr. Watson. After Mrs. Eskridge's marriage to Daniel Bullock, she and her third husband, Daniel, were appointed administrators in 1786. Her bond was given by BARRETT TRAVERSE, Joseph Nunn and David Collier. Inventory of the estate of Eskridge was signed by Nicholas Lewis, Wm, Butler, Frederick Sisson.

Mrs. Hannah Bell-Watson-Eskridge-Bullock survived her three husbands and died in S. C. in 1824.

THE BELL FAMILY OF HALIFAX AND EDGECOMBE COUNTIES

This particular Bell family descends from one William Bell of Isle of Wight County, Virginia. There was another Bell family that resided in the same part of Halifax County as did the descendants of William Bell, that appears to descend from George Bell who died in 1752. (Grimes "Abstracts of N.C. Wills"). These families do not seem to be related.

William Bell (1) married Ann Jones, the daughter of Richard Jones in Isle of Wight County, Va., in 1721. (Isle of Wight Great Book 2, p. 34). He removed from Virginia to North Carolina at an early date and settled on the Roanoke River in what was then Edgecombe County. His will, dated Dec. 1, 1752, and probated August Court, 1754, in Edgecombe County, mentions his son Arthur, son Joshua, and daughters Mary Pyrent and Ann Bell. (Grimes "Abstracts of N. C. Wills".)

Micajah Nicholas Dickson first appears in the Halifax records about 1811. The will of Arthur Bell, dated Dec. 9th, 1816, and probated May, 1818, mentions among others half brother Micajah Nicholas Dickson and half sister Nancy Horn. M. N. Dickson was executor of the will. (Halifax W. B. 3, p. 621). The connection between Micajah Nicholas Dickson and the earlier Dicksons in Halifax County has not been found. The estate of William Dixon was divided between Mary, Thomas, and Esther Dixon in 1750. (Edgecombe County Inv. and Settlements of Estates 1733-1759). On Dec. 11th, 1754, William Hobbe sold to Joseph Dixon of Virginia, 100 acres between Deep and Fishing Creeks. (Halifax D. B. 2, p. 301) On Dec. 14, 1749, Samuel Williams sold to Nicholas Dickson of Isle of Wight 200 acres on the south side of the Roanoke River: The deed was witnessed by John Pope and John Crudup. (Halifax D. B. 3, p. 479). The Nicholas Dixon of this deed was the son of Thomas Dickson or Dixon of Isle of Wight County, Va., whose will, dated April 26th, 1746, was probated in Isle of Wight Jan. 1748. (Boddie and Allied Families, p. 105). On Nov. 1, 1775, Nicholas Dickson of Halifax County deeded 100 acres to son John Dickson and 100 acres to son Josiah Dickson. (Halifax D. B. 13. p. 400). Micajah Nicholas Dickson may have been a son of one of these two. Micajah N. Dickson died prior to Aug. 1825. intestate. William Ruffin Smith, Sen. was his administrator. The will of his widow Milly Dickson, dated Dec. 3, 1833, and probated May 1, 1835, mentions sons Marmaduke and William and daughter Emily. The three children of Milly Dickson moved to Jackson County, Florida, where their descendants still live. William R. Dixon married in 1834 Emily Cotten of Scotland Neck. Marmaduke N. Dixon married Martha Pinner of Northampton County, North

Carolina, and died in 1864 in the Battle of Marianna, Florida. Emily Dickson married in Florida Felix Long.

Joshua Bell, son of William and Ann Jones Bell, married Ferebee Norfleet, daughter of Thomas Norfleet of Edgecombe County. (Halifax D. B. 9, p. 325). The will of Joshua Bell, dated July 4, 1793, is on file in Edgecombe County, (Edgecombe W. B. "C", p. 242) and mentions, in addition to his children listed below, his granddaughter Absilla Bryant's son William,

Martha and her husband Nathaniel Colley. (P. George D. Book 1787-1792, p. 627). Nathaniel Colley is said to have been an English sea captain who settled in Prince George County about this time. They had issue one child (1) Sarah Colley, b. 1792, married 1810 Thomas Poythress Cocke, son of Capt. James Cocke and Elizabeth Poythress.

Children:

(a) Martha Cocke married her first cousin James Cocke, son of Dr. James Cocke of Baltimore, and had issue.

(b) Nathaniel Colley Cocke of "Aberdeen", Prince George County, married Virginia Anne Peterson. Issue among others, Mary Herbert Cocke married Richard H. Smith (V. H. G.), and Anne Hayes Cocke married his brother Alexander Hall Smith and Virginia Peterson Cocke married William Edward Smith, first cousin to Richard H. Smith.

BELL of ISLE of WIGHT

George Bell was a headright for William Yarrett, a very prominent Quaker of Isle of Wight, who patented 660 acres north side of the Rappahannock July 29, 1650, for the transportation of 14 persons among whom was George Bell (C. P. 191). Mr. Yarrett also patented 580 acres in the same vicinity for transportation of 12 persons on the same day. Among them was the wife of Ambrose Proctor of Isle of Wight and Thomas Gwaltney of Surry. He was a large trader in lands and headrights.

On Oct. 11, 1664, George Bell requested the Administration of the estate of Edward Powell, who died intestate. His bondsmen were Thomas Ward and John Wakefield. (C 1-92)

On Feb. 7, 1663, George Bell and Hester, his wife, sold to John Sherrer and John Wakefield 755 acres of land. (17 C.-533). In 1664, Nicholas Cobb, mariner, and Susan, his wife of Isle of Wight sold to Thomas Davis land called "Rattlesnake Neck" next to plantations of John Crews and George Bell. On March 4, 1667, Nicholas Cobb sold to John Frizzell a parcel of land in Upper Parish adjacent to George Bell. George Bell, in 1678, also witnessed a deed of Thomas Tooke, planter, to Nicholas Cobb for 900 acres bought of William Tooke.

There was a Richard Bell who settled in Isle of Wight. On July 18, 1682, he witnessed a deed of John Wakefield and wife Sarah to Robert Thomas. (17 C.-593). On Oct. 9, 1693, by reason of his great age he was excused from labor and levies. (O. B. 1693-95 p. 1) Richard Bell and wife Sarah, on May 8, 1686, proved the nuncupative will of Nicholas Cobb. The inventory of Richard Bell's estate was presented by wife, Sarah Bell, April 9, 1700. (W & D. 2-424.)

Edward Cobb, on Jan. 16, 1686, sold this 900 acres to Thomas Moore. The deed recites that Nicholas Cobb died and the 900 acres went to Nicholas Cobb, Jr. his oldest son and heir; Nicholas Jr. died and the land went to Edward Cobb, his brother. This deed was witnessed by Thomas Tooke and JOHN BELL. This is the first appearance of John Bell, son of George, Sr., in the records. (17C.-597)

George Bell, on March 27, 1672, witnessed the will of Ambrose Proctor, Jr. Dorothy Bond in her will dated July 10, 1684, probated Oct. 9, 1684, bequeathed to son John Bond household goods; to grandson, William Watson, a colt; remainder of estate to be divided between sons William and John Bond and grandson Watson, Watson to go to Richard Sharpe until of age, if Sharpe die to go

to two Uncles. Richard Sharpe and George Bell, exrs. wits.: Wm. Blunt. Nicholas Cobb.

Dorothy Bond was the widow of Major John Bond, member of the House of Burgesses 1653-54. He served in the House until 1660 with the exception of 1656 when he was Sheriff. He was also a Justice of the County Court in 1659-1660 but was evidently a Puritan for he was expelled from his office as Justice in the Assembly of 1656-1660 for his "Schismatical tendencies". The new Berkeley Assembly was evidently expelling the Puritans from office.

On Nov. 1, 1688, the nuncupative will of Alexander Webster was proven by George Bell, Sr., John Crue (Crew), and John Sherrer. The legatees were GEORGE BELL, JR., John Harris and Hannah Brown, the daughter of George Brown.

George Bell, Sr., made his will June 22, 1702, probated Nov. 9, 1702. He bequeathed to wife JOYCE BELL "Land where I now live to hold for time of lease from Col. Joseph Bridger, 99 years;" to son GEORGE and daughter ELIZABETH rest of estate to be equally divided. Wife extr. Wits., John Davis, Francis Ffloyd.

I. George, Jr. in 1687 witnessed the will of Francis Hobbs. In 1688 he was a legatee of Alexander Webster. George Bell was living in Isle of Wight as late as Jan. 24, 1742, when he, together with Roger Allen, presented an account of the estate of Thomas Allen (C-2-114). He is probably the George Bell who made his will in Edgecombe Dec. 21, 1751, probated Feb. 1752. He named sons: ARTHUR, GEORGE and WILLIAM; daughter ELIZABETH FFLOYD; granddaughter MARY BELL. Exrs. FRANCIS FFLOYD and ARTHUR BELL. Wits.: William Pertis, Thomas Bell, Thomas Ffloyd. (Grimes 20)

His son George Bell made his will in Edgecombe Feb. 18, 1755, probated May, 1755. Sons: JOHN plantation where I now live; DAVID; GEORGE; wife SARAH BELL. Exrs.: Wife Sarah and son John. Wits.: Arthur Bell, George Bell. (Id. 20)

II. John,-m. Sarah . (See later)

III. Elizabeth, no further mention.

IV. Daughter, name unknown, m. John Bond. He survived his wife and made his will Mar. 15, 1687. Legatees: William Maynard; William Watson; if he die to go to son John Bond; to Mr. John Bond all land and property to John Harmon all of wife's clothing (she was evidently deceased) JOHN BELL, my wife's brother to be executor. John Bell to live on plantation with my two children, "my wife's and my own" and bring them up with the estate to learning. If son John die without issue, to Will Watson and Wm. Maynard. Wits,: John Porter, Reuben Gladhill, Thos. Doudell.

John Bell evidently a son of George and Joyce Bell is placed here as a son because of the relationship and association of the Bond family with his father who was executor of Dorothy Bond, mother of the above John Bond.

Nicholas Cobb's land as heretofore shown joined on George Bell's and on Jan. 16, 1686, John Bell was a witness to the sale of Nicholas Cobb's land,

John Bell made his will April 26, 1721, probated Mar. 26, 1722, as follows: to son JOHN BELL land where I now live; to son GEORGE BELL another part of land where I now live; to daughters: ALICE MILLER, silver spoons; OLIVE; son EDWARD BELL; land to son BENJAMIN BELL at his mother's decease; to wife SARAH BELL rest of estate and to her children, i.e. three daughters and one son. John Miller, Exr. Wits.: Wm. Dixon, Thos. Roberts, Thos. Goodson. (Great BK.-113)

Benjamin Bell, the above mentioned son of John Bell married Mary Lewis, daughter of Daniel and Sarah Lewis. Daniel Lewis died in 1698 and his wife married again as his second wife, Richard Bennett, Sr., who died in 1710 and gave a legacy to "Mary Thorpe, the daughter of Daniel Lewis".

Mary, daughter of Daniel Lewis, was at that time married to Thomas Thorp. Thorpe was her third husband. Her first husband was one Dixon by whom she had Mary and William Dixon. These two children of hers are mentioned in the will of her second husband, Joseph Ford, who died in Surry in 1709. She then married Thomas Thorpe, and had one daughter. Elizabeth Thorpe, whom she mentioned in her will. Mary must have been a very attractive lady for she married the fourth time Benjamin Bell, the subject of this sketch. Benjamin Bell died in 1722 and Mary married for the fifth time James Briggs. Previous to her wedding to James Briggs, she made a marriage contract with him enabling her to dispose of her own property. Her will was dated Mar. 21, 1726/ 27 and probated June 26, 1727. She bequeathed to daughter ELIZ-ABETH THORPE ±35 that is in Colonel Bridger's hands (George Bell, Sr., leased land from the Colonel for 99 years); to my son BENJAMIN BELL, 1 negro; to daughter ANN CROFTS; to son BENJAMIN BELL land and if no heirs to ELIZABETH THORPE. Wits.: James Batte, Wm. Cogill, John Grisord. (W. B. 3-p. 33)

Benjamin Bell, Sr., died in 1722 intestate. He and wife Mary had two children:

- I. Benjamin, who was mentioned in the will of his grandmother Mrs. Sarah Lewis-Bennett-Lancaster in 1722. (See her will under Bennett) and in the will of his mother the above mentioned Mrs. Briggs. (See later).
- II. Anne was mentioned in the will of her grandmother, Mrs. Lancaster, in 1722, as her granddaughter, Anne Croft. She was also called "Anne Croft" in her mother's will in 1723. She married Samuel Croft. (C. M. 13)

Benjamin Bell, son of Benjamin Bell and his wife, Mary, daughter of Daniel Lewis, as heretofore shown, married Patience Wrenn, daughter of Mrs. Mary Wrenn, who made her will Jan. 27, 1746, probated May 14, 1747, as follows: to daughters ANN POTTER, MARTHA CARY, and PATIENCE BELL, one shilling each. Grandchildren: Mary Meacum, Lewis Meacum, William Cary, Joseph Cary, Charity Cary, RICHARD BELL, BENJAMIN BELL, and MARY BELL to be schooled. Wits.: Will Salter, BENJAMIN BELL, Wm. Cary. (W. B. 5-62)

Mrs. Wrenn's daughter, Anne Wrenn, sister to Patience Wrenn Bell, married first Lewis Meacum and secondly John Potter. (W.B. 5-2; C.M. 42). Anne Wrenn Potter had Mary Meacum and Lewis Meacum by her first husband, who was a son of John Meacum (Meacom). Susanna Lewis was a daughter of Daniel Lewis d(1698) and his wife Sarah Lewis-Bennett-Lancaster.

Mrs. Susanna Lewis made her will in 1727 and an appraisal of her husband's estate was filed Nov. 3, 1731. The Bell and Wrenn families were therefore allied by marriage.

Benjamin Bell died about 1755. His estate was appraised by Samuel Wilson and John Bennett, May 1, 1755. (W.B. 6-175). Patience Bell died in Isle of Wight, evidently a widow in 1772. Her will was dated March 20, 1771, and probated May 7, 1772. She bequeathed all of her estate to her maiden daughter, Elizabeth Bell. (W.B. 8-132.).

William Jelks of St. Luke's Parish, Southampton, made his will Oct. 9, 1766, probated April 12, 1770, mentions his wife ANNE, son Lionel; son William; daughters: Mary, TABITHA and Betty Jelks. Exrs.: Wife Anne and son Lemuel. Wits.: Gregory Rawlings and Rivers Barker. (W. B. 2-319).

A John Johnson of Brunswick County, N.C., in his will probated in Brunswick Co., N.C., Feb. 1752, mentions a daughter ANN JELKS.

William Jelks, in his will probated Dec. 4, 1781, mentions his sister, TABITHA BELL, wife of BENJAMIN BELL.

Benjamin Bell Sr., was a member of the General Assembly of N.C. from Pitt County in 1792. (Wheeler 347). He died in 1805.

A division of his estate was made to the following sons: KINCHEN, WILLIAM, JOHN, JAMES and BENJAMIN BELL. (See later).

Benjamin Bell, born Dec. 2, 1790, died in Pitt County, N. C., August 2, 1839, on Jan. 15, 1818, married Lydia Tucker, born Feb. 19, 1795, died in Pitt County, N. C., Aug. 10, 1834, who was the daughter of Joseph Tucker, Jr., who patented 77 acres of land on Tar River in Pitt County in 1767. He was dead before 1779, as his wife was then married to a Mr. Stokes. (Pitt County wills destroyed). Benjamin was an Ensign in the War of 1812, serving at Beacon Island, N. C.
