Peter placed in care of William's s.-in-law Robert Love; est. adm. in 1742 naming heirs: s.-in-law Thomas Johnson; dau. Sarah Love; dau. Ann Bond; dau. w. of John Rigdon; dau. w. of William Andrew; in 1750 his heirs owned 50 a. Addition, 148 a. Buck Range, 150 a. Lawrence's Pasture, and 196 a. Hannah's Delight; will of Sarah Bond, 19 April 1770 - 14 May 1770, named sis. Elizabeth w. of William David; Margaret Tamou; step-dau. BOND, THOMAS (8), s. of Peter (2) and Eleanor, d. by 18 April 1768; m. on 9 May 1736 Phebe Thomas; in 1750 owned 52½ a. of Logsdon's Addition, 140 a. of Bedford Resurveyed, 27 a. Bond's Forest, 100 a. Wooley's Range, and 100 a. Bond's Meadows; in 1747, Thomas, tavernkeeper, and w. Phebe conv. two parcels of Bedford Resurveyed to Benjamin Bond; est. adm. 18 April 1768 and 3 July 1769 by Phebe Bond; had iss.: SARAH, b. 29 Jan. 1738; WILLIAM, b. 30 Nov. 1741; THOMAS, b. 27 Sept. 1744 (7; 77; 79; 133; 153; 200-63:248).

Susanna, bro. Richard, and ch. Samuel, Peter, Amon, Edward, Sophia, Kerrenhappuck, Benjamin, Henry, Elizabeth, Christopher, Joshua, and Susanna; had iss.: SAMUEL, b. 26 Sept. 1736; KERRENHAPPUCK, b. 26 Feb. 1742/3; PETER, b. 14 April 1744, d. 1769, leaving a will, 6 Nov. 1769 - 6 Dec. 1769, which named his f. Keturah (?); in 1750 owned 50 a. part Chestnut Ridge, 130 a. of Friendship, 100 a. of Roundabout Neighbors, and 50 a. of Brown's Prospect; conv. 40 a. Bond's Industry to William Tipton c.1760; will, proved 8 Dec. 1792, named ch. John, Mary Tipton, Ruth Gist, Rachel Harryman and Sarah Hall, and ch. of dau. Eleanor Gorsuch, and grandchildren John, William, and Keturah Bond; est. adm. 14 March 1795, naming Joseph Perogy who m. Mary Gorsuch, Norman Gorsuch who m. Keturah Gorsuch, David Gorsuch who m. Rebecca Gorsuch, Stephen Cole who m. Rachel Gorsuch, and Eleanor, Ruth, Charles, Elizabeth, Ann, Achsah, and Belinda Gorsuch, orphan ch. of Charles Gorsuch; Joshua Hall who m. BLADEN, JOHN (2), s. of Robert (1) and Elizabeth, was admitted to Gray's Inn, London, in March 1624/5 and was alive in 1632; d. by 1649; m. a dau. of Nathaniel Birkhead of East Heage, and had iss.: NATHANIEL.

BLADEN, NATHANIEL (3), s. of John (2), was alive in 1702; m. Isabella Fairfax, dau. of Sir William Fairfax of Steeton; Sir William's maternal grandfather was Edmund Sheffield, Earl of Mulgrave; had iss.: WILLIAM, b. 27 Feb. 1673; MARTIN, b. 1680, d. 15 Feb. 1745/6; ISABELLA; CATHERINE; FRANCES, m. William Hammond; ELIZABETH, m. Edward Hawke (by whom she was the mother of the noted Admiral Lord Hawke).

BLADEN, WILLIAM (4), s. of Nathaniel (3) and Isabella, b. 27 Feb. 1673 at Steeton, bur. at Annap., Md., on 9 Aug. 1718; m. Anne Van Swearingen, dau. of Garrett Van Swearingen; possessed some land in Balto. Co.: 300 a. Cullen's Lot, 500 a. Cullen's Addition, and 38½ a. Hopewell; held a number of offices in the provincial government incl. Secretary of Maryland and Attorney General of Maryland; had iss.: Col. THOMAS; ANNE, m. 31 Aug. 1711 Benjamin Tasker (211; Johnston).

BLADEN, THOMAS (5), s. of William (4), b. 1698, d. 1780 in Eng.; Governor of Maryland 1742-1747; later member of Parliament in Eng.; m. Barbara, eld. dau. of Sir Theodore Janssen, Bart.; in 1750 owned two tracts of land in Balto. Co.: 3500 a. Blathnia Cambria, and 500 a. Carse's Forest; had iss.: HARRIOT, m. William, 4th Earl of Essex; BARBARA, m. 3 Aug. 1773 Gen. St. John (153; Johnston).

BLAIN, WILLIAM, m. Lydia, admnx. of Amos Johnston (4).

BLAIR, (?), m. by 3 June 1765, Mary, dau. of Alexander Hannah, weaver (112).

BLISSARD, WILLIAM, m. Lurana (?) and had iss.: ISAAC, b. 19 May 1751; JOHN, b. 3 Sept. 1755 (134).

BLOVER, JOHN, gave his age as about 25 in March 1720/1 (23; 492).

BLUNDELL, LAWRENCE, m. Margaret (?) and had iss.: SARAH, b. 10 Nov. 1728 (133).

BLUNDEN, JAMES, m. on 1 Dec. 1759 Sarah Rights (131).

BOARD, (?) (1), m. by 9 Jan. 1723/4 (?), dau. of Anna, relict of Francis Mead of A. A. Co., who in her will of that date named her grandsons James and John Board; had iss.: JAMES; JOHN (124).

BOARD, JAMES (2), s. of (?) (1), was living in 1723/4, and was prob. the James Board whose will, 23 Feb. 1762 - 14 Feb. 1763, named sons: JAMES; FRANCIS (6; 111).

BOARD, JOHN (3), s. of (?) (1), was living in 123/4, and m. Jemima Henderson on 13 Jan. 1733; had iss.: ANN, b. 11 Jan. 1732; JOHN, b. 11 Jan. 1732 or 1735; JAMES, b. 5 March 1740; WILLIAM, b. 18 Dec. 1743 (133).

BODKIN, JOHN, taxable in Spesutia Hund. in 1695 (140).

BODY, PETER, transp. by 1672, m. on 28 Dec. 1686 in Som. Co., Frances, dau. of Stephen Cannon (263; 388).

BODY, STEPHEN (1), poss. a desc. of Peter and Frances (Cannon), d. in Balto. Co., by 9 May 1744; m. 1st on 3 April 1722 Susanna Long, and 2nd, on 10 Feb. 1728 Elizabeth (?); adm. est. of William Robinson on 9 Nov. 1731; purch. part Ballestone from John Long on 6 March 1733; will, 1742 - 3 Nov. 1742, named w. Elizabeth, and ch. Alanson, Penelope w. of Dixon Stansbury, Susanna w. of Neal Fall, Ann, Elizabeth w. of (?) Johnson, and Peter, ment. 170 a. Ballston; admn. bond posted by extx. Elizabeth Body with Nicholas Haile and Dixon Stansbury; est. adm. 9 May 1744 and 18 June 1752 by Elizabeth, now w. of (?) Trotten; had iss.: SUSANNA MEAD, b. 27 April 1723, m. by 1742 Neal Fall; PENELOPE MEAD, b. 27 Nov. 1724, m. 4 Jan. 1740/1 Dixon Stansbury; ANN; ELIZABETH, m. by 1742 (?) Johnson; PETER; ALANSON, b. 13 Aug. 1730, chose John Long as his guardian in March 1746, and his est. was taken out of Luke Trotten's hands (3; 11; 74; 110; 131; 133).

BODY, PETER (2), prob. s. of Stephen (1), m. on 25 Aug. 1757, Mary Allender (131).

BOHON, EDWARD, m. on 19 March 1761 Elizabeth Jones (131).

BOICE, JOHN, d. 28 Jan. 1737 (128).

BOLTON, JOHN, m. by Nov. 1685 Dorothy Crandon (18:358).

BOLTON, CHARLES, m. by March 1739 Ann, admnx. of John Higginson; in 1750 owned 200 a., part Bond's Gift (4; 32:151; 131; 153).

BOND, PETER (1), progenitor of the family, was in Balto. Co. by 1660, d. by 28 April 1705; m. Alice (?), wid. of 1st (?) Gill (by whom she had a s. Stephen), and of 2nd William Drury (whose will dated 22 Aug. 1676 named w. Alice); in June 1678 Peter and Alice Bond sued James Rigby for her share of Drury's est.; will, 23 Aug. 1704 - 28 April 1705, named w. Alice, sons Thomas, William, John, and Peter, land 300 a. at head of Bush R.; Alice Bond posted admn. bond on 25 June 1705 with Isaac Jackson and George Ogg; est. inv. on 27 June 1705 by Christopher Gardner and Jno. Hurst, val. at £ 55.15.0; adm. est. by Alice Bond on 26 July 1706, and by Alice, w. of Phillip Washington on 14 May 1707; by 1708 Phillip and Alice had agreed to live apart, and Peter Bond posted bond he would support Alice Washington; had iss.: PETER, b. c.1677; THOMAS, b. c.1679; WILLIAM, under 16 in 1704; JOHN, under 16 in 1704 (2; 11; 48; 67; 122; 200-67; 388; 538; 539).

Co. to the Assembly, 1716-1717; was a Justice, 1715-1717; will, 28 Feb. 1717/8 - 16 June 1718, named ch. Richard, William, Thomas, Peter, John, and Benjamin, lands on Garrison Ridge, Bond's Pleasant Hills; admn. bond posted

BOND, BENJAMIN (11), s. of Peter (2) and Eleanor, d. by 1750, m. Sophia, dau. of Henry Butler; vestryman of St. Thomas Par. after 1749; in 1750 heirs owned 62½ a. of Redford Resurveyed; had iss.: URATH, b. 10 Aept. 1742 (5; 133; 153; 398).

BOND, THOMAS (12), s. of Thomas (3) and Ann, b. c.1703, living 1781; m. on 3 Feb. 1725 Elizabeth, dau. of Daniel Scott, b. c. 1705, living 1781; prob. the Thomas Bond, Jr., who in 1750 owned 109 a. Bond's Beginnings, 56 a. part Bond's Fortune, 100 a. Tower Hill, and Miles' Improvement; w. w. Elizabeth conv. dau. Martha 200 a. Bond's Forest in 1778, Zacheus and Hannah Onion 100 a. of Bond's Forest in 1780, and 96 a. Bond's Forest to William and Susanna Amos, and 100 a. Tower Hill to dau. Anne Clemens, her husb. William Clemens and their s. Thomas Bond Clemens, all of Chas. Co.; d. by April 1791 when his relict Elizabeth, widow of Thomas Bond, d. 7 March 1791 in her 87th year, having lived with her husb. for over 63 yrs.; had iss.: ANN, b. 13 April 1728, m. William Clemens; ELIZABETH, b. 2 Nov. 1727; THOMAS; HANNAH, m. Zacheus Onion on 2 Dec. 1757; MARTHA, b. c.1747, age 29 in 1776; SUSANNA, m. Hester, dau. of Isaac Butterworth; she m. 2nd Caleb Hughes; admin. bond posted 23 Dec. 1738 by Hester Bond with Isaac Butterworth, Henry Garrett and Abraham Boyd; est. adm. 17 Sept. 1740 by Caleb Hughes and w. Hester; had iss.: SARAH, b. 9 Dec. 1719; ANN, b. 18 June 1729; PETER, b. 10 June 1738 (4; 11; 33:10; 131; 558).

BOND, WILLIAM (14), s. of Thomas (3) and Ann, d. by 1769, having m. Elizabeth Stansbury, dau. of Luke Stansbury; par. conveyed him 510 a. Bond's Lot in June 1723; conv. 304 a. Bond's Forest to Josiah Dyer of Bucks Co., Penna. in 1763, conv. 410 a. Bond's Forest to Luke Stansbury Bond in 1764, and 193 a. Bond's Water Mills in (?) to John Bond; in 1745 conv. negro to Ruth, Luke Stansbury Bond, Priscilla, Elizabeth, Thomas, William, and Tobias Bond; in 1750 owned 50 a. Filial Care, 100 a. Limerick, 246 a. Midsummer Hills, 180 a. Forberry Neck, and 100 a. Pork Hall; will, 6 Aug. 1767 - 8 April 1769, named bro. Jacob and w. Elizabeth as execs.; ch. Luke, Priscilla Worthington, Ruth Nicholson, Cassandra, and James; had iss.: LUKE STANSBURY, b. April 1733; PRISCILLA, b. 3 July 1735, m. Vachel Worthington on 17 Nov. 1757; RUTH, m. 16 March 1749, Nathan Nicholson; CASSANDRA; JAMES; ELIZABETH; THOMAS; WILLIAM; and TOBIAS. (69; 78; 87; 88; 90; 92; 112; 127; 131; 133; 153).

BOND, JOHN (15), s. of Thomas (3) and Ann, b. 10 Nov. 1712, d. 1786, m. Aliceanna Webster, dau. of John, on 26 day of May, 1734, at Nottingham Meeting; in 1750 owned 466 a. of James Park, 2 a. lots in Joppa, 84 a. The Oblong, and 33 a. Bond's Tanyard; known as John Bond, Gent., lived at Fells Point, Balto., in the winter, Justice of the Peace, Coroner, and Judge of the Orphans' Court, 1769-1773; private in Capt. William Murbury's Co. of Artillery, 1775-1783; had iss.: THOMAS; Dr. JOHN, m. Sarah Elliott; PAMELA, m. William Moore; SAMUEL, m. Cynthia Richardson; WILLIAM, m. on 16 Nov. 1771 Sarah Wrong; SUSAN, m. 1st Phineas Hunt, and 2nd (?) Johns; ANN, m. 1st (?) Giles; and 2nd Edward

Fell; JANE, m. Samuel Bradford; ABIGAIL, m. (?) Abbott; HANNAH, "marr. out of meeting," husb. not identified (79; 136; 153; 353; 430:930).

BOND, JACOB (16), s. of Thomas (3) and Ann, b. c.1725, d. Nov. 1780; m. on 28 Dec. 1747 Fanny Partridge; 2nd (?); and 3rd Elizabeth (?); member of the Committee in Harf. Co., and a member of Co. No. 11; in 1774 a delegate from Harf. Co. to protest the tax on tea; delegate to Annapolis in 1776 to draw up State Constitution; was conv. ½ of Poplar Neck by his f. in Nov. 1752; in 1776 res. in Bush R. Lower Hund. with his ch.: ELIZABETH, age 28 in 1776; JACOB, Jr., age 26; SARAH, m. Bernard Preston; JOHN, age 23; PRISCILLA, age 17; DENNIS, age 16; RALPH, age 13; MARTHA, age 10; and CHARLOTTE, age 9 (7; 81; 133; 210:31; 285; 354).

BOND, DANIEL (17), s. of Thomas (3) and Ann, m. on 1 Nov. 1759 Patience, dau. of James and Elizabeth (Parrish) Bosley; had iss.: BETSY ANN; ZACHEUS; JOSHUA, and THOMAS (131).

BORING, RICHARD (13), s. of James (6) and Martha, with bro. James inher. parts of Upland and Meadow Ground from their father.

Journals, edited by Wm. A. Darlington, were published at Pittsburgh in 1893. Christopher Gist married Sarah, daughter of Joshua Howard of Baltimore County, whose will dated 3 July, and proved 4 Sept., 1738 (Balto. i, 296) names his sons Francis, Cornelius, and Edward Howard, and his daughters Sarah, Mary, and Violetta Gist, and Elizabeth Wells. It is interesting to note that these ladies were the aunts of the distinguished Revolutionary worthy, Col. John Eager Howard, who was the son of their brother Cornelius.

Christopher Gist³ and Sarah (Howard) his wife had issue:—

- i. RICHARD GIST,⁴ b. 2 Sept. 1729; killed at battle of King's Mountain, 1780; said to have descendants in South Carolina.

5. WILLIAM GIST³ (*Richard*,² *Christopher*¹) was born in 1711, according to a deposition made in 1767, wherein he gives his age as 56 years (Chancery, D. D. no. 2, 179). He died 19 Nov. 1794, and the date is recorded in the register of St. Thomas's Parish, Baltimore County, where his marriage and the births of his children are also recorded. He married, 22 October 1737, Violetta, daughter of Joshua Howard, named in her father's will as "my daughter Violetta Gist" (see above). Moreover, Cornelius Howard (son of Joshua) of Baltimore County, planter, conveys, 7 August 1771, to his "sister Violetta Gist and William Gist her husband," Lot 502 in Baltimore Town (Balto. Co., A. L. no. C, 650). She was therefore an aunt of Col. John Eager Howard of Revolutionary fame. William Gist³ and Violetta (Howard) his wife had issue:—

He married, 2 July 1735 (St. Paul's) Susan daughter of John Cockey of Baltimore County. She was born 2 Nov. 1714 and died in 1803. Her will, dated 7 March 1799, was proved 12 February 1803 (Balto., vii, 152). Thomas Gist³ and Susan (Cockey) his wife had issue:—

7. COL. NATHANIEL GIST⁴ (*Christopher*,³ *Richard*,² *Christopher*¹) was born 15 October 1733, and was present, with his father and his brother Thomas, at Braddock's defeat on the Monongahela, in 1755. He later served with distinction in the Revolution. He was commissioned, 11 January 1777, Colonel of the Additional Continental Regiment; was taken prisoner at Charleston, 12 May 1780; and was retired 1 January 1781 (Heitman's Register). He settled in Kentucky where he built his homestead "Canewood," and died early in the nineteenth century, at an advanced age. Col. Gist married Judith Cary Bell, daughter of David
