CHAMPION OF SURRY AND ISLE OF WIGHT

Edward Champion, the first of his name in Surry, came there with Col. William Swann. Thomas Swann, the Colonel's son, used Edward Champion's name, Edward Swann's and that of twenty-two other persons as headrights, Mar. 1, 1638, for the obtaining of a grant of 1200 acres at "Swann's Point" in Surry. (C. P. 103)

Joseph Stratton, on July 8, 1635, patented 500 acres in Denbigh Co. (Warwick) "upon land that did once belong to Capt. John Smith, now in occupation of PERCIVALL CHAMPIOON and John Slaughter" (C.P. 25). On August 18, 1637, Percivall Champion patented 500 acres in Upper County of New Norfolk (Nansemond) W. N.W. upon Nansemond River, 50 acres for his own personal adventure and 50 for his wife Mary and 400 acres more for the transportation of 8 persons. He patented 250 more in the same locality Aug. 21, 1638. His land adjoined Samuel Stephens, William Landers, William Parker and Thomas Powell. (C.P. 65, 26, 113)

Richard Jackson, on Aug. 28, 1643, patented 110 acres in Isle of Wight for the transportation of JOHN CHAMPION and two other persons. Richard Jackson's patents and residence were in

the Upper Parish of Isle of Wight.

The first known ancestor of this family was Edward Champion, of Isle of Wight. He is first mentioned in the Will of Joseph Poole in 1668. Joseph Poole, planter, of Upper Parish of Isle of Wight, made his Will Jan. 18, 1668, probated May 3, 1669, as follows: "To wife ELIZABETH, all personal estate, she to be executrix. If without issue of fiftne then the said estate to return to her only son, EDWARD CHAMPION; to Thomas Blake's daughter to ELIAS FORT JR. calf; to Stephen Johnson a cow at becoming of age; to EDWARD CHAMPION my gun. I do request John Britt and Elias Fort to use their utmost endeavor to see this will performed." Wits. Thomas Barlow and Robert Poole (W & D 2, p. 65). Edward Champion and John Britt appraised the estate of William Cockins April 9, 1679, and they also appraised the estate of Elias Fort whose inventory was recorded the same day. He and Thomas Moore appraised the estate of William Evans 1688. Thomas Moore made his Will Sept. 28, 1696, probated the 9th of the 10th month 1696. He bequeathed to EDWARD CHAMPION land bought of Edward Cobb; to ORLANDO CHAMPION part of 400 acres between John Clarke and John Atkins on the west side of Blackwater Swamp for the use of ED-WARD CHAMPION SR., father of THOMAS and ORLANDO until 21; to ALICE CHAMPION, dau. of Edward Champion; to BENJAMIN CHAMPION, son of Edward Champion, a negro boy; to wife Elizabeth; to brother, GEORGE MOORE and friend Charles Chapman 1000 lbs. tbco. for use of my NIECE MAGDALEN CARTER for [] clothes and 1000 lbs. tbco. for use of PRICILLA CHAMPION JR. Wife and brother Excrs. Wits. John Carroll, Richard Lewis, Chas. Chapman (W.D. 2-371.)

Thomas Moore's wife was Mrs. Eldridge, the widow of Samuel Eldridge, for an account of Eldridge's estate was presented Aug. 22, 1667, by Thomas Moore who had married the relict (W & D 1-48). The relationship between Thomas Moore and the Champions is not known. His brother, George Moore, was 78 years of age when he made his Will Nov. 30, 1710. They were probably sons of John Moore who was Burgess for Isle of Wight in 1640 (W. D. 2-586).

The six children of Edward² Champion Sr. were Edward³ and Orlando³ who moved to North Carolina and Benjamin³ who moved Surry. (See later.) The daughters were Alice and Priscilla Ir. Photosistally whose fate is unknown. Because of the name "Priscilla Champion Photosistally." in Thomas Moore's will it is evident that her mother and the wife of Edward² Champion Sr. was the Priscilla Champion who witnessed Elizabeth Walton's will Dec. 23, 1675, together with

George Moore and Margaret Williams (W.D. 1-141).

Edward³ Champion Jr. on Jan. 28, 1705, sold to Andrew Woodley, the parcel of land in Upper Parish of Isle of Wight devised him by the Will of Thomas Moore which Moore bought of Edward Cobb. Wits. Thomas Files, Phillip Brantley, JOHN BELL, John Davis (D.B. 2-28). Edward made his Will Jan. 26, 1717, 18, as a planter living in Albemarle county, N.C. as follows: "to son JOSEPH CHAMPION all land west side of Miery Branch next to Widow Tadlers; to son THOMAS CHAMPION all land east side of Miery Branch except 10 acres I give to EDWARD CHAMPION adj. Capt. Bonner's and John Chanler's; to dau MARY CHAMPION one cow calfe that is an Allford calf; to dau. ELIZABETH a cow calfe; son JOSEPH to get tinber wherever he desire; wife MARY CHAMPION to keep plantation for life then to sons Joseph, Thomas and Edward. Wife extrix. Wits. Jane Jones, William Sadler, Henry Lesler. (N. C. Wills 1663-1789, Vol. VI. p. 13)

Orlando³ Champion, brother of above Edward³, as "Orlando Champion of the Province of N.C." in 1714 sold to John Atkinson Jr., of Surry county 200 acres of land in Isle of Wight, being a moiety of 400 acres granted Thomas Moore by patent, June 6, 1666. Wits. H. Lightfoot, Robert Brock, Nathaniel Ridley (D.B. 2-288).

Benjamin³ Champion, son of Edward² and Priscilla Champion, moved from the Upper Parish of Isle of Wight across Lawne's Creek to the Lawne's Creek Parish of Surry where he bought land in 1723. He married Elizabeth Williams, daughter of Charles Williams of that parish. Charles Williams appears in the list of Tithables for Surry from 1683 to 1702, the latter date being their last. He was in the Surry Militia in 1687 and held 100 acres in the Quit Rents of 1704. He made his Will Dec. 4, 1720, probated Aug. 16, 1721. as follows: "Sick and weak, to dau. ELIZABETH CHAMPION L 5 current money; to dau. MARY SEWARD my grey horse colt; to grandson CHARLES CHAMPION new feather bed, etc.; to son in law BENJAMIN CHAMPION my wearing apparel; to child my wife now goes with 100 acres lying in Lawne's Creek Parish, if child die without issue to my grand daughter ELIZABETH CHAM-PION; all rest of estate to loving wife ELIZABETH WILLIAMS and child she goes with, she to be extrix. Wits: William Gray, James Vaughan, Bartlett Moreland, Luce Mecone (Bk. 1715-30, p. 357).

Benjamin³ Champion made his Will April 6, 1735, of Lawne's Creek Parish, "sick & weak"; to son JOHN my plantation where I now live; son CHARLES my troopers saddle and arms, my Camblet

coate; son BENJAMIN, dau. ELIZABETH, dau. ANNE, dau, MARY, personalty; Wife extrx. to have rest of estate. Wits: Charles Binns, Samuel Lancaster Jr.; John Wall (Bk. 1730-38, p. 314). Elizabeth Champion, his wife, died in 1736 as her inventory was appraised in that year by Robert and Samuel Lancaster and Thomas Bell. Children:

John⁴, m. Lucy (See later) Charles, m. Anne, dau. of Samuel and Ann Judkins, and died in Surry in 1755 when the inventory of his estate was recorded. 34711. Benjamin⁴, m. Elizabeth; sold land in Surry in 1738 and moved to North Carolina, Halifax county, where he made his Will June 8, 1763, probated Nov. 1769. He mentions sons BENJAMIN, JOHN, WILLIAM, dau, LELA, and all my children; exers, son William and SON IN LAW JOHN BELL (Bk. 1-246).

 John Champion, the above son of Benjamin⁴, died unmarried in Halifax. His will was dated May 10, 1773, and probated May 1774. He mentions sister, SELAH CHAPMAN, nephew THOMAS CHAM-PION, son of brother BENJAMIN; brothers BENJAMIN CHAMPION and WILLIAM CHAMPION; sister ANN, wife of JOHN BELL; sister MARY, wife of GEORGE BELL; Exrs. bro. William and George Bell.

IV. Mary, no further record. Benjamin Bell was her guardian.

John 4 Champion, son of Elizabeth (Williams) and Benjamin Champion (d. 1735) of Surry seems to have married Lucy Hart, probably daughter of Henry Hart whose/Will was probated in Surry Nov. 21, 1739. (See Hart.)

21, 1739. (See Hart.) My 165 John Champion, "sick and weak," made his Will Aug. 25, 1755, probated Sept. 20, 1757, as follows: To eldest son, WILLIAM, /plantation whereon Robert Pully formerly lived being part of land my father left me by estimation 100 acres; to son HART, plantation whereon John Gray now lives being land I bought of Robert Savidge: to wife LUCY, plantation where I now live for life, then to son JOHN. If either of my three sons, WILLIAM, HART, or JOHN die under age without heirs that part so deceased shall be to child by wife goes with if a boy." Many slaves and personal property bequeathed to sons, wife and child in esse. Wits. Richard Presson, ROBERT

HARRIS, HAMES CLARK (Bk. 1754-65, p. 104).

William 5 Champion, son of Lucy (Hart) and John Champion, moved to Halifax county, N.C. There he and his first cousin Benjamin⁵ (Benjamin⁴, Benjamin³) and Benjamin's wife, Elizabeth, on Nov. 20, 1770, deeded Joseph Hollaman of Surry for Ł 65 a parcel of land lying on S.S. of the main Blackwater Swamp in Surry adjacent to Benjamin Champion's old field and Hart Champion's land, it being the land which formerly belonged to Benjamin Champion of Surry, grandfather to said Benjamin and William, the said Benjamin Champion being the heir at law of the said Benjamin Champion, the grandfather, and William Champion under the Will of the last mentioned Benjamin Champion (signed) Benjamin Champion, Lucy Holleway, William Champion, Wits; Benj. Barley, Davis Holleway Sr., Joel Thompson (DB 10, p. 92).

William Champion was born about 1745 and about 1772 married Mary Fort, daughter of Anne and Elias Fort of Halifax (See Fort). He was a planter and according to tradition served in the

North Carolina Militia. When on furlough he found it very dangerous to reach his home because of numerous marauding Tories. William Champion was allowed 5 pounds 5 sh. 4 pence as per report of Board of Auditors Oct. 5, 1781 (#206, Comptroller's office papers Vouchers Box C). In 1783 he was paid L 27 by Green Hill, Treasurer of District of Halifax (N.C. Rev. Army Accounts, Vol. VII, page 75, folio 4). On Dec. 23, 1778, William Champion and wife Mary, sold Wm. Edwards of Halifax for L 400, 80 acres adjacent to James Perry, John Bass and Jessie Haney. Wits: John Steptoe, Joseph Carter, John Bass.

Mary Champion died in Halifax after 1790 and William Champion died in Laurens county, Ga., 1825. Children:

He was graduated from the University of N.C.

Martha Boddie Williams was the daughter of General William Williams and his wife, Elizabeth, daughter of Captain Solomon Williams and Temperence Boddie. General William Williams of Martin County was the son of Colonel William Williams and his wife, Eliza-

beth, daughter of Thomas Whitmel.

Colonel William Williams had a distinguished career in the Revolution. He represented Martin County, April 4, 1776, at the Halifax Convention which declared for Independence. He was a member of the Constitutional Convention, Nov. 12, 1776, and signed the first State Consitution. This Convention appointed him Colonel of the Martin County regiment of militia (Wheeler II, 252). He resigned to enter the Continental Army and was appointed Adjutant of the 4 N.C. Sept. 1, 1775; wounded at Germantown Oct. 4, 1777; Capt. Invalid. Regiment April 1, 1778 to April 23, 1783 (N.C. Roster, pp. 50, 499, 501, 502).

1706 Thomas Holt and Francis Holt were administrators on the estate of Thomas Binns, deceased, who is mentioned as deceased in James Mason's will made in 1701. Thomas2 Binns had at least two sons, Charles³ and Thomas.³ Thomas made his will in 1722, and in it he mentions wife and children, names sons Thomas and Charles, brother Charles Binns and goddaughter, Mary Price. He makes his wife and son Charles executors. It was proved by Jane Binns and Charles Binns. About 1748 Charles Binns (probably the brother) made his will in Surry county, and names daughters Elizabeth, Martha and Lucy, mentions wife with child, nephew Thomas Binns, legacies to Sally Binns, Sarah Saunders, Jean Gwathmey, John Champion; nephew Thomas to be guardian to son Charles, and, if he should die, then to "Brother Thomas Eldridge." Of these children Martha married Timothy Rives in 1773, and Lucy married Capt. Richard Avery, of Sussex. Their daughter Sarah Avery married John Cargill, son of Rev. John Cargill, of Surry. Elizabeth Binns, third daughter of Charles Binns, married, in 1758, John Jones, who was a member of the House of Burgesses in 1772, member of the convention from Brunswick in 1788, and late President of the Senate. Probably it was his son, Binns Jones, who was his colleague in the convention in 1788. (Surry County Records.) There appear to have been three distinct Binns families—the family of which we have been writing, the Binns family of New Kent and Charles City counties, and the Binns family of Loudon.)



THE GENEALOGY OF THE STANARD FAMILY MADE AT THE REQUEST OF MY NEPHEW, W. D. STANARD, OF ALABAMA.¹

The first ancestor of the only Stanard family in Virginia, was Beverley Stanard, of Middlesex, Va., who emigrated from England and settled in the County, until his removal to Spottsylvania, Va., where his children settled. Beverley Stanard, the ancestor, died at the early age of forty-five, by the engraving on his tomb-stone in the cemetery of the family at Roxbury, Spottsylvania County. This ancient home is more endeared to me than all earth, besides consecrated, as it is by the tenderest affectionate embrace that on the hallowed banks of the beautiful river of the Potomac, is the Italian Marble's emblem of bereaved affection as constant as its tranquil flow.

Beverley Stanard left three sons and one daughter, William, Larkin and Beverley. William and Larkin had large families, but Beverley never married. William, the eldest son, inherited Roxbury, the homestead and rival farm of Spottsylvania, where he raised a large family, having twenty-three children, seventeen of whom were christened, but only fourteen were raised to mature
