WITNESSETH: That the said part of the first part, for and in consideration of the sum of Fifty Dollars, to him in hand paid by the said part of the second part, the receipt whereof is acknowledged, hath granted, bargained, sold and conveyed, and by these presents doth grant, bargain, sell and convey to part of the second part, his heirs and assigns, that certain tract or parcel of Land, situated in the County of Lowndes and State of Mississippi, known and described as follows:

The North East quarter of the North East quarter of Section one in Township Seventeen Range Sixteen West, containing forty acres more or less

together with appurtenances to said premises belonging, and all estate, title and interest, both at law and in equity, of the part of the first part in the same; to have and to hold the said granted premises, with the appurtenances, unto the part of the second part, his heirs and assigns forever, in fee simple. And the said part of the first part, for his heirs, executors and administrators, doth hereby covenant and agree with the said part of the second part, his heirs and assigns, that the said part of the first part shall forever warrant and defend the title to the said premises, unto the part of the second part, his heirs and assigns, against the claim of all persons lawfully claiming the same, or any part thereof, except on account of taxes due from and after the day of A.
