# DUCKE<u>TT</u>

RICHARD DUCKETT, SR., b. 1673, in London; d. bet. Sept. 15 & Oct. 29, 1733, P.G. Co., Md.; m. Jan. 16, 1698/9, All Hallow's Church, South River, A.A. Co., Md., Charity Jacob, dau. of John and Anne (Cheney) Jacob. She was b. C1681/2, A.A. Co.; d. aft. May 7, 1741, P.G. Co., Md.

He arrived in Md., in 1692, as a servant for 4 years (or, bookkeeper), consigned to Maj. Henry Ridgely. (See Richard Duckett's deposition as to his age, place of birth, & date of coming into Maryland, under Henry Ridgely's entry, the Ridgely chapter.) There is no record in the Maryland Land Office which shows the transportation into Maryland of Richard Duckett or anyone else of the surname. Mrs. Robert L. Hacker of Arlington, Va., not herself a Duckett descendant, recently did considerable research into the family for a friend who is a descendant. Mrs. Hacker, an able and competent genealogist-historian, made several discoveries concerning the Duckett family, and which she later included in her fine ms., The Ancestry Of William Thomas Duckett of Lyon County, Kansas (1965), a copy of which she very graciously and generously presented to this compiler.

Not only did Mrs. Hacker discover the approximate dates of death of both Richard Duckett, Sr., and his wife Charity (and apparently she was the first person ever to do so), but she also disproved the previously accepted English genealogy of the Duckett family. We quote from Mrs. Hacker's ms.(with her permission), from pp. 24, 25 (and a copy of which may be seen at NSDAR Library, Wash., D.C.)

"Ever since Gustine Courson Weaver published the HOWARD LINEAGE in 1929, it has been accepted as fact that Richard Duckett was the first of the Ducketts to come to Maryland, and that he was the son of William and Elizabeth (Henshaw) Duckett of Hartsham, County Wilts, England. Each succeeding biographer of the Duckett family has accepted and repeated these conclusions until it would be difficult to dissuade a descendant from them. If it could be proved, Mrs. Weaver's assertion that he was indeed the son of William Duckett of Hartsham would establish the ancestry of Richard of Maryland back to another Richard, archdeacon and judge in the reign of Henry III. Actually, there is no proof, though it well may be that Richard's remote ancestor, through a lineage not yet proved, was indeed the archdeacon. The lineage which Mrs. Weaver copied from Sir George Floyd Duckett's DUCHETIANNA, or HISTORICAL AND GENEALOGICAL MEMOIRS OF THE FAMI-LY OF DUCKET (1874), fails to show a Richard who was the son of William, nor any other Richard of that generation. In DUCHETIANNA, Sir George says that William and his first wife Elizabeth had only one son, Lyonel. It is remarkable that Mrs. Weaver should reproduce in her book the gravestone legend on Lyonel Duckett's tomb, which says that he was the only son of William Duckett and his first wife, Elizabeth. Thomas E. Duckett, in the Duckett FAMILY HISTORY (1960), also states that Lyonel was the only child of the marriage of William Duckett of Hartsham and his wife Elizabeth, and that by his second marriage to Anne Knight, William had one daughter, Jane. The marriage articles of this daughter Jane, to John Lawford state that 'William Duckett has one son by a former wife.' William's third marriage to Margaret Moore, apparently produced no children. When William Duckett died at Calne in November, 1686, his son Lyonel inherited his estate. Nowhere in these English records is there reference to any son named Richard. Richard Duckett of Maryland did not name any child of his William, although he named children for himself, his wife, and his wife's father [and mother].

Richard and Charity continued to live in A.A. Co., until 1708 or 1709, and their first five children were born there. Richard served as Parish Clerk, not only here, but also for twenty four years in Queen Anne's Parish, P.G. Co., and the fact that we still have extant records of his very legible handwriting, show us that he was a man of some education.

In 1708 Richard purchased 100 acres of land in P.G. Co., from Robert Tyler, and soon thereafter, moved his family to their new home. So far as we've been able

to discover, he never owned another acre, and in fact, lost his land (and virtually everything else he owned), in 1727, to the Rev. Jacob Henderson, in a mort-gage sacrifice. If times had been hard for Richard and his family before (and they must have been), they surely were desperately hard for the remaining years of his life, and even more difficult for his widow and younger children, after that. However, from the humble origins of the Duckett, Jacob and Cheney families, eventually came distinguished citizens not only of Maryland, but of states across the land.

Following, and in chronological order, are abstracts of the few records concerning Richard and Charity.

- 1673 Richard Duckett was b. in this year, according to his own depositions.
- Jan. 26 Richard Duckitt m. Charity Jacob "ye Dafter of John & Ann: Jacob his wife", this date, in All Hallows's P. E. Church, South River Parish, A.A. Co., Md. [All Hallow's Parish Register, p. 11.]

Susanna, wife of Robert Tyler released her dower. Wit: John Gerrard, Thomas Clegett. [P.G. Co. Deeds, Liber C. ff. 222-24.1

(NOTE: Over the years, Richard Duckett's name appeared in a number of probate cases in Pr. Geo's Co., either as an appraiser of an Estate or as a bondsman. It may very well be that his above indebtedness, which eventually resulted in the loss of everthing he and his family owned, excepting only the clothes upon their backs, came about as a result of his going the "bond" of some friend or relative. Such things happened with considerably more frequency in early times, than now. Duckett The above Deposition taken by the Subscriber as one of his L'ships Justices for the County aforesaid this 5th day of Febry 1730. Raigh Crabb." "Above Jacob Wells found on Bullitt Co., Ky. tax list of 1800 with sons and son-in-law Jesse Simmons. (NOTE: The <u>Sunday Magazine</u>, of <u>The Washington Post</u>, under date, Nov. 27, 1966, at pp. 6 & 8, carried an interesting article titled, "Old Greenwood", subtitled, "A Montgomery County estate dating to 1720s is rich in history and decaying grandeur". "Greenwood", the article stated, was an original land grant dating back to 1720, but the house itself, was built about 1735 by Larkin Pierpont. This estate would have been then in Pr. Geo's Co., later in Frederick Co., and finally in Montgomery Co., and of course, the house would have been built after Charity died. The article went on to say that the estate contains an old cemetery surrounded by a rock wall, wherein are burried several of the former owners...and that Larkin Pierpont sold the place to his nephew, Thomas Davis, II, "eight years before the French and Indian War of 1747".)

Lcdr. Duckett was graduate of U.S.Naval Academy 1947; Naval Attache to Poland, 1964; Commanding Officer of Presidential Yacht SEQUOIA, during Truman Administration and Commanding Officer of a Destroyer just prior to his death.

## (II.) JOHN DUCKETT, "JR."

- (II.) John Duckett, "Jr.", is presumed to be the child of Richard and Mary (Nuthall) Duckett, Jr., who was b. Mar. 17, 173 (probably 1733 or 1734), but his name and the year of his birth are not legible in the old Parish Register; living at least as late as June 22, 1780; m. Aug. 9, 1759, Queen Anne's Parish, Pr. Geo's Co., Ann Raitt, dau. of John and Ann Raitt.
  - On Aug. 20, 1759, a few days after his marriage, his father made a deed of gift (abstracted below) to John "Ju""..."of the City of Annapolis, Scrivener" ... of 200 a. of land in Frederick Co., called "Duckett's Misfortune". On Oct. 9, 1763, "John Duckett Jun.of the County [of Pr. Geo's] and Province [of Maryland] Planter", mortgaged negroes, horses and other goods to (his brother) "Richard Duckett, Jun of the County and Province aforesaid Planter". He acknowledged this mortgage (also abstracted below), on Aug. 30, 1765, and this is all of certainty that we know about John "Jr." (called "Jr." to distinquish him from his Uncle John).
  - Aug. 20 Deed of gift from his father, Richard Duckett to "John Duckett, Jun."" of 200 a. called "Duckett's Misfortune", in Frederick Co. [See abstract, this date, under heading "Richard Duckett, Jr.".]
  - Aug. 30 "know all Men by these presents that I, John Duckett Jun of Prince Georges County in the Province of Maryland Merchant for and in Consideration of Richard Duckett Jun of the County and Province aforesaid Planter, his becoming at the special Instance & request of me the said John Duckett Jun. my Security on the Ninth day of October in the year of our Lord One thousand Seven hundred and Sixty three to Daniel Dulany of the City of Annapolis Esquire for the Sum of one hundred and Seventy four pound Eighteen Shillings five pence Sterling money of Great Britain, and the better Security and indem-

nity of the said Richard Duckett Jun. have bargained Sold and delivered unto the said Richard Duckett Jun. his Heirs Executors Administrators and Assigns the following Negroes Goods and Chattles (vizt) one Negro fellow called Peter, one Negro Wench called Betty one Negro Wench called Peg, one Negro Girl called Fan, one Negro Girl Called Nan and one Negro Girl called Sall as also Four feather Bedds and furniture together with the following Horses and Horse Kind vizt (11 horses)...as also all my Household furniture of all kinds and nature whatsoever..." /s/ Jn? Duckett Junr. Wit: Mord? Jacob. [Pr. Geo's Co. Land Records, Liber TT, f. 459.]

- July 27 Presumably the same John Duckett who took an oath in A.A. Co., this date, that he'd "read over the books containing the votes from 1704 -1/15..." [Archives, op. cit., vol. 30, p. 223.]
- C1776 NOTE: Mr. T. Howard Duckett, of Hyattsville, Md. (1967), told this compiler, via the telephone, that he possessed a note issued by the state of Maryland during the Revolutionary War, as legal tender, signed by John Duckett, Secretary of the Treasury of that state. We suppose that it was this John who held that office.
- Nov. 24 "I, [John] Duckett, Clerk", [of House of Delegates], signed...[Ar-1778 chives, ap. cit., vol. 21, p. 252.]
- Dec. 13 The Council directed a letter to John Duckett...[Ibid., p. 502.] 1778
- Oct. 28 "Treasurer ordered to pay 450 pounds to John Duckett for past services as Clerk of House of Delegates... Also (same date), "333 pounds 6 shillings 8 pence for 2 months salary as Clerk to the House of Delegates." [Ibid., vol. 43, p. 46.]
- June 22 "Ordered that the Treasurer pay to John Duckett 274 pounds 3 shillings balance of accts passed by Deputy Auditor." [Ibid., p. 201.]

The issue of John and Ann (Raitt) Duckett have not been proved by this compiler; however, there were several as yet un-placed Ducketts living in Maryland in the late 1700s, one or more of whom may have been the child or children of this John Duckett. They were: Thomas Duckett, m. A.A. Co., June 7, 1788, Ann Cowman -[Brumbaugh, op. cit., vol. 2, p. 432]; Anne Duckett, m. A. A. Co., Dec. 6, 1794, James Frazier - [Ibid., p. 436]; Mary Duckett, m. A.A. Co., Dec. 29, 1785, Richard Frazier - [Ibid., p. 436]; Elizabeth Duck(?), m. A.A. Co., July 19, 1780, Caleb Ely - [Ibid., vol. 1]; and an unidentified (Dr.?) Isaac Duckett, listed in the 1790 Census for Pr. Geo's Co., and likely the Dr. Isaac who m. there on Jan. 24, 1792, Margaret Bowle...rather than Isaac brother of this John (as has been claimed). The Isaac listed in the Pr. Geo's Co. Census was listed with another male (besides himself) over the age of 16, and with one female. The female may have been his mother, and the other male, a brother. The other Isaac Duckett was living in Montgomery Co. , and appears to have been older (there were only these two Isaacs listed in the 1790 Maryland Census, and neither was listed as "Dr."). He was listed with 2 males (including himself), over the age of 16, 4 males under 16, and 4 females. (One Isaac Duckett appeared in the 1800 Tax Lists for Bourbon Co., Ky.)
