ii. Sarah "Sally" A. Duckett, b. Mar. 20, 1769, Frederick Co., Md.; dec'd by Dec. 17, 1827; m. in S.C., Josiah Fowler, son of Richard and Ruth Fowler, of Newberry Co., S.C. (She was shown as an heir to her father's estate in Final Return Papers, Box 24, Pkg. 51, dated Nov. 22, 1825, Newberry Co.

Josiah was dec'd by Apr. 7, 1817 (his will dated Feb. 2, 1817, and proved on Apr. 7 - Laurens Co., S.C., Box 24, Pkg. 13). Following are abstracts of a few papers found in his large Estate file - primarily those naming heirs, etc., as in his will he didn't mention any daughters but named only his wife Sarah, sons "Thomas, Newton" - and named as his Executors, "sons Alhanan Crocker and Als [Alsey] Fuller". (The last two apparently sons-in-

law.) Wits: Abner Pyles, Thomas Burnside, Isaac Mitchell.

APPRAISAL BILL - Total amount of plantation tools, cattle, horses, household goods, 20 slaves, etc., etc. = \$12,603.37 1/2. Appraisers: Thomas Burnside, Benjamin James, D. Mitchell and Benj. Brown.

RETURN FOR 1818 (March 2) - Richard Fowler, Excr. "...Paid Dr. Robert Campbell for his attendance on one of the deceased's children by name of Polly."

1827 - Paper bearing this date in file, contains a statement signed by John Odell (a son-in-law) to the effect that he had been requested to take over the duties of Administrator of the estate of Josiah Fowler, deceased (the son and Excr., Richard Fowler, had died in 1823), and he agreed to take over these duties to the best of his ability, etc.

(ii.) It appears that an unidentified dau. of Josiah and Sarah (Duckett) Fowler, m. Alsey Fuller, son of Solomon and Gillian (Avent) Fuller; but if so, she must have d.s.p., as his descendants claim his wife (and their ancestress) was Anna Jane Cook, dau. of John and Katherine (Griffin) Cook.

(iii.) Elhanan Crocker, son of James and Elizabeth (\_\_\_\_\_) Crocker, Sr., appears to have been a son-in-law to Josiah and Sarah (Duckett) Fowler, and at the time of his demise, C1824, his widow was *Melinda*. They had at least two children, names unknown to us.

- (iv.) We assume that the "Agnes and William Young", twice mentioned as heirs of Josiah Fowler, were grandchildren, and that Josiah therefore had a dau., unidentified and apparently deceased, who had m. a \_\_\_\_\_ Young, and who was the mother of Agnes and William.
- (v.) Ruth Fowler, clearly a namesake of her paternal grandmother, m. her cousin, John Odell, son of Reginald (Rignal) and Mary (Duckett) -Williams Odell. Their issue given under the Odell chapter, infra.

Con't. issue of Thomas & Mary (Odell) Duckett:

- iii. Martha "Patsy" Duckett, b. Mar. 9, 1771, Frederick Co., Md., m. Levi Fowler, son of Richard and Ruth Fowler, of Newberry Co., S.C. He d. intestate, Apr. 17, 1819, "age 50 years". She was mentioned as an heir to her father's estate, upon his decease.

APPRAISAL BILL - recorded in Admr. Book E, p. 39, Sept. 21, 1819 -(Estate and household goods...) Total amount \$3,380.50.

SECOND APPRAISAL BILL - recorded in Admr. Book E, p. 52, Nov. 10, 1819- "...remainder of the personal property of the Estate of Levi Fowler... oats, fodder, wheat, corn, (etc.), pumpkins (\$5.00), cotton, leather, (etc.), 3 bags of fruit \$7.75...geese...the clothing of the deceased, \$40.00, 40 chickens, \$2.50, etc. (no total given).

CITATION ON THE ESTATE OF LEVI FOWLER, DEC'D - July 5, 1819... (on back) - "Read by me publicly July 18th, R. L. Edwards. {Beneath his name) Martha X Fowler, her mark.

The children of this couple did not fare well, and one cannot but wonder whether the fact that the parents were so very closely related by blood to one another, may not have been the reason. Internarrriages between cousins was very common indeed, but this may be one case where it just did not work out. Jacob's parents were themselves first cousins, and when he m. Sarah, he m. his own first cousin on the same side through which his parents were cousins to one another. At any rate, only two or three of their children appear to have lived to marry, and they died in the prime of life, and childless, leaving this branch extinct.

Jacob succeeded his father on the place called "Pennington's Fort", and was himself succeeded there by his own son, Col. James Williams Duckett. [Annals of Newberry, by Chapman & O'Neill, p. 692.] The following deeds appear to have been his, although it is possible that one or more of them may have belonged to his cousin Jacob, son of his uncle Joseph Duckett.

- (vii.) Col. James Williams Duckett (relatives called him "Rich Jim"), d. July 6, 1860, "age 43 years", Sevier Co., Ark., or, Newberry Co., S.C. m. his cousin, Paulina Owens, dau. of Thomas and Alcey (Duckett) Owens Jr. She was b. Apr. 15, 1821, S.C.; d. July 30, 1859, nr. New Boston, Tex., "aged 38 years 3 months & 16 days". Despite his dying so young, he had outlived both parents, his wife, & all seven of his siblings! Both his & his wife's bodies were removed to S.C. (unless he had returned to S.C. by time of his death?), for burial or re-burial. Family tradition has it that Col. Duckett buried his wife in a silver casket, and that when her body was removed to S.C. for re-interment, the casket was opened and it was found that the body had become petrified.
- Col. Duckett and his wife had left S.C., and settled on a farm located on the Red River, nr. New Boston, Tex., and adjoining the Dr. Ware Plantation. After his wife's decease, he moved to Centre Point, Sevier Co., Ark., nr. to relatives. He was listed there at the time of

- the 1860 census (p. 139), July 9(?), 1860. His will was dated, Newberry Co., S.C., Dec. 6, 1858, and will appear in full at the back of this chapter. There were disputes and law cases involving the settlement of this estate, and it does not appear to have been finally settled until late in 1881, twenty years after his decease. No issue.

James Hill, who later removed to Arkansas, asked to be released as Surety for a Bond he and Thomas H. Cromer went with John L. Glasgow, when James H. Williams, as Exec. of estate of J. W. Duckett, paid him the money. Then in 1868, John L. Glasgow died and Frances was made his Adms. (she being the mother of Thomas and she and Thomas being the only heirs). Cromer, as guardian for Thomas, that the action be dismissed and there was no money to pay to him. A notation on one of the papers says, "Pay 1/339".
