## KEY.

The name of the testator is in **Bold Type**; those persons bearing relationship to the testator, if stated in the will, are in bold type also. All others are in Roman Type. The county of testator follows the name in the same line if it is given in the will itself, and if none appears in the abstract the inference must be drawn that it is lacking in the will.

The dates of drawing and of the probate of each are placed one above the other, opposite the name of testator; that of probate under that of drawing. If either date does not appear in the Calendar a line of dashes is placed in the respective place to indicate the fact that it is lacking in the will as recorded, and if, as is the case in a few instances, neither date of drawing nor that of probate appears in the will, a double line of dashes is substituted.

The numbers at the foot of each abstract give the number of the book and the page from which it has been taken. The book numbers and not the old liber numbers are used, this being in accordance with the system usual with genealogists in making notes from these books.

It will be seen that in many instances overseers or trustees are named by testators. The custom now being obsolete it is best explained by a quotation from one of the wills where a testator, after designating several friends for the office, adds: "who shall assist the executrix in the care of the estate that neither she nor the children be wronged!"

Nunc. placed after a name indicates that the will was a nuncupative one.

Young. is used in the calendar as the abbreviation of youngest.

Test., the abbreviation of testis and testes, has been adopted in accordance with the custom of the times rather than the more modern term of witnesses. The other abbreviations and terms are so simple that explanation of them seems needless, since they do not differ from those in ordinary use.

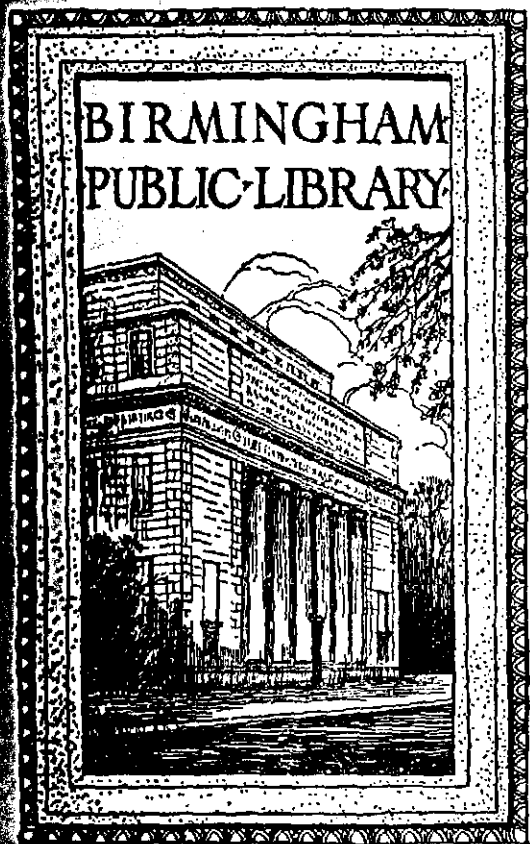

THURSTON, MARTHA, d. by 20 May 1710 when Mathias Gray posted admin. bond, with Joseph Peregooy and John Thomas; est. was inv. 26 May 1709 (sic) by James Read and Thomas Smith and val. at £ 15.9.10; est. was admin. by Mathias Gray on 14 May 1711 (1:214; 14:228; 48:33).

THURSTON, WILLIAM, was in Balto. Co. by 1692 as a taxable in n. side of Patapsco (138).

THWAITE, MARY, and her ch. William and Thomas, were named in the Aug. 1671 will of William Boulding of Bohemia River, Balto. Co. (120:70).

THYLER, GEORGE, m. Catherine Graves on 1 Jan. 1748 (131).

TIBBETT, JAMES, servant, with 2 yrs, 5 mos. to serve was listed in the April 1706 inv. of Col. Edward Dorsey (48:43).

TIBBETT, JAMES, m. Rebecca Wordsworth on 19 Feb. 1760 (131).

TIBBS, WILLIAM, Rector of St. Paul's Par., d. leaving a will 25 Sept. 1732 - 13 Oct. 1732, naming sis. Ann who was to have his dwelling plant.; est. was inv. at over 1000 lbs.; admin. bond was posted 15 Feb. 1732 by extx. Ann Tibbs, with Buckler Partridge, and Richard Caswell (14:216; 125:233; Joseph Towne Wheeler, "Reading Interests of...the Clergy," MHM, 36:187-188).

TIPPER, or TYLER, EDGAR, m. Elizabeth, admnx. of William Pritchett, on 30 Oct. 1713; on 7 June 1734 Edgar and w. Mary (2nd w.?) conv. 176 a. Perkins lot to William Snelson (1:28; 74: 72; 128:30).

TIPPER, ELIZABETH, d. 17 Jan. 1724/5 (128:51).

TIPPINS, THOMAS, d. 8 May 1739 (128:102).

THE TIPTON FAMILY has been the subject of a typescript by Charles Brunk Heinemann, "Tipton Family of Maryland, Virginia, Tennessee, Kentucky, Ohio, Indiana, Illinois, and Indiana," at the Maryland Historical Society, compiled in 1942. More recently Ervin Charles Tipton published We Tiptons and Our Kin (San Rafael, CA, c.r. 1975).

TIPTON, EDWARD (1), probable progenitor of the family, may have settled in Jamaica c.1639 where his son Jonathan was born; was transported to Md. c.1668; claimed land for his service in 1674; may have then moved to Northumberland Co., Va., where it is possible he m. Sarah Towson with Thomas Ford, Charles Robinson, Thomas Sheredine, and Richard Caswell; his est. was inv. on 11 Nov. 1728 by Luke Stansbury and Thomas Matthews and val. at £ 184.9.2; John and Mary Tipton signed as kin; Sarah Towson was admn.; est. was admin. 16 April 1731 by Sarah and her 2nd husb. Elizabeth Mahone on 1 Jan. 1745; his est. was admin. by James Carey on 18 Sept. and 21 Nov. 1754; the first admin. acct. contained an entry for expenses for "burying the wife of the deceased;" Abraham and Elizabeth had two children who chose their uncle William as their guardian; left iss.: MARY; DORCAS (4:224, 240; 14:276; 40:19, 220; 138:158).

TOWSON, THOMAS (7), s. of Thomas (4) and Sarah, was b. c.1725; m. Elizabeth (---) and had iss.: (b. in St. Thomas Parish); THOMAS, b. 25 April 1752; SARAH, b. 18 Jan. 1754; JOSHUA, b. 18 Jan. 1756; HANNAH, b. 23 Oct. 1758; JAMES, b. 21 Sept. 1760; SHADRACH, b. 3 Sept. 1762 (134:36, 37).

Vulcania; in April 1752 he bought part of Gunner's Range from Samuel Gott, and in June 1761 he and w. Dinah sold 18 a. part Towson's Chance, to Isaac Risteau; d. leaving a will, 8 April 1772 - 1 Aug. 1772, naming w. Dinah and ch. THE TRACEY FAMILY has been the subject of a great deal of research by Mrs. J. W. T. Armacost of Hampstead, Md.; she has graciously shared her work with the author.

TRACEY, THADY or TEAGUE (1), was in Md. by 1694 when he m. Mary James on 3 Nov. of that year in St. James Parish, A. A. Co.; d. in Balto. Co. by 18 June 1712; when his est. was inv.; on 30 March 1699 he and his w. sold land called Cuckold Point in Chas. Co.; may be the "Thady" Tracey who pat. 200 a. in Balto. Co. in Jan. 1706 and called it James Meadows; on 10 June 1706 he pat. 100 a. Tracey's Park; on 9 Sept. 1709 sold 100 a. part of James Meadows to Mordecai Price of A. A. Co.; admin. bond on his est. was posted by Mary Tracey, with Dutton Lane and Jonathan Hanson, on 16 June 1712; his est. was admin. by the wid. Mary, now w. of George Hitchcock on 22 July 1713 and 31 Aug. 1714; had four ch. b. in St. James' Par., A. A. Co., and poss. one other s. James Meadows, to his step-father George Hitchcock; by March 1745/6 had moved to Craven Co., N. C., when he appointed John Ensor his atty. to conv. James Meadows and Teague's Park to John Cole; may have been the father of James and Nathaniel, two Revolutionary soldiers from N. C., but this has not been proved (69:397; 79:248; 219-3).

Mary, dau. of Absalom Barney; JOHN, m. Feity (Unpublished research by Mrs. Armacost and hypothetical placement by the author; this line needs a great deal more work).

TRACEY, SAMUEL, of Balto. Co. imm. c.1670; d. by 23 March 1675/6 when admin. bond was posted by Giles Stevens, with Thomas Long; on 9 March 1670 had surv. 200 a. Tracey's Level; dau. ANN m. Richard Taylor in 1687 (14:197; 97:124, 125; 98:46; 99:347; 211; 263).

Lewis Cocks were almost undoubtedly among the earlier settlers in Virginia.

4. **Representatives of Cocks Families in England 1600-1635.** We return now to Thomas Cocks, who, as will be recalled, had moved from Kent to Gloucester (1540, say) and taken up his residence at Bishop's Cleeve which was at no very great distance from the busy seaports of Bristol and Plymouth which were destined to become the centers of a brisk trade with the new world. He married Elizabeth, daughter of Roger Holland, Esq., of Dalton, co. Lancaster, by whom he had a large family comprising ten sons and three daughters who lived to be prosperous men and women (Lady Somerset's Eastnor Castle; also, Rudder's Gloucestershire, p. 420, and Va. M. H. & B., V, 308, 310. For the purposes of our argument it is significant to note that the second husband of one of his daughters, Dorothy Cocks, was Sir Charles Percy, to whom she was married in 1620; she died in 1646 (Va. M. H. & B., V, 309, 318). Her brother-in-law, therefore, was Hon. George Percy, one of the leaders of the original company at Jamestown; which affords another probable explanation of the appearance of Cocks in early colonial Virginia.

Concerning nearly all the sons of Thomas Cocks, some information can be given. The eldest, Thomas Cocks, resided at his estate, Crowle, in Worcestershire in 1634. Richard Cocks, the second or third son, lived at Castleditch in Herefordshire where he was High Sheriff of the county of Hereford, in 1615. Another son, Christopher Cocks, was sent by King James I on an embassy to the Czar of Moscow; and, incidentally, it is here that we meet the name Christopher for the first time, which will recur both in England and in Virginia, and seems to be of special significance in our present inquiry. In the inner hall of Eastnor Castle hangs a portrait of Christopher Cocks in tartan costume, and beside it a portrait of his wife to whom he was married in 1573 (Lady Somerset's Eastnor Castle; also, Va. M. H. & B., V, 309, 318, 319). Charles Cocks, Esq., who was 'bencher of the Middle Temple' (d. 1654), was one of the two sons of Thomas Cocks that were 'bred to the law' (Va. M. H. & B., V, 309, 318). Four other sons we are told were merchants, one of whom was John Cocks, of Hawkstede, Co. Suffolk, who was engaged in adventures in the old East India Company, and in Persian expeditions, apparently being a person of considerable wealth at the time of his death in 1629 (Id., V, 310, 318). We see therefore that he was a contemporary of Richard Cox of the Grocers Company in London, who was actively engaged in the East India trade and a member of the Virginia Company, and we suspect they were closely associated in business and perhaps nearly related in other ways. Another of these brothers was 'James Cocks of London merchant an 1634' (loc. cit.). It is likely that Christopher Cocks above mentioned should be included among the four brothers who were merchants, which would leave one of them still to be accounted for. In the absence of any information, we venture to guess that this was probably none other than Robert Cocks, grocer of London, who, together with Richard Cocks or Cox, was one of the incorporators of the second charter of Virginia. Finally, the youngest of all these brothers was Peter Cocks, rector of Bishop's Cleeve, d. 1612 (Id., V, 310, 319), whose name recalls that of Peter Cocks, of Norwich (1560), and seems to suggest that the Cocks of Norfolk and Gloucester were related. Later, in 1638, we find also a Peter Cocks in Suffolk mentioned in the will of his brother Rev. Mathew Cocks (Id., V, 319). We know that two of the sons of Thomas Cocks were clergymen, and it is just possible that the other one was Rev. Henry Cocks who was living in London in 1587 (Id., V, 308, 314).

More than once we have had occasion already to speak of a branch of the Cocks family that seems to have been located in Devon and Cornwall from very early times. The Cornishmen were a hardy race engaged for

In the reign of Henry VIII (say, about 1540) Thomas Cocks, of Cock Hall, son of Thomas Cocks and Alyce Lychfield, sold his estate in Kent and removed to Gloucestershire, where he purchased a property in the parish of Bishop's Cleeve, some little distance northeast of the city of Gloucester and not far from Malvern Hills (Id., V, 308, 313; also Lady Somerset's Eastnor Castle). As he was the founder of the family of Cocks of Gloucestershire, we shall refer to him hereafter as Thomas Cocks, of Bishop's Cleeve.

In 1545 when (as we suppose) Thomas Cocks had already been established some years at his new home in Gloucester, 'the manor of Willemsley and the demean lands thereof, lately belonging to the abbey of Evesham, were granted to John Cock and John Wrath, 36 li. 8s.' (Rudder's New Hist. Gloucestershire, 1799, p. 823; Va. M. H. & B., V, 312). Evesham, where the great earl Simon de Montfort was killed in battle in 1265, is in the southeast corner of Worcestershire near the border of Gloucestershire. Probably the above individual was John Cocks, of Broxbourne (Va. M. H. & B., V, 314, 315, 316, 317). By 1560 the Cocks of Broxbourne had become a powerful family. John Cocks, Esq., was succeeded by his son Sir Henry Cocks, of Broxbourne and Ponsbourne, who died in 1600, aged 71. It was his daughter, Elizabeth Cocks that married Robert West, son of Thomas Lord de la Warr, about 1600 (Id., V, 309, 314, 315, 316). Lord de la Warr was first lord governor and captain general of Virginia; his younger brother Francis West, who was the comrade of Captain John Smith at Jamestown, was afterwards also governor of the colony.

Thus, according to the above summary as compiled from the scattered records, it may be inferred that until about the middle of the sixteenth century the seats of the Cocks families in England were to be found mainly in the adjacent counties of Kent and Surrey in the southeast of England, also in Hertford and Essex, and at the opposite extremity of the kingdom in Devon and Cornwall. However, soon after 1540 we begin to discover them in Norfolk and Suffolk in the east and in Gloucester, Hereford, Worcester and Berks in the west, and occasionally also in some other counties.

About 1560 the name re-appears in Essex, where now we find Richard Cocks, Esq., of Prittlewell, son of John Cocks, of Shopland, and Elizabeth Wentworth (Va. M. H. & B., V, 305). At this same period a prominent family of Cocks arises in Norfolk county; presumably, Peter Cocks, of Norwich (Id., V, 319, 322) was the ancestor of Colonel Charles George Cocks who died about a century later and is referred to as 'the famous Mr. Cocks the sequestrator in the late troublesome times' (Blomefield's Norfolk, IV, 151; Va. M. H. & B., V, 321, 322).

Apparently, Cocks had also been living in Surrey ever since the days of Gilbert le Cok, for in 1562 Rev. John Cocks was vicar of Effingham (Id., V, 304, 324), and long afterwards the name continues to be met with in Surrey county.

In the annals of England the year 1588 is memorable for the defeat of the Invincible Armada. One of the minor heroes of that great victory was Captain William Cocks, of Plymouth, 'the Cocks of the Game', as he was called who, in the words of Sir Richard Hawkins 'died with honour amidst his company', being indeed the one Englishman of note who lost his life on that occasion (Va. M. H. & B., III, 414; V, 183, 184, 314, 317, 318). The supposition is that he was of the same family as Lewis Cocks of Plymouth in Com. Devon, whose pedigree can be found in the 'Visitation of the County of Cornwall, 1620' (Har. Soc. Pub., IX, 43); which is of great interest to us, because, as we shall see presently, the descendants of

This alliance would seem to furnish a clue to the immigration of Cocks to Virginia. Doubtless, it was with this marriage in mind that Dr. Alexander Brown, in his book on The Cabells and their Kin, asserts that the Cocks family in Virginia was allied by marriage to the family of Lord de la Warr.

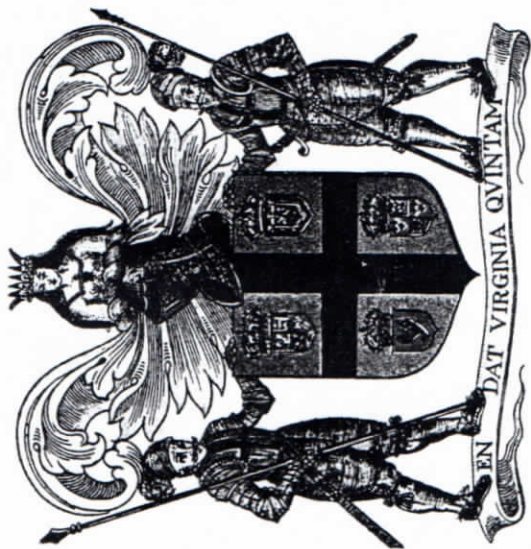

In 1619, a year marked by several important events in the Colony, including the assembling of the first General Assembly, the London Company adopted a "Cote for Virginia". The coat-of-arms has been a puzzle and source of speculation to every historian and has been sometimes confused with the proper seal of the Colony itself. It is found as a book plate or frontispiece in nearly all of the printed acts and official proceedings of the Colonial government. It appears in Smith's *General History of Virginia*, editions 1624 and 1632; in Beverley's *History of Virginia*, in several issues of the *Virginia Gazette*, and in Stow's *Survey of London*, published in 1633. It was changed slightly from time to time to make the quarterings agree with the arms of the different reigning houses, and after the union of England and Scotland "quartam" succeeded "quintum" in the motto. The illustration is from the title page of *Merchants of Virginia* in the Virginia State Library.
