Hill, was son of Ralph and Eliza. Parker, he b-in Eng., d-1695; founded a town, Billerica and his house was used as a garrison during King Philip's War. He was representative in general courts of Mass. 1689 and again 1692. He m— Martha Toothaker, b—1635, d—1704, dau—of Roger and Margaret Toothaker of Plymouth. Had 6 children. Of these, Capt. Samuel Hill, b—1672, d—1755. He m— the widow Deborah Whiting. Her first husband was Samuel, son of Rev. Samuel Whiting, first minister of Billerica. Had issue—9 ch. He served in Revo. and at Fort Wm. Henry prior to that time. His son Samuel, Jr., m—1760 to Sarah Cutler, had 2 children. Of these Rev. Ebenezer Hill, b—in Cambridge, Mass., 1766, d—1854, grad. of Harvard and minister of Mason Church sixty-four years. He m—Polly Boynton, she d—1794. He m secondly, 1795, Rebecca Bancroft (widow Howard). His third wife was another widow, Abigail Jones Bateman (widow Stearns), dau-of Col. Timothy and Rebecca Bateman. Children by first wife, 3; by second, 2; by third, 9—14 children. A son by second wife, Rebecca Bancroft (Howard), was Rev. Joseph Bancroft Hill, b-N. H. at Mason, 1796. He m-Harriet Brown, whose issue were all men of letters. It was said her son, Charles Ebenezer Hill, who was a trustee of Woman's College, which became Goucher of Baltimore; that he was consistent with his heritage of Puritan Ancestry and his life was devoted to a service for his fellow man, whether that service was to State, Family, or Neighbor. He m-Kate Watts Clayton, had three children. Of these John Philip Hill, who was b—in Annapolis, graduate of Johns Hopkins and Harvard University, a lawyer and Representative in Congress of U. S. A. from Md. to becoming a Brig.-Gen. The Maternal lineage of John Philip Hill was through Kate Watts Clayton, dau—of Philip Coleman Clayton and Cath. Guest Schwarar, b—1819, m—1837, d—1901 (dau—of John Geo. Schwarar and Keturah Watts, b—1794, d—1862). John Schwarar's mother was a Watkins. Philip C. Clayton was son of Capt. Philip and Mary Ann Brewer, b-1812. He was son of Samuel Clayton and Ann Coleman Clayton, m-Harriet Strother. He was vestryman of St. Mark's Parish, Va. m-Coleman, dau-of Robt. Coleman, of Culpepper, Va. Samuel Clayton was son of Maj. Philip Clayton, son of Samuel and Eliz. Pendleton, he d—1786. A Vestryman of St. Marks of Culpepper, Va., in 1745 Maj. Phil. Clayton m— Ann Coleman; Samuel Clayton, b-1684, m-Eliz. Pendleton, b-1684, dauof Philip Pendleton and Isabella Hart, both b-in Norwich, Eng., m-1682, d-1721. The parents of Samuel Clayton, were John, who m-Miss Page. John came to Va., 1705, he became attorney-gen. of Va. 1714, a Burgess of Va. Miss Eugenia Calvert Holland. 4713 Roland Ave., Roland Park, Baltimore, Md. (*Memb. and Cor. Sec. of The Md. Soc. of Colonial Dames*)

Mr. William Calvert Holland, 4713 Roland Ave., Roland Park, Balto., Sir George Yeardley was one of the ablest and most popular of Virginia's Colonial Governors. His public acts are matters of history, and many of them have been published and commented upon in a number of historical magazines. Sir George Yeardley came to Virginia in the "Deliverance" in 1609 (see Hotten's lists). He was a member of the Virginia Company of that year and became Deputy Governor of Virginia Company of the Virginia Company of ginia, 1616-17. He returned to England in 1618, and in the latter part of that year was knighted and appointed Governor of Virginia, returning to the colony in 1619. He summoned the first Legislative Assembly ever held in Virginia. He was a member of the Council in 1625 and was again appointed Governor in 1626, which office he held until his death, November, 1627.

Sir George Yeardley owned three thousand, seven hundred acres of land at Hungar's Creek, Northampton County, Eastern Shore of Virginia, and this land is still known as Yeardley. (Now owned by Dr. Griffin W. Holland, of Eastville, Virginia.)

Governor Yeardley's wife was Temperance Flowerdew, dau-of Anthony and Martha Flowerdew of County Norfolk, Eng. After Sir George's death, she m—Capt. Sir George Yeardley is considered one of the most remarkable men who were prominently connected with the early government of Virginia under James I. FOREWORD Hellary

Prince George's County is an old and important county in the development of the Colony of Maryland. In, 1696 the upper portions were taken from Calvert and Charles County to form this new county which included all of Western Maryland. By 1746 actilement of the western lands was sufficient to make feasible the formation of Frederick County from portions of Prince George's and Baltimore. In 1776 Montgomery County was cut from the south-eastern portion of Frederick County while Washington County was taken from the north-western part. Washington County was then divided in 1789 to form Allegany County and in 1837 Carroll County was formed from portions of Baltimore and Frederick County. In 1872 the last county to be established in Maryland was taken from the western portion of Allegany and called Carrett County. Thus for 52 years most of the land now belonging to these counties was called Prince George's County. In the 1702-1709 period covered by these records there were few plantations located west of the present-day Montgomery County line, while the area-of present-day Prince George's County was so well actiled that land was being resurveyed to correct boundaries.

These land records are a valuable resource for genealogists researching Prince Ceorge's and surrounding counties. They consist mainly of deeds which show the name of the seller's wife (if any), show her maiden name if the plantation came through her family, and occasionally include the name of the buyer's wife. Sometimes they include the names of children, siblings and other relatives. Many persons from Calvert, Charles, Anne Arundel, baltimore and &t. Mary's Counties bought and sold land recorded in the recorded during this period as well as Virginians and Englishmen. Merchants and mariners of England and Scotland recorded letters of Attorney and deeds. There are several leases and deeds of gift of both land and slaves. Oaths of allegiance for the representatives of Queen Ann were recorded.

The spelling of persons, plantations, and landmarks was not consistent, even in the same document. The scribe who wrote the majority of the records consistently spelled field with the letter e before the letter i and his spelling was copied throughout this book. For the most part the spelling is presented in this volume as it appeared on the microfilm, but in some cases it was modernized where it could make no difference to the researcher. Example: Edinburgh instead of Adenborrough. Some of the archaic spelling and peculiar phrasing was included in parenthesis to add interest and color to this book and some was used without parenthesis added. The folio numbering is duplicated in some instances on the original documents, but, since indexing is according to book page number; this should not cause confusion for the researcher.

The English pound sterling was the currency of the Colony. For simplicity this has been presented as £/a/p (pound/shilling/pence) with the numerical figure before the symbol (example: 10£/5a/4p). The survey measurement was a perch which is the equivalent of a present day rod, 5 1/2 yards or 16 1/2 feet. Since both the Julian calendar, which began the new year on March 25th, and the Gregorian calendar, which starts the new year on January 1st, were used, some documents show both dates written, for example, as 1702/3.

In 1699 the Court House and Church Yard were laid out in Charles Towne. In 1707 the first lots were recorded in Charles Towne Court. Records for the town of Mariboro. The plat of the Court House and Church Yard of Charles Towne was recorded along with several other plats in the latter part of the Court. Records. These interesting drawings have been meticulously copied and included, but it was not possible to copy them to scale working from the microfilm.

It has been my pleasure to abstract this naterial for publication, and it is my hope that this book will be of value to those interested in the land and the atout-hearted people who actiled and developed Prince George's County and the Colony of Haryland.

In 1619, a year marked by several important events in the Colony, including the assembling of the first General Assembly, the London Company adopted a "Cote for Virginia". The coat-of-arms has been a puzzle and source of speculation to every historian and has been sometimes confused with the proper seal of the Colony itself. It is found as a book plate or frontispiece in nearly all of the printed acts and official proceedings of the Colonial government. It appears in Smith's Generall Historie of Virginia, editions 1624 and 1632; in Beverley's History of Virginia, in several issues of the Virginia Gazetta, and in Stow's Survey of London, published in 1633. It was changed slightly from time to time to make the quarterings agree with the arms of the different reigning houses, and after the union of England and Scotland "quartam" succeeded "quintum" in the motto. The illustration is from the title page of Merchants of Virginia in the Virginia State Library.


