serve Sam Huby "fower years". He is to receive for his services "Meate, drinks, apparell, washinge & Lodginge and all other necessaries". At the expiration of his term, he is to be given "one Heifer of two yeares old, a young Sowe and three Barrels of Corne".

Stealing hogs from the English seems to have been a favorite pastime with the Surry Indians. The following order was entered by the Surry County Court, March 5, 1671. "Upon the Complt. of Christo Holiman itt manifestly apearance that the Coppahunck Indians have kild two hogs of the sd Holimans itt is ordered that Capt. Pipscoe within three Months make paymt unto the sd Holiman of six Buck and six doe well drest skins & in case itt doe apeare hereafter that any Indian shall kill any hogg or hogs of the Englishes that they shall pay for every hog by them kild twenty Buck skins". Prior to this, in Sept., 1663, on account of "diverse thefts committed by the Indians on the southside of James river", which the neighboring Indians affirmed to have been done by the "Tuscarores", an act was passed by the Assembly prohibiting the English entertaining any Indian without a badge to show what town he was from. These badges had been provided for by an Act of March, 1662, and were made of silver or copper, with "the name of the towne graved upon them", and were delivered to the kings to be given their people when they came within the "English bounds".

See notes on "Floods" in reference to Indian messengers and their striped coats.

It was Chanco, a Surry Indian, who with Mr. Pace of Pace's Paines saved the Jamestown colony in the massacre of 1622. (See notes on Pace's Panes). There is a tablet to the memory of Chanco on the walls of the church at Jamestown.

Some of the Indian names that are retained by us are "Chipoax" or "Chippokes", the name of a plantation and two creeks, Upper and Lower Chippokes; "Pocatink" swamp and plantation near Derring's Mill; "Pipsico" plantation, named for an Indian chief; "Rockyhock" the name of a church and also of a swamp; "Johnchichehonk" swamp, mentioned in a patent in 1684 as "Johnchecohunk" and in the County records in 1694 as "Johnchecohunk". "Jnoshehocen" is still another way of writing it, and there is a "Johnshehawkin" road.

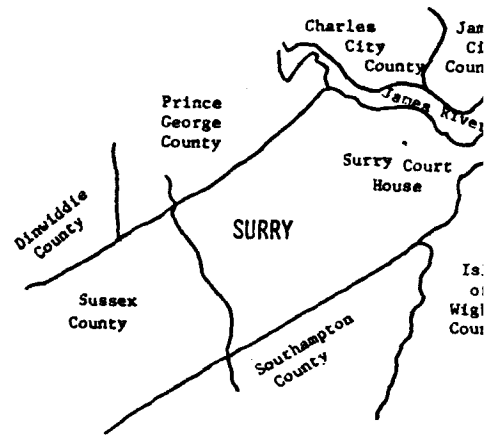
