MATTHEW HOWARD, SR. was probably 5. at least by 1610, and since he was not listed among those persons living in Va., at the time of the "Muster" of 1624/25, he clearly was not b. in Va. He d. sometime bet. 1652 and 1659, in Va.; m. possibly C1635, Ann (), whose transportation into Va., he claimed - probably having brought her here, himself. It isn't known when Ann died. Her last child was b. C1651.

As will be shown below, the earliest record in America which mentions the name of Matthew Howard, of which we have knowledge, was dated 1635, and the last was in Dec. 1652. His wife Ann. was first mentioned in Va. records on May 26, 1638, with no further known reference to her after July 6, 1640, although she undoubtedly lived a number of years after this.

It seems likely that Ann, the mother, had died only shortly before the children came to Maryland, in 1659.

It doesn't take too much imagination to picture in one's mind, that little family of orphans, the two eldest being the sisters. Ann. who would have been about 22, and Elizabeth, about 20, scurrying around, packing up all belongings, and finally saying goodbye forever to the only home they'd ever known, near which both parents lay buried, and embarking aboard a ship that was to carry them to their new home in Maryland. It would probably have been spring or summer, since they had to build a shelter for themselves after their arrival.

Perhaps Edward Lloyd had found them a place to stay with some neighboring family, since he seems to have preceeded them and likely was instrumental in hurrying their move. After all, 9 years had already elapsed since he'd laid out land for their father.

Matthew. Jr. would have been about 18, and Cornelius about 16, the two men of the family, John 14. Samuel only 12. Philip but 10, and little Mary only 8.

After their Maryland arrival, the family was unexpectedly split up, as Ann and Elizabeth were quickly wooed and won by two of a female hungry Maryland society of bachelors, and they must have taken the 3 youngest siblings with them for a few years. leaving the older boys to settle their land and build a home. What a task! But how exciting!

In his, Founders of Anne Arundel and Howard Counties, Maryland, p. 68, Prof. Warfield states (by what authority, we don't know), that Matthew Howard was the son of one of three or four John's Howard (or Hayward), three of whom were among the English members of the Virginia Companies". These were, "Mas-J ter John, Rev. John, and Sir John Howard, Knight". Prof. Warfield says these three "contributed, in all, Ell2 and 12s ", to the Virginia Company, as recorded in First Republic, by Alexander Brown. A possible fourth was "a John Howard, who had come with Edward Bennett's first company, in 1621, [and in 1622] was killed by the Indian massacre..."

The late Charles Francis Stein, Jr., in his, Origin and History of Howard County, Maryland (1972), had this to relate, regarding this family: "The Howard family, which Harry Wright Newman in his Anne Arundel Gentry has called one of the most aristocratic and distinguished of Maryland families, and which gave it's name to Howard County, was founded by Matthew Howard, who came up from Virginia with the Puritans, and settled at Round Bay on the Severn River!. His sons and daughters followed him a few years later. I Mr. Stein was in error in stating that Matthew Howard settled in Maryland, He did come up with Edward Lloyd in 1650, and had lands of his choice in the area of Round Bay, surveyed for him, so he obviously intended to move his family up, but he returned to Virginia and died there before such a move could be accomplished, and his lands were never confirmed to him. His children came later and chose land in the same general area, and it was patented to them.

In origin the Howards precede the Norman aristocracy of England and date back to the ancient Saxon nobility. According to Newman, there was a Hereward (Howard) living in Norfolk in the time of King Edgar (957-973 A.D.). He was of the family of the Saxon leader, Hereward, known as Hereward the Wake, who fought against William the Conqueror, and was banished after the Norman Conquest in 1066, but eventually was permitted to return and claim his ancestral estates in Norfolk.

The late Mr. James E. Moss apparently read Mr. Stein's treatise on the Howards, and was so captivated that he spent a great deal of time and financed considerable genealogical research in England on the Howard lineage (as countless others have done before him). He failed to find all the desired proof, but he did come close to it, and presented his findings in an interesting book, Providence Ye Lost Towne at Severn in Maryland (1976), in which he stated that Matthew was a son of John (1578-1642) and his wife Elizabeth Lock. John, he said, was a son of Robert Howard (1537-162-) who m. 1574, Phillipa Buxton.dau. of Thomas Buxton...and Robert was a son of Lord Thomas Howard, whose wife was Lady Margaret Douglas, day, of Oyeen Margaret of Scotland, and neice of Henry VIII. This is heady stuff...what a pity absolute proof cannot be found! Mr. Stein gives the Arms for this family as: Gules, a bend between six crosslets fitchee argent. Crest: A lion statant gradent argent, holding a crosslet fitchee of the shield, and he also illustrates the Arms,

There appears to have been some degree of relationship between Matthew and/or Ann, his wife, and the brothers Cornelius and Edward Lloyd (who came from the Severn River area of Wales), and also between them and Richard Hall - all parties of Lower Norfolk Co. (Later, Norfolk Co., but now called Chesapeake), Va. The Lloyds and Richard Hall were persons of some importance in early Va. Col. Cornelius Lloyd, who died in Va., intestate, in 1655, was a member of the vestry of Elizabeth River Church, there, in the late 1640s. His bro., Edward, served both as burgess and justice of Lower Norfolk. By 1645, Edward Lloyd's name was associated with Anne Arundel Co., Md., and he later became "commander of Providence [on the Severn River, in Md., which river he named], a title kindred to that of deputy-governor" [Warfield, op. cit., pp. 6, 7, 10]. Even later, he settled on the Eastern Shore of Md., at "Wye House", and finally died in England, in 1696 [Jester, op. cit., pp. 223-4].

According to Prof. Warfield (op cit., p. 68), Richard Hall was a member of the "Grocer's Court", of England, in 1610, at which time he contributed £100, to the Virginia Company, and he was later a merchant in Va.

Much has already appeared in print on the Howard family of Va. and Md., since the turn of this century, and since we cannot, to our regret, add anything new, we are limiting ourself here, to a brief resume of what is known of the first few generations. Following are what extant records there are, mostly abstracted, concerning Matthew and Ann Howard, and these are followed by their children and some of their descendants. Matthew Howard unfortunately died intestate, but every one of his sons left wills, as well as every one of his sons-in-law, and one dau., which is guite remarkable!

- 1635 Matthew Howard was in Va., by this year, when he was involved in a suit with a Mr. Evans. [Warfield, op. cit., p. 68.]
- Oct. 26 Court Proceedings...Lower County of New Norfolk. "Whereas it doth appear that John Boulter did buy of Matthew Heyward four bbls. of Indian Corn being in the house of Robert Jones...the aforesaid Boulter coming to demand a while after, without any notice or token from under Heyward's hand the said Jones denied to deliver, but being very earnest for it, the said Jones delivered two barrels and a bushel of it. It is therefore ordered that the said Robert Jones shall repay the aforesaid corn by the 1st of January, or else execution to be awarded." [Norfolk Co. Minute Book, 1637-46, p. 6.]
- Robert Taylor patented land in the "Up. Co. of New Norf...bounded on the W. with Mathew Howard". [Nugent, op. cit., p. 79.] 1637/8

"MATHEW HAYWARD, 150 acs. Low. Co. of New Norf., 26 May 1638, p. 561. E. upon the W. br. of Eliz. Riv. & N. upon the broad cr. runing out of sd. branch. Due for trans. of his wife Ann & 2 pers." [Ibid.. p. 89.] (NOTE: The date of this patent is not an indication that Ann had just arrived in 1638, and it seems certain that in fact, they had one or two children by this date.)

"At a Court holden at William Shipps The 6th of July, 1640 Present -July 6 1640 Capt. Thos. Willoughby, Esgr. Capt. John Sibsey Mr. Henry Sewell Mr. Francis Mason Mr. Edward Windham Mr. William Julian...Whereas it appeareth to this Court that Eady Hanking hath spoken divers reproachful words against the wife of Matthew Haward, which she cannot prove; it is therefore ordered that the said Eady Hankin shall ask the said Haward's wife openly, forgiveness both at the house of Mr. William Julian on Friday next and also at the Parish Church the Sunday following, and defray the charges of the Court.

> "...Simon Peeter-age 28 years deposed: sayeth: that he heard Eady Hanking say that Matthew Hayward's wife did live as brave a life as any woman in Virginia for she could lie abed every morning 'til her husband went a milking and came back again and washed the dishes and skimmed the milk, and then Mr. Edward Floide (sic) would come in and say 'Come neighbor, will you walk?' and so they went abroad and left the children crying. That her husband was fain to come home and leave his work to quiet the children-Further sayeth not." Peter Riglesworth declareth the same upon oath." [Virginia Historical Magazine, pp. 40-1, 43, vol. XL.]

Matthew Howard and Robert Bowers applied for the administration on Nov. 6 1646 the Estate of Robert Jones, who d. intestate, and it was granted them. [Lower Norfolk Co. Court Records, 1636-46, p. 24.]

Richard Hall wrote his will this date, and which was proved, Nov. 16, Aug. 1 1648. in which Matthew Howard and his children were almost the sole 1648 legatees. (Given in full at the back of this chapter.)

June 10 Matthew Howard wit, the will of Edward Hodge, [Norfolk Co. Wills & 1649 Deeds, Book B, p. 119.]

July 3 A tract of 350 a. called "Howard" was laid out for Matthew Howard of Ann Arundell County, planter...lying on the south side of the River-Severn near a creek called Marshes Creek, beginning at a Hollow in the said creek and extending south of the creek and a swamp called Howard's Swamp..." There was also laid out for him 45 a. adjoining the above tract on the east, and 255 a. south of Howard's Swamp lying on the west, the total containing 650 a. [Patents A.B.& H., f. 258, Hall of Records.] (NOTE: While Matthew Howard was herein spoken of as "of Ann Arundel County, planter", it seems likely that he was in Md., preparing to bring up his family from Va. These lands were surveyed for him by Edward Lloyd, and Prof. Warfield (op. cit., p. 67], says, "This record indicates clearly, that Matthew Howard came up with Edward Lloyd, in 1650." It is obvious that he expected to bring 12 other persons besides himself, since at that date. Lord Baltimore was allowing 50 a. per person, for those who came to Maryland to inhabite. Matthew, with his wife Ann, and his then seven known children, would have made 9 persons, and he perhaps intended to transport 4 servants, or neighbors. The fact that he died before he could do so, is evident in the fact that such an entry does not appear of record in the Land Office Records of Maryland, although at a later date, his children, or most of them, do appear as having transported themselves, or, in the case of his dau. Elizabeth, as having been transported by her husband. Land was never claimed for the transportation of Matthew, Sr., or his wife Ann.

II. ELIZABETH HOWARD

II. Elizabeth Howard, prob. b. C1639, Lower Norfolk Co., Va.; d.aft. 1669 but bef. 1673, Md.; m. bet. 1659 and 1664, A.A. Co., Md., Col. Henry Ridgley. She was also a legatee in the 1648 will of Richard Hall, and her husband claimed land rights in 1664, for having transported her into Maryland. Actually, it seems doubtful that such was the case. Probably she transported herself, or perhaps one of her brothers brought her to Maryland, but if a woman married before land rights could be claimed for her, it was customary to allow her husband that privilege. Her bro. Cornelius came to Md. in 1659 and prob. the others too, and Elizabeth with them. For known issue of Col. Henry Ridgley, which we believe to also have been Elizabeth's, see the Ridgley family.

III. MATTHEW HOWARD, JR.

III. Matthew Howard, Jr., prob. b. C1641, Lower Norfolk Co., Va.; d. testate, A. A. Co., Md., bet. Oct. 3, 1691 and Jan. 19, 1694 (dates of the writing and proving of his will (Given in full at the back of this chapter.); m. bef. 1667, Sarah Dorsey, dau. of Edward and Ann Dorsey. She predeceased him. [See: The Dorsey Family, by Dorsey and Nimmo (Baltimore, 1947.).]

Matthew, Jr., was a legatee in the 1648 will of Richard Hall, in Va., and in the 1684 will of one Henry Howard, of A.A. Co., Md. He and his bro. John, were each left "a silver seal". (This will also given in full at the back of this chapter.)

He immigrated to Md., from Va., bef. 1659 [Skordas, op. cit., p. 216], and in 1661, Henry Catlin, also from Va., and one of Edward Lloyd's commissioners, assigned his Md. survey to Matthew, Jr., who then re-named it, "Howard's Inheritance" [Warfield, op. cit., pp. 44, 68.]

Matthew claimed land rights for having transported Sarah Darey(sic), prior to 1667, when he styles her, his wife. [Skordas, op. cit., p. 122.]

I give one Sow chote of a twelve month old to Mathew Howard the younger I give one Sow pigg to Cornel[ius] Howard and my hatt. I give one Sow pigg to John Howard and my work clothes 8 my handkercheifes I give unto Math[ew] Howard the elder my best paire of breeches; I give unto Samuel Howard all the tob⁰ that is coming unto mee after my debts are payd I give unto Thos. Bell my bedd, bouls[ter]8 blankett & my chest & my old suite went I nowe have on & one payre of shoes & stockins; I desire Howard [the] elder [to be] my sole Executor of this my last will b testament [In] Witness hereof I have hereunto sett my hand this twenty first day of August 1648. /s/ Richard Hall Signed & deliv[ered] in the presence of Cornelius Lloyd. The mke of Tho.
