could not influence others to his opinions, he returned to England, 1646, and from there set sail, 1648, for Barbados, where he lived at St. Michael's until his death. He left will, 31 July 1655–12 June 1657, dated at Barbados,²⁴ which mentioned "my estate in this Island, New England or any other part or place in the world," named son John "not now in the Island," daughter Anna wife of Nicholas Ware, daughters Margaret and Mary Vassall "all now here," daughter Judith wife of Resolved White and daughter Frances wife of James Adams.

He married, (license 9) June 1613,25 Anna King, born about 1593, daughter of George King of Cold Norton, Essex, and his wife Joane.

Issue: 24. Anna³, born 6 Sept. 1614 at Cold Norton, died 22 Sept. 1614; 25. JUDITH³; 26. FRANCES³; 27. Samuel³, twin, born 22 June 1624, died 16 Nov. 1624; 28. Mary³, twin, born 22 June 1624, died young; 29. JOHN³; 30. ANNA³; 31. Margaret³, born about 1633, died 9 Sept. 1659, married, 16 April 1656 at Barbados, as his (1) wife, Joshua Hobart (Hubbard), graduate of Harvard College, 1650, preacher at Bass River, now Beverly, Mass., who was admitted freeman at Hingham, Mass., 18 May 1653, signed in her behalf the deed of sale of her father's estate in Scituate, 18 July 1657, was ordained, 7 Oct. 1674, as pastor of the church at Southold, Long Island, and died there 28 Feb. 1716/7, aged near 90;²⁶ 32. Mary³, born 1634, died unmarried in 1657.

21. MARY³ VASSALL (Samuel², John¹), baptized 28 March 1634, married (1), (license 12) Oct. 1661, Robert Arnold of St. Mary Aldermanbury, London, and (2) Charles Cliffe. She embarked on the *Marygold* for Virginia with her father, brother, nephew and son Robert, and died on the voyage leaving a nuncupative will proved at James City 29 April 1667.²⁷

Issue: (by 2) [CLIFFE] 33. Robert⁴, came to Virginia, 1667, but not mentioned afterward in surviving records and probably returned to England.

22. SAMUEL³ VASSALL [Samuel², John⁴), baptized 6 Aug. 1635, was admitted pensioner at St. John's College, Cambridge, 18 April 1653, aged 17, and received his B.A. in 1658.²⁸ As of St.

George, Southwark, clerk, he married, 24 April 1660 at St. Dionis Backchurch, London, Margaret Wray of St. Andrew Undershaft, London.²⁹ He was living in 1667.

Issue: 34. Samuel⁴, sailed for Virginia on the *Marygold* with his grandfather, probably the child, —— Vassall, for whose keep Henry Corbin Esq., Lt. Col. Cutberth and Mr. Thomas Williamson were allowed £10, 19 April 1670,³⁰ not mentioned afterward in surviving Virginia records and probably returned to England.

25. JUDITH³ VASSALL (William², John¹), born about 1619, married, 5 Nov. 1640 at Scituate, Mass., Resolved White, born about 1615 in Leyden, Netherlands, died after 1687, of Scituate and Marshfield, Mass., son of William and Susanna White who came to Plymouth in the *Mayflower*.³¹ His brother Peregrine White was the first white child born in New England and their father died soon after. The two boys were reared by their step-father Edward Winslow. Resolved and Peregrine White were listed in the company of Capt. Miles Standish when a division of cattle was made, 1 June 1627.³² Judith White was buried 3 April 1670³³ and Resolved White married (2), 5 Oct. 1674 at Salem, Mass., Abigail ——, widow of William Lord of Salem. Resolved White was one of the last survivors of the *Mayflower* passengers and was living at Marshfield in 1687.

Issue [WHITE]³¹ 35. William⁴, born 10 or 18 April 1642, died 24 Jan. 1694/5, of Marshfield, unmarried and apparently afflicted; 36. John⁴, born 11 March 1643/4, may have died young after 1650; 37. Samuel⁴, born 13 March 1645/6, died 1720–31, lived at Sandwich and later at Rochester, Mass., married Rebecca (?Lapham), born about 13 March 1645/6, died 25 June 1711; 38. Resolved⁴, born 12 Nov. 1647, buried 27 March 1670, of Marshfield, Mass.; 39. Anna⁴, born 4 or 5 June 1649, died 25 May 1714, married, 2 June 1671 at Concord, Mass., John Hayward of Concord, born 20 Dec. 1640, died 22 Nov. 1718; 40. Elizabeth⁴, born 4 June 1652, died after 1696, married, 17 June 1672 at Concord, Mass., Obediah Wheeler of Concord, born about 1650; 41. Josiah⁴, born 29 Sept. 1654, died

prison,⁸¹ married Agnes —; 39. Mary⁴, bequeathed part of Baldwin's Chance "where they now live," married, 21 Aug. 1707,⁸² Robert Lusby, Jr.; 40. Catherine⁴, died 13 May 1733 in her 28th year, bequeathed "lott and houses in Annapolis" and other lands, married, 1727, Capt. Charles Griffith, born 20 Jan. 1693, died 6 Oct. 1771, vestryman of St. Anne's Parish, Anne Arundel Co., Md., who left will 10 April 1767–17 Oct. 1771.⁸³

11. LYDIA³ BALDWIN (Mary² Wilkins, John¹) married (1), after 1671, Thomas Watkins of Anne Arundel Co., Md., who left will 15 April 1679–19 May 1679,⁸⁴ and (2), by 31 July 1680, Edmund Bittison [Beetenson] of Anne Arundel Co., Md.⁸⁵

Issue: (by 1) [WATKINS] 41. Thomas⁴, married ——.

12. RUTH³ BALDWIN (Mary² Wilkins, John¹) married, after 1671, Capt. Philip Howard, born before 1649, son of Matthew Howard of Lower Norfolk County, and his wife Anne. He was a justice of Anne Arundel Co., Md., 1694, and the same year a member of the commission to lay out the town of Annapolis ⁸⁶ His will, 29 July 1701–24 Feb. 1701/2 ⁸⁷ named his wife, an only daughter and her two sons, with reversion of his estate to cousins Philip and Joseph Howard should his direct heirs fail.

Issue: [HOWARD] 42. Hannah⁴, born about 1678, died 9 Feb. 1752, married (1) Maj. Charles Hammond, born about 1670, planter and merchant, military officer, 1696, major, 1708–13, and justice, 1702–13, of Anne Arundel Co., Md., and member of the Lower House of the Maryland Assembly, 1710–13,88 who died 23 Nov. 1713 leaving will 16 Nov. 1713–19 Jan. 1713/4,89 and (2), 15 Aug. 1714,90 Edmund Benson, born 4 June 1687, Talbot Co., Md., planter of Anne Arundel Co., Md., justice, 1716–23, vestryman of St. Anne's Parish, 1722–25, member of the Lower House of the Maryland Assembly, 1719–1721/2,91 on whose estate Hannah renounced administration 26 Nov. 1734,92

13. ARGOLL³ WILKINS (John², John¹) deposed, 29 May 1690, that he was aged 25.93 His father gave him half of his remaining 300 acres, 18 April 1687,94 and he was charged with this land in 1704. He married (1) —— and (2) Mary (——) Watkins. His will, 2 Jan. 1725/6–13 Jan. 1725/6,95 mentioned his son-in-law [step-son] Joseph Watkins and gave his three oldest sons 60 acres apiece.

Issue: (by 1) 43. Elizabeth⁴, married —— Humwilton; (by 2) 44. John⁴, left will 16 June 1726–12 July 1726,⁹⁶ married Violet ——; 45. Argoll⁴, died without issue; 46. Beary⁴, married Amy ——; 47. Watkins⁴, left undated will, proved 11 Feb. 1752,⁹⁷ married ——.

15. ANN³ WILKINS (Nathaniel², John¹), born 11 Feb. 1662/3, died 16 June 1700, married, by 6 Sept. 1681,⁹⁸ Benjamin Stratton, born 25 Feb. 1657/8, died 22 Oct. 1717,⁹⁹ of Stratton Manor, Northampton County, vestryman of Hungars Parish, who owned 745 acres in Northampton County, 1704, and left will 29 June 1716–19 Nov. 1717.¹⁰⁰

Issue: [STRATTON] 48. Agnes⁴, born 25 April 1684, died 1711, married —— Johnson; 49. Ann⁴, born 14 Aug. 1686, died 1 Dec. 1702; 50. Benjamin⁴, born 30 June 1688, died 28 May 1760, unmarried; 51. Nathaniel⁴, born 19 June 1691, died 29 March 1709; 52. John⁴, born 21 March 1695/6, died 15 April 1751, sheriff of Northampton County, 1732–34, left will 14 Feb. 1750/1-codicil 11 April 1751–14 May 1751, on married Susannah ——; 53. Thomas⁴, born 21 Sept. 1697, died 19 Dec. 1697; 54. Joseph⁴, born 6 Dec. 1699, died 10 May 1700.

16. JOHN³ WILKINS (Nathaniel², John¹), was deeded by his father the home place including 150 acres, 30 March 1692. He married —— whom he survived and left will, 22 June 1731–14 June 1737, 103 naming grandchildren, both his children having predeceased him as well.

CLEMENTS

*1. Mrs. ELIZABETH1 (FULLER) CLEMENTS came to Virginia with her family in the George, 1617, and as Mrs. Hamor was listed, 1623/4, at James City with her (2) husband and two of her Clements children.² The family was also listed at James City in the muster, 1624/5.

She was the daughter of Cuthbert Fuller (baptized 4 Sept. 15428), a son of Nicholas Fuller, merchant of London.4 Her uncle, tNicholas Fuller of Chamberhouse, Berkshire, who was a member of the Virginia Company, left a will, 19 Feb. 1619/20-1 March 1619/20.5 which mentions Elizabeth Clement, daughter of his brother Cuthbert Fuller, her late husband Jeffery Clement and her

Sir Warham¹ married Mary Hayward, daughter of Sir Rowland Hayward, twice Lord Mayor of London, 1631 and 1662, of Salmeston, Kent.6 He died 11 Oct. 1631,7 leaving will 4 Sept. 1631-1632,8 His widow, who later lived at Lenham, Kent, died 1662.9

4. URSULA² ST. LEGER (Sir Warham¹), born 1609, married, (license 9) Aug. 1627, at Ulcombe, Kent, the Rev. Daniel Horsmanden, who was baptized 16 March 1583/4 at Lenham, Kent, son of the Rev. Richard Horsmanden, rector of Ulcombe. He was B.A., St. John's College, Cambridge, 1603/4, M.A., 1607, B.D., 1614, D.D. Oxford, 1617, and D.D. Cambridge, 1627, was rector of Whipsnade, Bedfordshire, 1622, vicar of Goudhurst, Kent, 1625-40, and rector of Ulcombe, 1627-39, until sequestered for his loyalty to the crown.¹² As of Maidstone, Kent, he left a will, 27 Jan. 1654/5-24 June 1656, naming his wife, his "brother Sir Anthony St. Leger," his own sisters and his children. 13 His widow was buried at Ulcombe 18 Oct. 1672.14

LEGER (Sir Warham¹) married, 10 July 1628 at Ulcombe, Kent., †Thomas Culpeper who was admitted to the Middle Temple, 7 May 1621, was a member of the Virginia Company, 1623, was one of the original patentees of the Northern Neck of Virginia, 18 Sept. 1649, and probably died in Virginia before 1652. His widow returned to Maidstone, Kent, and died before 28 Aug. 1658 when administration on her estate was granted to her son Alexander. 16

Issue: [CULPEPER] 21. Mary³, baptized 26 April 1629 at Ulcombe, Kent, buried 3 Dec. 1630; 17 22. ANNE³; 23. Capt. Alexander³, born about 1631, served as secretary to the Second Lord Culpeper, was commander of Cowes Castle and Vice-Admiral's Deputy at the Isle of Wight, 1664-66, was in Virginia for some years before 1671 and on his return to England was granted the office of Surveyor General of Virginia, 25 Oct. 1671, but remained, to the dissatisfaction of Virginia residents, at Leeds Castle until his death, unmarried, being buried at Bromfield, 26 Dec. 1694, leaving will, 29 Nov. 1691–5 Jan. 1694.5, in which he bequeathed his interest in the Northern Neck Proprietary to Margaret, Lady Culpeper, widow of his second cousin, Thomas, Second Lord Culpeper, and her heirs; 18 24. John³, baptized 4 April 1633 at Hollingbourne, Kent, resided in Albemarle in North Carolina where, 1677, with the aid of some Boston merchants he led a rebellion against the government, and after returning to England to make his peace with the Carolina Proprietors, which he accomplished, was arrested and committed to Newgate Prison on a charge of high treason concerning misuse of the Crown's customs, but was acquitted: 19 25. Frances³, baptized 27 May 1634 at Hollingbourne, living July 1690,20 married (1), 1652, 2.
