FOREWORD

Isle of Wight County is one of the original Virginia shires created in 1634 as Warascoyack. In 1637, the name was changed to Isle of Wight extended from the south bank of the James River to the Nor Carolina line and was bordered on the east by Nansemond County at on the west by James City County which became Surry County in 165 Since that time, a number of boundary changes have altered the county area but not its importance to genealogists.

Nansemond County has lost most of its early records and the Nansemond references found in the Index to this book may be significant help to those readers who are researching Nansemon ancestors along with those who are aided by the many indexed reference to individuals in Surry County, Prince George County and the State North Carolina. Even at this very early time, there was much movemed over county and state lines.

As the title indicates, this book covers three areas.... deeds, orde and guardian accounts. These three areas are brought together her because the deeds and guardian accounts are bound in the same volum and the orders happen to be the only extant orders for this county price to the year 1746. This book is also a second look at and an addition the material covered by John Bennett Boddie in his Seventeenth Centur Isle of Wight.

Finally, the reader is encouraged to always go to the original cany abstracted document to look for spelling variations and ar genealogical information that may have been overlooked by the author.



FOREWORD

Isle of Wight County is one of the original Virginia shires created in 1634 as Warascoyack. In 1637, the name was changed to Isle of Wight. It extended from the south bank of the James River to the North Carolina line and was bordered on the east by Nansemond County and on the west by James City County which became Surry County in 1652. Since that time, a number of boundary changes have altered the county's area but not its importance to genealogists.

Nansemond County has lost most of its early records and the sixty-three Nansemond County references found in the Index to this book may be of significant help to those readers who are researching Nansemond County ancestors along with those who are aided by the many indexed references to individuals in Surry County, Prince George County and North Carolina. Even at this very early time, there was much movement across boundary lines.

This book is a continuation of the deeds found in the author's previous book, Isle of Wight County, Virginia Deeds 1647 - 1719, Court Orders 1693 - 1695 and Guardian Accounts 1740 - 1767. Isle of Wight County deeds for the years 1736 - 1741 are not included in this volume because they have already been published by T.L.C Genealogy, PO Box 403369, Miami Beach, FL 33140-1369 as Isle of Wight County, Virginia, Deeds, 1736-1741 and copies may be obtained by writing to the publisher. Also, there are no extant Isle of Wight County recorded deeds for the time period 25 April 1726 to 24 March 1729 nor are there extant order books that would have noted the recording of deeds at court during that three year time period.

Finally, the reader is encouraged to always go to the original of any abstracted document to look for spelling variations and any genealogical information that may have been overlooked by the author.
