Looks like Caleb Lindsey had sons Archibald, Carolton and James at least, maybe John and Caleb, Jr.. Caleb and family appear to have moved to Chatham County, NC by the 1780s, where he died. Then members seems to have gone to Lincoln/Rutherford Co. area.
