1. Col. Andrew¹ Love¹. Born, circa 1765 (??) in Ireland. Died, 10 Sep 1803, in York Co., SC. Census: 1790, in York Co., SC. Census: 1800, in York Co., SC. Occupation: Planter.

This ancestor not proved, however his will, recorded in Will Book A, p. 510, York County, SC, proven on 6 May, 1805, mentions a daughter Sarah who was unmarried at that time. We do know that she was one of the Loves who lived in the area from Bullocks Creek to Smith's Ford in York County, which is where James Davison, her spouse, lived on Broad River and Guyon Moore's Creek. Other than the will, we have nothing to tie her to a particular ancestor. There were at least two other Sarahs of about the same age in York County. Robert had a daughter Sarah, but there is a record of her marriage to another. Alexander Jr. or Sr. had a daughter Sarah, who also is supposed to have married another. We suspect Andrew is either the brother or the son of Alexander Love, Sr. The earliest Loves in York county were apparently William who secured an Anson Co., NC land grant of 400 acres, the place he now lives, on the N. side Broad River at Moores Creek. 11 May 1753 Grant Book 2 p. 53.

To add further confusion, an Alexander Love, born 1718 in PA, married on 3/6/1743 in PA a Margaret Moore b. 1719, d. 1806-7 York Co, SC. We know he had a daughter Mary who married David Honer <1784, and a son, Colonel Andrew Love b. 9/12/1747 PA, d. 3/26/1821 in KY who m. Anna Lattimore 3.22.1770. She died 5/18/1814 in York SC. They had a son Alexander b. 3/9/1771. There were three NC grants to Robert Love for 700 acres on the N side Broad River at Bullocks Creek 11 May 1754 (Grant Book 15 p. 13); 410 acres N. side Broad River at Bullocks creek where he now lives 13 Mar. 1756 (Grant Book 15 p. 131); and acerage on b.s. Hanging Rock Creek 23 Apr. 1762 (Grant Book 15 p. 396.). John Love received a grant of 130 acres Moores Creek, Turkey Creek, Broad River 15 Feb. 1764 Meckl. Co, Grant Book 17 p. 40, N. C. Dept. of Archives.

Col. Love served in Sumter's Regiment during the Revolutionary War. He was said to be strong, daring, and hell on Tories by Alexander Love, member of Provincial Congress 1 Dec. 1775, who was a member of his regiment.

The 1790 census records 4 sons and 3 daughters at home, and 3 slaves. The 1800 census shows 4 sons, a daughter between 16 and 26, man and wife age 45 plus, and 3 slaves.

"In the name of God, Amen. The tenth day of September A. D. one thousand eight hundred and three I Andrew Love, being advanced in life and Desirous to settle my Worldly Estate, do make this my last Will and Testament; the particulars is as follows; viz. To my dearly and well beloved Wife I give and bequeath one hundred dollars in Cash paid as hereafter mentioned also her choice of bed, bedstead, and furniture With two Cows her Choice: also her Wheel and Chair one lot with the one half of the Dresser furniture, With the prividge of my Room and press with forty bushels of Corn per year two Cows feed fire wood Cut and hauled dureing their stay here. Item--I give and bequeath to my daughter Mary one Dollar .-- Item--I giva nad bequeath to my son James the Sum of fifty Dollars. Item -- I give and bequeath to my son Robt, the Sum of one hundred Dollars. Item-- I give and bequeath to my Son William the Sum of one Hundred Dollars. Item -- I give and bequeath to my son Andrew the Sum of one hundred Dollars. Item -- I give and bequeath to my Son John the Sum of one hundred Dollars. Item-- I give and bequeath to my Daughter Sarah the sum of fifty Dollars. Item -- I give and bequeath to my Daughter Elizabeth the Sum of one hundred and forty five Dollars, and two Cows, one Bed Stead and furniture the Second Choice. Item--I give and bequeath to my Sister's Son Andrew Donagy the Sum of Sixty Dollars. Item -- I give and bequeath to my two Sons Mathew and Sam'l, the interest of four hundred Dollars to be paid yearly. Item -- I give bequeath and Demise to my Son Andrew three tracts of Land containing eight hundred acres with all the improvements thereunto belonging except Such Reserves as is above disposed of, with all my horses, cattle and hogs, Waggon, and hind geers, Still and tubs, farming utinsels, Household, Kitchen and Dresser, furniture not above disposed of, providing, he pay the above Bequeathed Legacies to be paid as follows, viz. the one half at the end of one year of my decease the other two years after that also to pay to my son mathew and my Son Samuel the interest of Four Hundred Dollars year and year by commencing two years after my decease, also to find them in Sufficient Clothing, Boparding, Washing, and Lodging, and they to work in moderation. If they do not like to live With him, they may Choose to go to any of my they may

think best, and always to draw the aforesaid interest, to keep them in decent Clothes fit and proper to appear abroad the principle Still to continue with him. If my Son Andrew does not See fit to undertake the above property, and pay the above Legatees the above Sums, then I allow my Son Wm. to fall in the place in every Respect. He Will not take it then my Will and pleasure is that the named property be sold by my Exrs. Still reserving all property otherwise bequeathed by me, and the Whole amount to be distributed among my Legatees agreeable to the said proportion If the above property be sold, the Exers. is to keep the above named four hundred dollars nominated to Mathew and Sam'l, at interest as thei necessity may require, if there be any over When they have no more need I allow it to be disposed of as above. If my Wife Sees Cause to move from here I allow her twenty bushels of Corn Yearly dureing her life. Lastly I name and appoint my beloved wife Sarah and my two Sons James and And'w , to Execute this my last Will and Testament, here by revoking and Disannulling all former Wills Legacies, bequeathments or Executors, made, done, or appointed by me in any manner of Way before this: Ratifying and confirming this and no other to be my last Will and Testament in Witness Whereof I have here unto Set My hand and Seal the day and date above written. Signed, Sealed, Published, and Pronounced and Declared by the Said Andrew Love as his Last Will and Testament in the presence of us Who in the presence of each other have hereunot set our names. Andrew Love (Seal). Robert Love, Samuel Erving, Wm. Love, wit.

The following Love family members came to the U.S. between 18 June and 31 Dec. 1798 from Ireland. and petitioned for citizenship Oct. 19, 1813 at the same time as James A. Davison and Andrew Davison, taking the oath the same day: Robert Love, William Love, Jr., William Love, Sr., Andrew Love (not Col. Andrew Love). York Court of General Sessions p. 243, 253-4, 259-60, 263-4. SC Archives Roll # C1668.*
