Originally granted by the Lords Proprietors to the Landgrave, Edmund Bellinger, which land afterward became vested in his son, Edmund Bellinger, and which by him and Lucie, his wife, was conveyed to the Memorialist by lease and release bearing dates, respectively, the 9th and 10th days of December 1768, at quit rent of 3/ sterling or 4/ proclamation money, per hundred acres, commencing two years from date.





Hugh Wilson 1838-1914

Hugh Wilson, Sr. was born in the City of Tarbolton, Scotland, Aye County in North Britain in 1820. His father and family landed in Charleston, S.C. about 1822, when he was around two years old. From Charleston they moved to Newberry, and afterwards to Laurens County, where he built a cotton mill on Raburn Creek about 1832. He died in 1836.

On September 4, 1837, Matthew Johnson petioned the Ordinary of Laurens District to appoint him guardian of Hugh Wilson, Jr, of Abbeville District so that he could receive Hugh Wilson, Jr's distributive share of his father's considerable estate, Hugh being a minor.

Hugh Wilson Jr. married Mary Rose Godfrey in December 1837. He like his father was a mill wright. A mill wright in those days was the right man in the right place, as no wheels could turn without his skills and supervision. To them were born five daughters and two sons, the eldest of the sons, Hugh Wilson. Hugh Wilson, Jr. died August 24, 1899 at the age of 80. He is buried in Upper Long Cane Cemetery, Abbeville, S.C.

Hugh Wilson, veteran editor and printer, who wielded the pen of the Abbeville Press and Banner fifty years, was born in November 1838. He never married. His fiancee died before they were married. He built a

home for his bride to be which is still standing on Magazine Street, in Abbeville.

His work as an editor was governed by—quote "Profanity under certain provoking circumstances might be pardoned or excused, but there could be no provocation, and there could be no excuse, or pardon for vulgarity. In the heat of passion profanity gives relief and therefore had some plea for excuse, but vulgarity was deliberate and cold blooded, and for which language no excuse could be urged."

"During the fifty years of my connection with the Press and Banner, never knowingly printed in the paper, nor in a job, a single word of vulgarity, and I never knowingly published a word for the purpose of suggesting unutterable things" Unquote

He died December 17, 1914. Buried in Episcopal Cemetery, Abbeville, S.C. by his mother and brother Robert.

Wilson

At the turn of the century, the above photograph was made at the Abbeville Medium office, located in basement of Poliakoff's Store. Editor, Hugh Wilson, had a staff primarily comprised of another Wilson family, unrelated.

Leroy Jefferson Wilson, married to Sarah Ursula Dansby had settled in Fairfield County; Mrs. Wilson originally from Wales. Coming to Abbeville, they resided in Fort Pickens, on Dead Man's Curve.

At Mr. Wilson's death, his widow was left with six children, ranging from three to twelve years of age. This necessitated seeking employment at an early age.

Ernest O. Wilson operated the cutting machine, later becoming editor of Beaufort, S. C. Gazette. Had one son, Lewie.

Ellie F. Wilson working at ten, was called the Devil Boy. Married Eva Pruitt, served in World War I, later operated the Southern Oil Co. One son in N. C. and daughter in Tenn.

Marie Florence, type-setter by hand; married J. Lewis Sprouse. Children, Florence Guy, Sara Ferguson and J. Lewis Jr. Seven grandchildren.

Bessie was also type-setter; married R. Y. Simmons. Leola, oldest daughter, also worked but absent at time of photo. Married C. B. Wosmansky. Children. Pauline Rosenberg and Franzes Warren; three grandchildren.

Della, school teacher, married O. A. Lominick. Children Kathleen Jennings, Helen Hendricks, Lerovand Harold Lominick. Six grandchildren.

There were two half-brothers, Eugene, a dentist. Will, engineer in Central America.

The lady in the hat has not been identified. Majority of descendants now residing in S. C.

William Norris & Descendants of Turkey Creek Area to Mississippi and Texas

William Norris (c 1755-1803) and wife, Athaiah, with sons Hesikiah, Eley (Eli), and Alexander settled in the Turkey Creek area of Abbeville County near Ware Shoals after 1790, but before 1795. They were believed to have come from Maryland, but had lived in Virginia and were probably east of Ware Shoals in Laurens County by 1790. Hesikiah Norris surveyed and patented 167 acres on Turkey Creek of the Saluda River near Ware Shoals in 1805. Alexander Norris was a private in Captain William Ware's Company during the War of 1812. Eli Norris (c 1785-1838) spent his adult life in residence in Abbeville County near Donald's and Ware Shoals, although his children listed Maryland as his birthplace to the 1880 census-taker.

In his will dated October 26, 1838, Eli Norris listed his wife, Olive (Olly) and children: Mahulda (Huldy Blain), Wesley (Westley), George W. (Washington), Matilda (Tildy), Frances, William H. (Henry), Willis, Olive (Olly), and Eli. Mahulda Norris married Daniel Blain, son of William (c 1769-1829) and Mary Blain, in 1837. Matilda Norris married Bailey A. Dean. William Henry Norris married Cassandra Dean. Eli Norris' widow and children moved to Attala and Winston Counties in Mississippi between 1842 and 1845. William Henry Norris, Eli's son, who was born in Abbeville County c 1818, established the Norris family in Johnson County, Texas after the Civil War when he moved from Attala County, Mississippi.

James Oliver (1751-1802)

James Oliver rendered material assistance during the Revolutionary War by serving "since the reduction of Charleston" as a private under Colonel Robert Anderson by fifty-two days wagon hire and by the sale of oats (data from South Carolina Department of Archives and History and by DAR and SAR records of Mary Claire Oliver Cox and of James Oliver Bell, respectively).

In 1784 James Oliver received a grant of 200 acres of land in Ninety-Six District on 23 Mile Creek. He is buried in the now abandoned Cemetery of the Rocky River Presbyterian Church. The inscription on the tomb stone reads: James Oliver aged 52 died October 7, 1802.

The will of James Oliver is dated June 19, 1799 and probated March 4, 1803 (Abbeville County Will Book I, page 278). Wife Mary, sons James, John, William, Thomas, Alexander, Andrew, Samuel, daughters Mary, Margaret, "and other sons and daughters that mey be born to me" are named in the will. In the settlement of the James Oliver estate personal property was appraised at \$1,864.25; among the books listed in the inventory are Perkins' EXPLANATION OF THE SCRIPTURES, RISE AND PROGRESS OF RELIGION, Bible, Hymn Book, and Watts' PSALMS.

Mary Oliver, one of the daughters of James and Mary Oliver, was the wife of Nathan Strickland. She and her husband were appointed guardians of the minor children Samual, Robert P. and Jane ("Jenny") Oliver (see Abbeville County Box 71, Pack 1745). In 1809, Samuel McElvaney was paid his wife Margaret's legacy of \$214.28 and in 1813 the estate of Samuel McElvaney

was administered by his widow Margaret. Children of Samuel and Margaret (Oliver) McElvaney were: John Sidney McElvaney, born Nov. 1, 1809, Ellen Taylor McElvaney, born Jan. 28, 1811, and Mary Evaline McElvaney, born Dec. 25, 1812 (Reference: Flanigan's HISTORY OF GWINNETT COUNTY, GEORGIA, Vol. II, pages 550-552).

Samuel Oliver, the youngest child mentioned in his father's will was born July 15, 1797, and died July 25, 1869, in Gwinnett County, Georgia. Samuel Oliver married first in South Carolina on Sept. 15, 1818, Charity Cain, born Jan. 18, 1800, died in Walton County, Georgia, on July 12, 1840. Samuel Oliver married second in Walton County, Georgia, Susannah ("Susan") Braswell, born Feb. 13, 1814, in Greenville County, South Carolina, died Sept. 22, 1865 in Gwinnett County, Georgia. (See account of the Oliver Family in Flanigan's HISTORY OF GWINNETT COUNTY, GEORGIA, Vol. II, pages 569-570).

In 1814, Thomas Oliver was a witness to the will of Jacob Strickland. In 1830 Robert P. Oliver, Alexander Oliver, and John Oliver are listed as residents of Abbeville County in the Federal Census. In 1839 Alexander Oliver made the inventory of the estate of Morcicai Schackelford.

The Lewis Perrin Family

Another branch of the Perrin family who made their home in Abbeville was the Lewis Perrin family. Lewis, son of William, son of John and brother of Thomas C. Perrin, married first Elizabeth Hinde and second Mary E. Grant. Lewis and Elizabeth H. had a son, James H., and his son Lewis Perrin, born 1873, lived all his life in Abbeville. He was a banker and was also noted for writing many articles of the history of old Abbeville. He

married Ethel Mills. Their children were Mary Norwood Perrin and Ladson Mills Perrin.

The son of Lewis and Mary Grant was Thomas Grant Perrin who served as City Clerk of Abbeville for many years. He died in 1921.

None of this family is left in Abbeville.

The Pettigrew (Petrigru) Family

The Pettigrew family, originally French, migrated to Scotland and Ireland prior to 1496. The Abbeville line is traced from those in Northern Ireland. James Petigru I served under Oliver Cromwell. His son James II changed the name to Pettigrew because of the enmity between the English and French. His son William fought for King William at the Battle of the Boyne. He was rewarded with 300 acres of land in County Tyrone Ireland. His home there was named "Crilly House." It is still occupied today.

His son James Pettigrew, born April 1713 at "Crilly House" was the first American ancestor of the family. He and his wife, Mary Cochran, a daughter and two

sons landed in Delaware in 1749. He pushed on into Pennsylvania where he bought 300 acres of land. Benjamin Franklin advised him to study medicine, but James Pettigrew, born to adventure went on to Virginia, North Carolina, and in 1768 he reached the "Long Cane Settlement" in South Carolina. Here he prospered until the Cherokee uprising in 1776.

After coming to America, James had become very religious. No cooking was allowed in his home on Sunday. This may have saved the lives of his family. One Sunday, hostile Indians, seeing no smoke, thought the house was deserted and did not stop.

James Pettigrew with several of his sons, sons-in-law, and grandsons, served with the Colonial Army during the Revolution. Being somewhat skilled in medicine, he gave aid to wounded Whig and Tory alike. For this reason his family was little disturbed by the British soldiers

James Pettigrew, called "The Immigrant", died from

pneumonia on December 24, 1784. He had ridde horseback twelve miles home after attending a reli service at the Pickens House where the courthouse stands. His grandson, James Louis Petigru, a tinguished statesman and lawyer, changed his a back to the original French spelling, Petigru.

Pilgrim

The Pilgrim family came from Anderson County in late 19th century. Lucinda Pruitt married a John Tucker of Anderson. Their daughter Lucretia married John Pilgrim, They had several children among whom. Ruth Ann (Anna) married also a J. Wesley Pilgrim, probably a cousin, and settled in the Ridge Community west of Lowndesville sometime prior to 1880. They had five children: Margaret (m. Joseph Turner), Essie Victoria (m. Charlie Brooks Hutchison), John Wesley Pilgrim (m. Lavinia Crocker, later m. Mildred Willard), Daisye Melinda (m. Henry Chambers of Anderson, S.C.), and Samuel Walter Lewis Pilgrim (m. a young lady, Anna, from Scotland while he was serving in World War I). S. W. later removed to Rock Hill, S. C., where he and his son built and operated airplanes as a hobby. S. W. was an official with the South Carolina

Ports Authority and had the distinction of having ports building in Charleston, S. C. being named him.

Essie Pilgrim and Charlie B. Hutchison Lowndesville and Calhoun Falls, had the follow children: Annie Mae (m. Carol A. Bonds), Roberta C. R. Johnson), Robert Eugene (m. Rosa Mannie Caroline (m. George C. Norton, Sr.), Charlie B., Jr. Lula Powell of Greenville), Charlie retired from the S. Air Force, has been very active in politics in Greville County and owns and operates a golf course the Lula (m. G. Calhoun Williams), Bertha (m. Carl Williams), and Lucille (m. James S. Hozey).

The Post Family

When Wiley Post became the first man to solo fly his airplane, The Winnie Mae, around the world in 1933 he became an instant hero. Two years later the great aviator went down in Alaska with his famous friend and passenger, Will Rogers, and the world mourned the loss of both.

Wiley Post was a descendant of Samuel and Aley Post who came down from an eastern state and received a 150 acre grant of land in Abbeville District, South Carolina on Shanklin's Creek in 1784. In 1789 Samuel Post was granted 333 acres on Rosses Creek where he farmed for several years before moving over to Elbert County, Georgia shortly before 1800. Samuel Post, born in 1740, had four sons and a daughter who lived much of

their younger life in Abbeville County. These inche John, Samuel, Jr., Joseph M., and Elizabeth Hollis who all raised their families in Georgia. And son, William Post, moved to Shelby County, Alab where he died in the 1840's being remembered as of the founders of the Alabama Baptist Conven William's son, William B. Post, moved to nort Louisiana in the 1850's and to Bowie County, T around 1879. William B. Post, through his son, Jos and grandson, William Frank, was the great gr father of Wiley Post.
