### SOUTH CAROLINA HISTORY FOR GENEALOGICAL RESEARCH

Miscellaneous Historical events:

1826 PENDLETON DISTRICT was divided into two counties:

ANDERSON COUNTY
PICKENS COUNTY
The Pendleton District ceased to exist as a separate legal entity upon creation of these two counties.

## HISTORICAL LOGISTICS

OF

#### LANCASTER COUNTY

In 1826 Robert Mills presented the South Carolina Senate with a copy of his Atlas which was recognized as the first atlas of an American state. While the Mills' Atlas is a monumental work, the culmination of years of work by many surveyors, more importantly it provides us with a landmark source of the historical geographical information on the families of South Carolina. Mills has provided us with the "exact" location of families residing in the various districts of South Carolina during a period around the year 1820. In our investigation of the Hollimans in Lancaster County it becomes obvious that Mills work was by no means complete. However, it does provide some answers for us.

The Lancaster District is of primary interest to the Holliman family as our ancestor Cornelius Holliman is known to have resided there just prior to his removal to Fayette County Alabama in the 1830's. We have proof of his family's residency there from numbers of sources, one being the 1820 South Carolina State Census. At that time he was the head of a household composed of 1 male age 26 to 45 (himself), 2 males under age 10, and 1 female age 16 to 26. We also have evidence of his purchase of land on Dead Pine Creek in January of 1830 in Lancaster District.

Other Hollimans also appear in Lancaster District during that period. Willis Holliman appears in the 1820 South Carolina State Census along with a large family and one slave. James Holliman, Sr., and James Holliman, Jr. appeared frequently in the Deed Books of Lancaster District beginning as early as December of 1797 when James Holliman, Sr., purchased 1000 acres of land "...in the fork of Wild Cat Creek and part of Lynches Creek from Robert Welsh." Numerous land transaction followed this purchase. In fact one could draw the conclusion the James Holliman, Sr. and his son were early real estate developers of Lancaster County. When James Holliman, Jr., became deceased in 1804 his land holdings were returned to his father, James Holliman, Sr., by his Last Will and Testament. James Holliman, Sr., apparently continued to reside in the area until his demise in 1836.

All of these Hollimans in Lancaster District would lead you to believe that Mills Atlas would reveal their location. After studying the Lancaster District map with a magnifying glass I found, to my disappointment, no Hollimans. In fact the index in Mills book list Hollimans in our two districts: the Darlington District and the Kershaw District. From all indications the Darlington District was occupied by Kindred Holliman, which appears to be spelled a Holloman in various

sources. The Kershaw District apparently held Herman Holliman, which appears to be spelled Holleyman in some sources. Well, at least Robert Mills knew how to spell the name Holliman! Unfortunately, he could not find us in the Lancaster District.

However, he did find the Plylers, a family that is significant to the ancestors of Cornelius Holliman since he married Elizabeth Plyler in Lancaster County in the year 1813. In scanning the area along the North Carolina border I find two families of Plylers. The location of one family of Plylers is approximately a quarter of a mile south of the North Carolina state line and on the East side of Fork Road and north of the intersection with the road connecting Lands Ford with Lynches Creek. Looking at the other family of Plylers we find them about one mile east of the other family and "sitting" directly on the state line. They are on the east side of a eastern branch of Pole Cat Creek. Elizabeth Plyler may have originated from either of these Plyler families. Furthermore, there is documentation from other sources of Hollimans located in the exact, same area.

Looking at Deed Abstracts we find "...James Holleman, Senr., of North Carolina, & Mecklenburg Co.,..." sold land for "...\$40 to James Holleman, Junr., land in Lancaster Co." in September of 1803. In that deed we find land described as located adjacent to Jacob Plyler, Koonrod Plyler, Paul Plyler, et. al. and described as in the upper corner of General Sumter's original land grant. This would locate the land along the North Carolina state line, exactly where we find two families of Plylers are shown on Mills' map of Lancaster District. Furthermore, land grants show that Conrod Pliler sold land to Frederick Plieler in August of 1810. Frederick Plyler (probably the same person) came from Mecklenburg County, North Carolina, where he lived in 1783. As a point of interest, the Plylers of Mecklenburg County were know to sign their name in German script. It appears the Plyler - Holliman connection goes back many years.

Then there is the mysterious matter of Samuel Holliman that was buried in Lancaster County in a "Tory" Cemetery. He was born April 7, 1750 in Edgecombe Co., N.C., and died in 1832 in Lancaster County, S.C. The location of the "Old Tory Cemetery" (aka Gibson Cemetery) appears to be in the same general area of Lancaster County.

Studying Mills' map along with information received from other sources would indicate all of these Hollimans and Plylers lived within a relatively small area of Lancaster County. We could characterize this area as having a radius of five miles. As we continue our investigation we now know exactly where to look for the answers.
