Note to the user of this compilation:

Edgewcombe Precinct, North Carolina was formed from Bertie in 1732 and Edgewcombe County, North Carolina was formed in 1741.

Records indicate that Edgewcombe court of the early 1730s was probably held from place to place at plantations within Edgewcombe. In the late 1730s and early 1740s, there seems to have been a courthouse of sorts near what is now Tillery, N. C. By about the mid 1740s, the Edgewcombe County courthouse at Enfield, N. C. was in use. Early in 1759, when Halifax County, North Carolina was formed from a part of Edgewcombe County and the limit of Halifax County was set, one boundary was and still is Fishing creek which flows just below Enfield. The Edgewcombe County courthouse was then within the new County of Halifax. For this reason deeds in the Halifax County, N. C. public registry prior to 1759 call for lands within the huge area that Edgewcombe covered in its very early days.

Granville grantees are not included in the abstracts that follow, but appear in "1749-1763 ABSTRACTS: GRANVILLE GRANTEES Halifax County, North Carolina Public Registry" compiled by Margaret M. Hofmann and published in 1967.

Apparent confusion in dates in the following abstracts is explained by the fact that Great Britain did not adopt the Gregorian calendar until 1751 and at the same time changed the first day of the new year from 25 March to 1 January.

Spelling appears in this work exactly as it is found in the public record. Counties mentioned should be assumed to be in N. C. unless otherwise designated.
