1783 and entered on 2 Sept. 1807 by no. 466, there was granted to William Caswell and his heirs 640 acres in Bedford Co., in the 2nd dist., 4th range, 7th section on Alexander's Creek, next to Joseph Dickson's grant of 5000 acres.

No. 347. Heirs of Jacob Clarke, private in the N.C. Line; 336 acres within the limits of land reserved for officers and soldiers of the N.C. Cont. Line; issued 10 July 1820. Isaac Clark of Lenoir Co., N.C., true and lawful heir of Jacob Clarke, conveyed to Toderick Cherry, 1 July 1820.

No. 377. Heirs of Jacob Clarke, private in the N.C. Line; 640 acres of land within the limits reserved for officers and soldiers of the N.C. Cont. Line; issued 29 July 1820. Isaac Clark of Lenoir Co. transferred the warrant to Roderick Cherry on 12 Aug. 1820.

No. 620. Cornelious Callayhan, private in the N.C. Line; 274 acres; issued 22 April 1784.

No. 185. Also no. 793. Heirs of Amos Carl or Cail, private in the N.C. Cont. Line; 640 acres; issued 22 April 1809. On 25 April 1809 Scaley Cale of Martin Co., N.C., heir of Amos Cale, dec., conveyed the warrant to Daniel Cherry.

No. 1999. Jno. G. and Thomas Blount are assigned this grant, 1 Aug. 1798 issued to William Crow a private in the N.C. Cont. Line for his services. Based on Warrant no. 1546, dated 14 Jan. 1786.

No. not given. John Collins, soldier in the N.C. Cont. Line, enlisted for the duration of the war. Statement signed 23 Nov. 1797. 20 Jan. 1798 John Collins assigned the warrant to Jno. Hague, who on 25 Jan. 1798 assigned it to Samuel Crocket.

No. 654. Heirs of William Chronicle, capt. in the N.C. Cont. Line; 3800 acres; issued 23 Nov. 1820. James McKee of Lincoln Co., N.C., the only heir and legal representative of Capt. Wm. Chronicle, assigned said warrant to Robert Henry on 23 Nov. 1820.

No. 3328. Heirs of Thompson Chapman, private in the N.C. Cont. Line; 640 acres; issued 7 Jan. 1786. Granted by Martin Armstrong. 24 Aug. 1790, it was certified that the land was duly sold having been taken by an attachment at the suit of John Conrod and sold to him in Surry Co., N.C.

No. 3336. Samuel Chappell, private in the N.C. Cont. Line; issued 7 Jan. 1786. On 8 Feb. 1786 Chappell assigned the warrant to John Marshall. 25 Feb. 1800, Dixon Marshall, heir at law of John Marshall assigned the warrant to Jessey Powel, who made it over to John Lancaster on 2 Nov. 1801. Lancaster assigned it to William Henderson in Jan. 1805. Henderson assigned it to James Henderson in June 1805.

No. 274. James Cocks, heir of Robert Cocks, sergeant in the N.C. Line; 1000 acres of land within the limits of land reserved for officers and soldiers of the N.C. Line; issued 15 Dec. 1818. In 1818, James Cocks, son of Robert, transferred the warrant to Daniel Cherry.

No. 115. Heirs of Joseph Cox, private in the N.C. Cont. Line; 640 acres of land; issued 18 Dec. 1804. Daniel Cox of Beaufort Co., N.C., son and heir of Joseph Cox, sold the warrant to James Hern (?) who transferred it Joseph Terry.

No. 121. Heirs of John Cooper, corporal in the N.C. Cont. Line; 1000 acres; issued 28 Nov. 1805. Jordan Cooper, heir of John Cooper, transferred same to John Brown and James Welbourn in 1805.

No. 688. Heirs of William Cooper,, lieutenant in the N.C. State Line; issued 21 July 1821. Elisha Ham made oath before Amos Jones, J. P., Franklin Co., N. C., that William Cooper was a lieutenant in the N. C. Cont. Line, and that Cooper marched away in the said army and never returned, and said Ham understood that Cooper was killed while in the service, was unmarried, and left one brother, Robert Cooper, who now lives in Franklin Co., N. C.; 14 July 1821. Robert Cooper, only lawful heir of William Cooper, transferred the warrant to Andes Jones; 1821.

No. 166. James Cronister, private in the N.C. Cont. Line; 640 acres; issued 25 Nov. 1808.

No. 163. Heirs of James Carmady, private in the N.C. Cont. Line; 640 acres of land within the limits of land reserved for officers and soldiers of the N.C. Cont. Line; issued 17 Sept. 1808. Elizabeth Hanes, only heir of James Carmady, dec., assigned the warrant to Reuben P. Jones, who assigned it to Frederick B. Nelson on 23 Sept. 1813. In the same month Nelson assigned it to John C. McLemore.

No. 124. Thomas Creecy, on account of a balance due for the services performed by William Luppencute, musician in the N. C. Line; 360 acres; issued 14 Dec. 1805. In Jan. 1806 Creecy assigned the warrant to William Clemens, who assigned it to Thomas N. Clark.

No. 1036. John Cotants, a soldier in the N.C. Cont. Line. Jeesey Cherry, administrator of John Cotants (Concante), endorses the warrant to William Cherry to have surveyed, 2 July 1796. On 2 July 1796 William Cherry assigned it to Samuel Barton, Thomas King and Noah Lilley, witnesses. 13 Aug. 1796, Samuel Barton assigned the warrant to James Saunders. 29 Sept. 1807, James Saunders assigned the warrant to William Davidson, with John Lowery, Daniel Griffin, and Johncon Lowery, Joseph Cummins (?) and Robert Cooper, witnesses. (Paper is in very bad condition).

No. 384. Heirs of Thomas Caswell, corporal, 428 acres within the limits of land reserved for officers and soldiers of the N.C. Cont. Line; issued 3 Aug. 1820. Uriah Caswell, one of the heirs of soldier Thomas Caswell, transferred the warrant to Lawrence Cherry. Milley Bateman, another heir of Thomas Caswell, also transferred her right to the warrant to Lawrence Cherry.

No. 670. Heirs of Hugh Curren, private; 640 acres; issued 27 March 1821. 5 July 1822, Benjamine Hester of Granville Co., N. C., made oath that he knew Hugh Curren, Sr., and Elisha Curren, who enlisted as a soldier in the Troop of Horse under Capt. John Sickerson or Dickerson for two years and six months in the N.C. Cont. Line, and served in the same until they both died in the Rev. War, and Hester further stated that Hugh Curren is the only rightful male heir to the deceased Hugh and Elijah Curren.

No. 582. Heirs of William Campbell, corporal in the N.C. Line; land within the limits of that reserved for officers and soldiers in the Cont. Line; issued 12 Sept. 1820. On 13 Sept. 1820 William Campbell of Beaufort Co., N.C., only true and lawful heir of continental soldier William Campbell, conveyed the warrant to George Brown.

No. 689. Heirs of John Carney, private; 640 acres. Carney was a soldier in the N C. Cont. Line in the Rev. War; issued 21 July

under the rules, regulations and restrictions as by law directed. The warrant was issued from a grant to Hugh Dunlap for 500 acres, of no. 263, dated 7 March 1796, obtained by virtue of fifty shilling warrant.

No. 4424. Henry Ferguson, private; 640 acres for his services in the N. C. Cont. Line; land located in Davidson Co.

No. 869. Heirs of Thomas Ferrell; 640 acres; for services as a private in the N. C. Line; issued 23 Aug. 1821, and transferred on the same date by Veazey Ferrell to George Brasfield, who on 6 Oct. 1821, assigned the same to Thos Wynns.

No. 337. Heirs of William Flury, sergeant, 1000 acres for services in the N. C. Cont. Line; issued 23 June 1820.

No. 510. Heirs of James Fikes, sergeant; 1000 acres within the limits of lands reserved for officers and soldiers of the N. C. Cont. Line; issued 30 Aug. 1820, and transferred on 31 Aug. 1820 by Nathan Fike to Joseph Hurbork (?), Zach. Harman a witness.

No. 359. Heirs of Timothy Fields, private; 640 acres within the limits of land reserved for officers and soldiers of the N. C. Cont. Line; issued 17 July 1820. John G. Field, heir at law of the within named Timothy Fields, authorized Joseph N. Seawell to locate and obtain a grant for the warrant, 1 Aug. 1820.

No. 3947. A. Foster; 200 acres; a military warrant.

No. 4426. James Ginn, private in the N. C. Cont. Line; 640 acres within the limits of land reserved for officers and soldiers of the N.C. Line; issued 22 Dec. 1796. John Hunter, attorney for James Ginn, on 22 Feb. 1797 assigned the warrant to Samuel French, witnessed by (?) Shelton, Jonathan Church, and Moses Vincent, 7 Sept. 1797. Samuel French of Pittsylvania Co., Va., transferred same to Alexander Joyce, with Adam Tate and Geo. Adams as witnesses.

No. 4415. Oliver Gresham, private in the N. C. Cont. Line; 228 acres; issued 22 Dec. 1796. On 1 March 1797 Gresham transferred the warrant to Redmond Dillon Barry, who assigned it to Edward Gwin on 13 Aug. 1798.

No. 4531. Elisha Garland, private in the N. C. Cont. Line; 228 acres within the limits of land reserved for officers and soldiers of the N. C. Cont. Line; issued 24 Dec. 1796. The warrant was assigned to Jonathan Frier Robertson on 30 July 1802, with Jno. Davis a witness.

No. 4532. John Garland, private; 228 acres of land; issued 24 Dec. 1796, and transferred to James Robertson.

No. 1902. David Gunn, private in the N. C. Cont. Line; issued 15 July 1785, and transferred to James Cole Mountflorence on 20 Aug. 1788, with Robert King a witness.

No. 4378. Heirs of Lewis Guttrege, private in the N. C. Cont. Line; 640 acres within the limits reserved for officers and soldiers of the Cont. Line; issued 20 Dec. 1796.

No. 4377. Matthew Guttrige, private in the N. C. Cont. Line; 640 acres; issued 20 Dec. 1796.

No. 318. Heirs of Thomas Gibson, ensign in the N. C. Cont. Line; within the limits of land reserved for officers and soldiers of the said line; issued 15 May 1820. Thomas J. Davis of New Hano-

ver Co., N. C., sold the warrant to Calvin Jones of N. C. in 1820, H. Potter a witness.

No. 130. Heirs of Isaac Gumbs, a private in the N. C. Cont. Line; 640 acres within the limits reserved for officers and soldiers of the Cont. Line; issued 2 Dec. 1806.

No. 687. Heirs of William Green, lieutenant; 2560 acres for services in N. C. Line; issued 21 July 1821.

No. 1046. John Grimmage (Grummage), private in the N. C. Cont. Line; 640 acres; issued 26 May 1784, and transferred to Wm. Lytle in May 1785.

No. 1041, Alexander Gill, private in the N. C. Cont. Line; issued 26 May 1784, and assigned to Allen Brewer.

No. 125. Heirs of Ambrose Goslin, private in the N. C. Cont. Line; 640 acres within the limits of land reserved for officers and soldiers of the Cont. Line; issued 18 Dec. 1805.

No. 2377; Grant no. 1823. Samuel Sanford assignee of David Ginn, private in the N. C. Cont. Line; 640 acres in Summer Co.,on the head of the eastern branch of Roaring River; 20 May 1793.

No. 2287. Granted to John Marr, assignee of Isaac Griffin, a private in the N. C. Cont. Line; 640 acres in Summer Co. on the south side of Big Barren River, on the south creek that the Virginia Line crosses that empties into Barren River; May 1793.

No. 165. Isaac Griffith; sergeant in the N. C. Cont. Line; 428 acres within the limits of land reserved for officers and soldiers of the Cont. Line; issued 22 Nov. 1808. The same was transferred to William Horne on 1 Jan. 1784, with Samuel Lockhart a witness. William Horne of Northampton Co., N. C., transferred to Elias Troost of Halifax Co., the warrant on 19 May 1807, with Anson Jeffreys a witness.

No. 536. Heirs of Edward Griffith, sergeant in the N. C. Cont. Line; 1000 acres within the limits of land reserved for officers and soldiers of the N. C. Cont. Line; issued 4 Sept. 1820. Elizabeth Artis, of Edgecomb Co., N. C., only true and lawful heir of Edward Griffith, dec., sold the warrant to Dempsey Bryan and his heirs on 18 Aug. 1820. In Sept. 1820 Bryan sold it to Louis D. Wilson.

No. 1819, Samuel Sanford, assignee of Simon Grimes, a private in the N. C. Cont. Line; 640 acres in Summer Co., on the eastern branch of Roaring River; issued 20 May 1793.

No. 1042. Jacob Gerrard, private in the N. C. Cont. Line; 640 acres. 26 May 1784. He transferred the same to Stockley Donelson, who assigned it to William Tyrrell, who then made it over to Stephen Hills, on 10 Dec. 1796. On 4 Dec. 1795 (sic) Hills assigned it to David Henley.

No. 2461. No. 257. Granted to Nicholas Gibbs, assignee of Martin Armstrong, from lands reserved for officers and soldiers of the N. C. Cont. Line; issued 7 March 1796.

No. 250. James Garret, a continental soldier in the last American war with Great Britain. Pursuant to an act 10 Dec. 1813 the heirs of James Garrett were granted 640 acres within the limits reserved for officers and soldiers; issued 11 Nov. 1814. Thomas Garret of Martin Co., N. C., heir of James Garret, transferred the warrant to Darling Cherry on 29 Nov. 1814, Jesse Cherry a witness.

No. 257 (3318). Heirs of William Herbert, sergeant; 1000 acres; issued 27 Nov. 1816. James Butler and wife Margaret assigned the warrant to John Roberts and his heirs and assigns on 2 Sept. 1817. On 6 Jan. 1819 the warrant was assigned to Geo. Read, with Rob't Read a witness. George Read assigned it to John Roberts, Rob't Read again a witness. On 11 Sept. 1820 Roberts assigned it to Richard Smith of Raleigh, N. C., with Jno. M. Brasfield and Jesse Williams as witnesses.

No. 133 (171). George Farragut; 50 acres. This warrant was issued from a grant for 380 acres of no. 171 dated 8 April 1794, obtained by virtue of a fifty shilling warrant dated 2 May 1803. It was assigned to Charles McClung on 4 May 1803, and McClung transferred it to John Hickey on 9 Feb. 1805.

No. 97 (340). David Haley; 153 acres. This warrant was issued from a grant to Landon Carter for 500 acres, no. 611, dated 12 July 1794 by virtue of a fifty shilling warrant dated 6 June 1803. Registered 29 June 1807. Signed Archibald Roane, Pres. of Board of Commissioners, for East. Tennessee.

No. 574. Daniel Harget, devisee of David Miller, dec., a soldier; 640 acres.

No. not given. John Hathaway of Pitt Co., N. C., for \$50.00 / sold to Calvin Jones of Wake Co., N. C., the land John Hathaway received for his military service in the N. C. Cont. Line, 4 June 1821.

No. 188. Samuel Hollis made oath before Hardy 5. Bryan. Justice of Peace for Robertson Co., Tenn., on 20 Dec. 1809 that his father James Hollis, dec., had several claims for lands in Washington Co. for lands entered in Carter's office, and that James Hollis moved from that place after said office was opened, to Cumberland, and never returned. James Hollis has been dead for about 15 years last April, and that Samuel was young when his father left Washington, and he (Samuel) cannot recollect about the aforesaid entry.

No. 4018. Isaac Herrington, private in the N. C. Cont. Line; 274 acres; issued 25 Nov. 1796. Isaac Herrington of Camden Co., N. C., assigned the same to William Lurry, Jr., of the same county on 9 Feb. 1797. Wm. Lurry of Summer Co., Tenn., assigned the same to Manoah Taylor on 6 Nov. 1803.

No. 171. Heirs of John Hern, private in the N. C. Cont. Line; issued 9 Dec. 1808. Mary Hern of Edgecomb Co., N. C., transferred the same to Daniel Cherry on 22 Dec. 1808, in the presence of Christmon Winam (?), Micajah Windom, and Jesse Florin. The warrant was signed Mary Hearn.

No. 186. Nicholas Hilderman, private in the N. C. Cont. Line; 640 acres; issued 21 Nov. 1809. On 10 March 1810 the same was assigned to Andrew Derr in the presence of Millington Abernathey and Jas. Bleckley.

No. 247. John Hawks, a private in the N. C. Cont. Line; issued 29 Sept. 1814. Mary Sandy of Cravin Co., N. C., only heir of John Hawks, assigned the warrant to Reuben P. Jones on 4 Oct. 1811, with Elizabeth Charlott a witness.

No. not given. William Hays and Elisha Hays of Gates Co., N. C., to Calvin Jones of Wake Co., N. C., transferred a warrant or claim to land to which James Hays a lieutenant was entitled for military service in the N. C. Cont. Line; John Gatling and Andes Jones were witnesses.

No. 1578. John Holley; 100 acres of land in Washington Co., N. C., joining Holley's line, running up to and including the cabin where John Loveday. Two dates: 26 Sept. 1779, and 12 Oct. 1796. J. Carter, E. T.

No. not given. Jones Hays of Hertford Co., N. C., on 22 Feb. 1822, deeded to James Freeman of Bute Co., N. C., a military warrant that Hays became heir to for the service of his father, James Hays, a lieutenant in Capt. Dawson's Co., in the 7th Regt. of the N. C. Line. David Atkins and Will. Miers were witnesses. Solomon White deposed he was personally acquainted with James Hays, a lieutenant in the 7th Regt. of the N. C. Line, and that James Hays married Winniefried Jones of Hertford Co., N. C., and had by her several children, all of whom died except Jones Hays, now living in Hertford Co., the only heir of Samuel Hays. Deposition made 23 Feb. 1822 before Joseph F. Dickinson, clerk of the county court. George H. Bond and Irvin Jenkins witnessed the deposition.

No. 2925. Heirs of Joel Hobbs, private in N. C. Cont. Line; 640 acres; issued 30 Sept. 1785. John Sheppard purchased it from Jacob Hobbs on 3 May 1785. Sheppard assigned it to William King who assigned it to Sterling Brewer on 7 Feb. 1797, with John Horton and Daniel King, witnesses. Brewer assigned it to Samuel Thornton and William Downes.

No. 1964. Anthony Hart: 9 Nov. 1802. On 17 May 1802 Susanna Hart of Davidson Co., Tenn., executrix of the last will and testament of Anthony Hart, dec., according to the will of the dec. sold land in Smith Co., on Caney Fork River on the mouth of Indian Creek, to Thomas Hickman. Date 20 May 1793 is given.

No. 2927. Heirs of Moses Hobbs, private in the N. C. Cont. Line; 640 acres; issued 30 Sept. 1785.

No. 2926. Heirs of Timothy Hunter, private; 640 acres; issued 30 Sept. 1785. On 25 July 1785 James Hunter sold the same to John Sheppard. On 11 Aug. 1806 Reading Sheppard, heir of John Sheppard sold the same to Stephen Montgomery. James Sheppard, heir of John Sheppard, also signed.

No. 3093. William Humphries, private in the N. C. Cont. Line; 640 acres; issued 6 Dec. 1785. The warrant was transferred to S. Donelson and Wm. Tyrrell, who assigned it to Francis Nash. Rutherford Co., N. C. Wm. Humphries of Spartanburgh Co., S. C., appointed Samuel Sevan of Rutherford Co., attorney to sell, act, and demand of Wm. Skiner, Esq., all rights entitled to for services as a soldier in the Cont. Line under the command of Col. Thos. Polk for two and a half years in 1777-1778. Dated 29 Sept. 1792.

No. 3137. Heirs of John Hartley, fifer in the N. C. Cont. Line; 1000 acres; issued 14 Dec. 1785. Joseph Hartley made oath in Beaufort Co., N. C., that John Hartley his brother died in the army of the U. S. during the war with Great Britain without leaving any issue and that Joseph is the eldest brother of the said John. The deposition was witnessed by J. G. Blount, C. Offidant (or Olifant) and Branfort Cannly (?). Joseph Hartley assigned the same to Edward Harris.

Warrant no. 1648 was issued to Thomas Hartley, heir of John Hartley, dec., a private. John Hartley was mustered as a private and died in 1778. "Of course warrant no. 1648 is good and this warrant (no. 3137?) is not good unless better proof

is made."

No. 537. Heirs of Peter Higgins, a private in the N. C. Cont. Line; 640 acres; issued 4 Sept. 1820. Elizabeth Higgins signed the warrant away on 5 Sept. 1820 to Bartholomue Bowers and Stephen Higgins of Edgecomb Co., N. C., the only true and lawful heir of Peter Higgins a Cont. soldier in the Rev. War, in the presence of Riddick Barnes and Eli Anderson. Bowers assigned the same to James W. Wilson on 4 Sept. 1820. On 19 Oct. 1820 the same was assigned to Louis D. Wilson.

No. 488. Betsy Jones formerly Betsy Hockaday, and Worrick Hockaday, heirs of William Hockaday, private in the N. C. Line; 640 acres (no date shown).

Grant no. 1506. John Henly; 640 acres on south side of Red River adjoining Martin Armstrong's Middle Corner adjoining Parson Boyd's claim, 4 Jan. 1792. This grant was vacated for 338 and 3/4 acres, certificates having been issued for that amount to the grantee (see nos. 2202 and 2203). 1 May 1822, Tennessee County.

No. 2805. Heirs of Thomas Harwood, private in the N. C. Cont. Line; issued 30 Sept. 1785, and assigned to Sterling Brewer on 3 Oct. 1785, and then assigned by Brewer to Thomas Molloy. On 1 Aug. 1785 James Harrowood endorsed the warrant to William Harrowood.

No. 437. Heirs of Reuben Hamm, private in the N. C. Line; 640 acres; issued 26 Nov. 1796.

No. 249. Laurence Hare, a lieutenant in the N. C. Line. A grant of 914 acres in Davidson Co., on both sides of Cedar Creek, adjoining Col. Murphey's, was made to Hardy Murphy, assignee of the said John Laurence Hare. Warrant no. 115, located 5 July 1784.

No. 264. Heirs of Isaac Hardy, a lieutenant of the N. C. Cont. Line; 1097 acres; issued 10 Dec. 1817. Abraham Hardee of Pitt Co., N. C., sole heir to Isaac Hardy, dec., a lieutenant in the Rev. War, assigned the grant to William Hill on 24 Nov. 1808, with John Phillips and Richard Evans as witnessed.

No. 265. Heirs of Wm. Henson, private; 640 acres; issued 18 Dec. 1817. James Hinson, the proper owner of the warrant assigned it to Darling Cherry on 2 Feb. 1818. Cherry assigned it to James Vaulx on Nov. 1818. Eli Cherry, attorney for his brother Darling Cherry, signed the transfer.

No. 870. Heirs of Zachariah Hampton, private; 640 acres; issued 23 Aug. 1821. John Hampton transferred the same to John Terrell on 11 Sept. 1821, witnessed by Wilbourn F. Hampton and William Clement. John Washington deposed before Richard Sneed, a justice of the peace for Granville Co., N. C., that he was well acquainted with Zachariah Hampton, reported to have died of wounds received from the enemy at the Hughtaugh (Eutaw - R. B.) Battle in the Revolutionary War. John Hampton is the oldest son and rightful heir of said Zachariah, dec. 20 July 1821.

No. 159. Capt. John Herritage, captain in the N. C. Line; 1280 acres; issued 22 Oct. 1783. William H. Bryan, one of the heirs at law of John Herritage, dec., for himself and for James Bryan, the other heir, all right and title to Thomas Shute, his heirs and assigns, assigned all land granted said Herritage. The transfer was dated 31 Aug. 1808, Isaac Shute a witness.

On 28 June 1821 Israel Harding of Beaufort Co., N. C., for \$10.00, transferred his right and claim to land due to Abraham Harding to John Bartholomew of FRanklin Co., N. C.

No. 376. Heirs of John Harrell, private in the N. C. Line; 228 acres; issued 29 July 1820. Lewis Harrill of Greene Co., N. C., only lawful heir of John Harrell, a continental soldier, transferred the warrant to Roderick Cherry. Cherry transferred it to Eli Cherry on 12 Aug. 1820, with Wm. Bell, Wm. Anderson, and Laurence Cherry as witnesses.

No. 980. Joshua Harvey; 640 acres; issued 22 May 1784. Jno. H. Bryan, agent, transferred the warrant to Thos. Henderson.

No. 3538, Robert Howell, private; 274 acres; issued 15 Feb. 1786. On 7 Sept. 1789, Robert Howell assigned the same to Stockley Donelson who transferred it to William Donelson on 25 Aug. 1795.

No. 4399. Heirs of David Hatfield, private; 640 acres. Richard Hatfield, Sr., heir of David, assigned the warrant on 24 Aug. 1797 at Perquimans Co., N. C., to Thomas B. Littlejohn, who made it over to Wm. Shute.

No. 3511. Heirs of Zachariah Hughs; 640 acres; issued 8 Feb. 1786. Ben Harrison made it over to Robert Hooks, Esq., on 9 Feb. 1786.

No. 4562. Adam Hampton; 228 acres; 9 Feb. 1797. It was assigned to Sterling Brewer on 12 Feb. 1797, with William Reed and Jesse Sharp as witnesses. On 7 April 1797 Brewer assigned the warrant to Peter Johnson, who transferred it to Abner Pillow on 3 Aug. 1804, with Geo. W. Payne and A. Mathes as witnesses.

No. 3128. Thomas Hickman; 640 acres on 14 Sept. 1797, the land having been issued to Simon Sumhley (?), a private in the N. C. Line. The land was located on the waters of Big Barron, Caney Creek, in Sumner Co., on 22 Sept. 1797.

No. 690. John Laughinghouse of Pitt Co., N. C., made oath before Bryan Grimes, Justice of the Peace, that he, John Laughinghouse, was a soldier in the N. C. Cont. Line, and that he knew Abraham Harding who enlisted and served in the said line, and that Harding was taken sick at Santee Hills and carried to a hospital in Camden, S. C., where he died. Abraham Harding was never married and left a brother Israel Harding who in 1821 was living in Beaufort Co., N. C. Sworn on 17 June 1821 (See no. 690 above).

No. 1917. James Hays; 640 acres in Summer Co., in 1796. David Humphries was a private in the N. C. Line. Land was on Cedar Lick Creek.

No. 329. Heirs of Thomas Hill, corporal; 357 acres; 30 May 1820.

No. 5198. Heirs of Benj. Hill, private; 640 acres; 9 Dec. 1797. Richard Hill assigned the warrant to William Lytle on 10 Dec. 1797.

No. 544. John Hill, lieutenant; 2560 acres; issued 20 April 1784.

No. 685. Heirs of Jesse Harris, private; 640 acres; issued 23 May 1821. John Harris assigned it to John Jenkins on 6 June 1821. No. 146. Heirs of Jesse Harris, a private; on 10 Feb. 1807 the warrant was transferred to 0. P. Nicholson, with Edward Harris and John Nicholson as witnesses. Samuel Bailey made oath onl1 May 1821 in Wake Co., N. C., before William Reavis, a Justice of the Peace, that he was acquainted with Abner Harris and Jesse Harris, who enlisted in the Cont. Line, and that they were sons of William Harris, dec., and that John Harris of Cheatham Co., Tenn., and was a brother and rightful heir of Abner and Jesse Harris.

No. 311. Heirs of Henry Hanners, private; 640 acres; issued 23 Feb. 1820. Thomas Hanners, George White, Frankey White, Joel Ethridge and Elizabeth Ethridge, part of the heirs of Henry Hanners, a continental soldier, sold the warrant to Laurence Cherry on 10 March 1820, with Isham Anderson and Malbourn Kilgro as witnesses.

No. 954. James Hayes. James Brown of Gates Co., N. C., made oath on 22 Aug. 1821 before Henry Gilliam, J. P., that previous to and during the Rev. War he knew well a James Hayes who entered the N. C. army as a lieutenant and marched to the north where he died, as the deponent was informed by a soldier of the army, as well as from a common report of his friends and connections, and adding the circimstances of his never having returned from the said army. James Hayes was not married and left an only brother named Jacob Hayes who married and is now dead and leaving by marriage only two sons, William Hayes and Elisha Hayes, both now living in Gates Co. The heirs of James Hayes, lieutenant, were issued 2560 acres. The grant was transferred by Calvin Jones to James Kimball.

Robert Patterson of Grainger Co., on 10 Sept. 1807 made oath before Charles Hutcheson, J. P. for the said county, and stated that he believed that in 1787 he was called by Thomas King a chain carrier on the head waters of Flat Creek, and they made and marked a corner, they did not run any line on the said survey, and now they cannot find any corner of the same.

Joseph Cobb made oath on 16 Aug. 1814 before Thomas Henderson, J. P. for Crainger Co., Tenn., that he made a search for a tract of land no. 431 for 1000 acres granted Thos, King by

N. C. and was unable to identify same, 10 April 1800. Thos. King of Hawkins Co., deeded the land to Francis Mayberry of Knox Co., Tenn. The land was in Grainger Co. on the waters of Flat Creek. Thomas Jackson and Joseph Gentry were witnesses. Another deed dated 7 April 1798 was between William Henshaw of Jefferson Co., Tenn., and Stephen Stafford of Grainger, with NathanielPeters and Elihu Swain as witnesses. A plat showed the interference of grants 131 and 133 and 2497. On 15 April 1807 a certificate showed Francis Mayberry's military warrant no. 3803 was issued to the heirs of James Horseford for 640 acres; signed Robert Searcy, clerk of commission for West Tenn. No. 2497 for bravery of James Horseford, private, granted to Francis Mayberry, 640 acres in Eastern District. Registered in Campbell Co., Tenn., on 20 Sept. 1809, Book A, page 100.

No. not given. Thos. Harrowood, a revolutionary soldier. See Petition of Executors of Thomas Mallory in Davidson Co., Tenn., in 1807.

No. not given. Henry Hicks, private; 300 acres; 14 April 1792. Hicks served in a battalion of troops raised pursuant to an Act of our General Assembly for protection of the inhabitants of Davidson Co. for the first half year's pay; land west from the Cumberland Mountains.

No. 4756. John Hawthorn, private; 274 acres; issued 27 Feb. 1797. The warrant was assigned to Robert King on 17 Oct. 1797. William Lackey for Robert King assigned it to John Brown (?) on 5 June 1803. John Brown (?) assigned it to Nathaniel Steele on 17 Nov. 1825.

No. not given. Roger Herndon, a revolutionary soldier. See petition of executors of Thomas Mallory in Davidson Co., Tenn., in 1807.

James Hawkins (or Hawkins Hames), revolutionary soldier. See Secretary State papers, Archives, Legislative Papers and petitions where Hawkins stated he served at the surrender of Cornwallis.

No. 4620. James Hanley, private; 228 acres; 9 Feb. 1797. The warrant was assigned to Sterling Brewer on 18 Feb. 1797.

No. 3924. Heirs of Conrod Halfaker, private; 640 acres; issued 8 Dec. 1795.

No. 4612. Heirs of Thomas Hair, private; 640 acres; issued 9 Feb. 1797. James Hair assigned the warrant to Sterling Brewer, with James Horton a witness. Brewer assigned the land to William Tyrrell, 4 March 1797.

No. 508. Hardy Hawkins, private; 274 acres; 2 April 1784.

No. 4615. Heirs of Charles Hughlet, private; 640 acres; 9 Feb. 1797. John Allen, sheriff of Stewart Co., sold to Beunch Searcy the grant for \$5.00, in 1810. Daniel Hughlett sold the warrant to Sterling Brewer.

No. 4616. Heirs of Carter Harter, private; 640 acres; issued 9 Feb. 1797. Zebulon Harlord (?) as heir sold it to Sterling Brewer who sold it to William Tyrrell on 4 March 1797, and later sold by the sheriff of Stewart Co., Tenn.

No. 3130. Thomas Hickman; 640 acres in Summer Co., Tenn., granted for services of Robert Williams, a private, on 22 Sept. 1797.

No. 334. Heirs of Robert Howe, a major general; 16,000 acres; 19 May 1820.

No. 3601. Located 7 March 1797. Benjamin Jossling, assignee of Alexander Patten, issued originally of Samuel Hart, 274 acres of land in Davidson Co., on the first creek on the east side of Harpeth (River) below Joneses Creek, one and half miles above the mouth; survey dated 5 Sept. 1797.

Nos. 691 and 3531. Nancy Sheppard, 640 acres; 11 July 1788. (See no. 930 for evidence). Holladay Hathcock, private in the N. C. Cont. Line, assignee of Nancy Sheppard; 640 acres on Cycamore (Sycamore?) in Davidson Co.

No. not given. John Hart of Northampton Co., N. C., a soldier in the N. C. Line of Cont. Army in the Rev. War, deposed that before the war he well knew John Edwards, who enlisted in the said line for and during the war; that he was a corporal in Child's Company and that the said Edwards through the inclemency of the weather was taken sick with a combination of complaints so far that he was deemed unfit for service and returned home to Northampton where the said Edwards died leaving by marriage six children, to wit: James Edwards died leaving by marriage six children, to wit: James Edwards, Mathew Edwards, Martha Edwards, Rebecca Edwards, Charles Edwards, and Temperance Edwards, all of whom live in Northampton Co., and who J. Tyrrell sold the same to Allen Brewer, with Nathan Markland and Barnet Rogers a witness. John Taylor, Sr., of Orange Co., N. C., for natural love and affection he had towards his son John Taylor, Jr., transferred the warrant to him in 1805.

No. 2874. Heirs of John Rainer, private in the N. C. Cont. Line; 640 acres; issued 30 Sept. 1785. Richard Rainer transferred the same to Thomas Dillon on 7 Oct. 1785, with Jacob Winkles (or Winkler) a witness. Dillon transferred the warrant to Jonathan Magness on 13 July 1803.

No. 655. James Roz, a fifer, in the artillery of N. C. Cont. Line; 1000 acres; 23 April 1784.

No. not given. Alexander Reed deposed "respecting my service right how I have missed obtaining land for it. Gen. Robertson as to locate and survey my land allowed one for my service as a chain

cerrier when he went down the river on the Mississippi, surveying and when he and his surveyor, Henry Rutherford, Esq., both returned. Gen. Robertson told me that he had done it and likewise he had surveyed a 600 acres by virtue of a Treasury warrant of that quantity. I purchased of a Mr. Kuykendall he told me himself he had run off one of the tracts and Henry Rutherford the other. Some time after Mr. Rutherford met me in Nashville and told me that money was wanting to clear the expenses and likewise the certificate I had from the commissioners. I gave him my certificate, but I told him if Gen. Robertson would furnish him with sufficient money I would settle with him for the same as the General owed me for schooling his children being at school with me at Nashville then. I heard no more bur before Esq. Rutherford returned from the Settlement I received a patent for my 600 acres Treasury warrant, but no account of my service right. When Rutherford came here I asked him about my service right, he told me several times he did not know nor remember anything of it, although I expected surely the grant for my service right would come the same time the grant for the Treasury warrant because Henry Rutherford's name is to the Plat that is with the patent of the Treasury Warrant which I have now in my possession and recorded in this county; likewise I have not sold, (or) gave away...said service right to any person whatsoever. (Signed) Alexander Reed. Sworn before Thos. A. Claiborne on 19 July 1806. Major John Buchanan came before Thos. Claiborna and certi-

Major John Buchanan came before Thos. Claiborne and certified that Alexander Reed served a tour of duty as a chain carrier the second time the boundary line for continental officers and soldiers was run, under the direction of Gen. Robertson, Gen. Rutherford and Major Tatum, commissioners. Sworn to on 19 July 1806. James Mulherrin also certified to the above certificate.

No. 9. Elijah Roberson, quartermaster of the guard appointed to the commissioners to lay off the lands granted the Cont. Line; 625 acres on Duck River at the mouth of Beaver Creek, Jan. 1786. #### BURK MARRIAGES IN FRANKLIN COUNTY

Note: Franklin County, Tennessee, was erected on 3 December 1807 from Warren and Bedford Counties, and was named in honor of Benjamin Franklin. The county seat of Winchester was named in memory of General James Winchester. The site for the county seat was purchased from Christopher (sic) for the price of one dollar. The first county court was held at the home of Major William Russell in 1808, and the county courts were held in Winchester beginning in 1814.

# MISCELLANEOUS NOTES ON HAWKINS COUNTY

This county took its name from Benjamine Hawkins, who as United States Senator, conjointly with Senator Samuel Johnston, who on 25 Feb. 1790, executed the deed which transferred what is now Tennessee to the United States.

The early settlers of this county were largely from North Carolina and Virginia. A few Pennsylvania and New England natives came here. Among those first settlers were some families which are still among the leading families of the county. Some of these families were: Amis, Mulkey, Carter, Parker, Love, Kinkeads, Longs, Gillenwaters, Lucas, Parsons, Bradley, McKinney, Miller, Powell, McMinn, Cocke, Rogers, and Armstrong.

In the early days of the state, no county contributed more to the education of its population than did Hawkins County. Some of the early notable teachers were: John Long, 1783; William Evans, 1784; James King, 1786; Samuel B. Hawkins, 1796.

Rogersville, the county seat, was named in honor of Joseph Rogers, one of the early settlers.

The first will recorded in Hawkins County was that of Thomas Amis, 6 Nov. 1797. This will is on the first page of the first will book. There may be other wills but they were not recorded in the probate books, and if existing may be among the rapidly detereorating old papers scattered in the four corners of the ancient courthouse.

The will of Thomas Amis, dated 6 Nov. 1797, names his wife

wife Lucy, children John, Willis, Thomas Gale, Haynes, Tabitha, and Mary. John Ray, Esq., Col. James Armstrong, Wm. Armstrong, Esq., Joseph McMinn, Esq., and Wm. Howard, Surveyor, were requested to divide the estate.

The next will recorded in the county is that of William Amis, dated Dec. 1809, on p. 3.

William Armstrong's will, dated 17 Feb. 1810, but probated in 1809 (sic) is also on p. 3. He names his wife Abinah Armstrong.

The will of John Armstrong, dated 17 April 1813, and proved in 1813, on p. 4, names wife Jane, "plantation in Carter's Valley," daughter Jane Armtrong, son Thomas, daughter Amos Baker, daughter Mary Armstrong, and son Baker. Thomas Armstrong and John Young were to be executors.

#### NOTES ON HENRY COUNTY

Henry County was erected on 7 Nov. 1821, and named in honor of Patrick Henry. It was taken from the Western District.

John B. House was the first settler in 1819. Among the other early settlers were: Joel and Willis Hagler, Alex Harmon, John Young, James and David D. Greer, Samuel McCorkle, Johannon Smith, William Walters, Rev. Benjamine Reoples, Rev. John Mauly, Abraham Walters, William Porter, Thomas Grey, Adam Rome, and others.

The first court was held on Monday, December, 1821, at the home of Peter Wall.

The county seat of Paris was laid out by commissioners in 1823. Joseph Blythe and Peter Ruff were the commissioners selected by the Legislature.

Henry County is not an old county, but it is a progressive one. Paris is a thriving town as well as the county seat. The records of the county are preserved but are not classified or arranged in any degree of system, many being original papers tied in packages.

The county is bounded on the north by Kentucky, on the west by Weakley County, Tennessee; on the south by Carroll County, Tennessee; on the southeast and east by Benton County and Stewart County. The Tennessee River divides this county from Stewart on the east, and is spanned by a handsome new bridge erected by the State in 1932.

Moses Ellis lived in Wilson Co., Tenn., in 1820, and had a

Robert Ellis and family were in Wilson Co. in 1820. Thomas Ellis and family were in Wilson Co. in 1820. John Ellis and family were in Wilson Co. in 1820. James Ellis and family were in Wilson Co. in 1820.

Benjamine Ellis, Presley Ellis, and Isaac Ellis resided in the lower end of Summer Co., in 1799. Benjamine Ellis, Willis Ellis, and Abraham Ellis lived in the upper part of the county in the same year.

In 1820, James G. Elliff (sic), Similion Ellis, Ransom Ellis, James Ellis, Everd Elliff (sic) all lived with families.
Sims Ellis, Aaron Hudson, and Stephen Ellis all lived with families in Robertson Co. in 1820.

Miles Elliss and family were in Montgomery Co. in 1820. Underhill Ellis was in Capt. Joshua Hadley's Company of Evans Battalion, for the protection of settlers in Davidson Co. in 1787.

George Ellis married Jeniah Holton on 3 April 1802 in Montgomery Co.

John Ellis married Masson Thompson on 25 May 1802.

A number of Ellises were mentioned in deeds in Summer Co. on 28 Nov. 1805.

Everett Ellis married Polly Carlson, 17 Sept. 1806, Summer Co.

James Elliss married Susannah Cottron on 4 Sept. 1813. Simon Ellis married Delilah Smith on 25 Nov. 1808, with Abraham Ellis a surety.

Abraham Ellis married Prudence Lindsey on 24 April 1800. William Ellis of Cumberland Dist. and Jno. McFarland, Bill of Sale, 7 Dec. 1781, in Davidson Co. Will Book no. 1, name 8

North Carolina Certificates of Survey Military Warrants: Robert Ellis; John Ellis a private in the N. C. Line (his grant was transferred to Thos. Henderson, 1820).

Tennessee Grants also show Charles Ellis a private. Edward Ellis will made 20 May 1800, proved 1800 (Davidson Co. Wills, Book 2, page 175) named Edward Ellis of Davidson Co., wife Sarah Ellis to have all estate real and personal, daughter Abbee Ellis. Thos. Hickman a witness.

There is an Ellis graveyard on Stewart Ferry Road in Davidson Co., but no old stones with markers.

Wm. E. Ellis married Mary Ann Ellis on 12 Feb. 1838 in Dickson Co.

William Ellis was in War of 1812, from Davidson Co.
Simeon Ellism orphan, age 9, bound to William Crockett to
learn art of tanning and curing. (Summer Co. Minute Book, 1818,

Margaret Ellis appointed guardian for her five minor children: Robert, Samuel, John, Thomas, and Joshua. Isaac Ellis and Joseph Spradlin were her securities. (Summer Co. Minute Book, 1832-1834, p. 11).

Inventory of Robert Ellis, dec., taken 17 Aug. 1820, and returned Aug. Term, 1820, signed by Somelling and Abram Ellis. (Summer Co., 1808-1821, page 446).

Samuel Ellis, private in the Revolutionary War in the N. C. Militia, was pensioned in Adair Co., Ky. He was born 9 April 1762 in Montgomery Co., Md.; entered service in Rowan Co., N. C. and lived there for three years after the war. He moved to Surry Co., N. C., then back to Rowan Co., and in a few years to Burke Co., then to Jefferson Co., Tenm., until 1826 when he moved to Cumberland Co., Ky., where he lived until 1832, when

he settled in Russell County, Kentucky, where his wife died. He had a son and two daughters. His pension began 4 March 1831.

#### Etheridge

Emerson Etheridge was born in Currituck Co., N. C., in Oct. 1819. His farmer was a farmer and migrated to Weakley Co., Tenn. from N. C., about 1821.

## Ezell

Margaret Ezell died 1874, about 86 years old. She is buried in the Ezell graveyard near Buchanan's Creek in Giles Co., Tenn. She died at Milton Buchanan's in Lincoln. Her husband was W. M. Ezell. The graveyard is on the edge of Pulaski, Giles Co. Tenn. Other graves are there also.

#### Gilliland

James Gilliland of East Tennessee married first a Miss Painbow and second a Miss Cable. James had a brother Hamilton Gilliland who lived and died in White Rock, Tenn. Another brother, David Gilliland, went to Alabama.

John Gilliland was on the first grand jury of Jefferson

Co., Tenn., in 1792.

John Gilliland was a member of the Convention held at Greenville, Tenn., with Jno. Sevier and Jno. Tipton.

Abel Gilliland settled on Wolf Creek about five miles from Pell City, Alabama. He had two sons, Patrick and Wesley Gilliland. A Methodist Church was erected on the land occupied by Gilland or Gilliland. The church has been discarded and the membership moved to Eden, some three miles away. There was an old graveyard at the church, which has not been used for some fifty years, and is badly neglected. Wesley Gilliland is said to have moved to Texas. Abel Gilliland was from East Tennessee.

James Gilliland lived on what is known as the fork of Pegeon River and was prominent in the early history of Cocke Co., Tenn. His family intermarried with the Axley family. They also intermarried with the family of Peter Huff who lived on the French Broad River.

In the Davidson Co., Tenn., records, Will Books 1 and 2, pages 188, 200, 201, 345, and 346, are mentions of James Gilliland. 23 Aug. 1800, James Gilliland names his family, Robert, Daniel, James, and wife Nancy. James was the youngest son, and a daughter Sarah would be 21 years old in 1800.

One James Gilliland was a leader in the Zion Church. His wife was a sister of Jas. Axley and an excellent woman. This is the Cocke Co., Tenn., Gilliland family. Abel Gilliland, a brother of James, was a remarkable man. In 1821 he moved to Wolfe Creek, St. Clair Co., Alabama, and founded a church at that place. Before he left Cocke Co., he gave land between French Broad and Pigeon Rivers one mile west of Newport for the erection of a church.

John Gilliland was granted land in Greene Co., on French Broad, an island in Warford.

Silas Jasper Gilliland was in the early history of Tenn.
