#1350 p. 367 KING GEORGE, the Second, land grant to ANTHONY HERRING (county not given), April 5, 1749, for a tract of 280 acres in Craven Co., N. C. lying on the north bank of Neuse River. Note: This deed may not be complete.

#1351 p. 367 CHARLES HOPTON, acting executor of the last will and testament of CHARLES HOPTON, Sen'r, deceased, deed to MARY HOWELL, a legatee in said will, Oct. 30, 1792, for all the right, title, and claim of the deceased to two certain tracts of land in Wayne Co. lying on the north side of Neuse River and west side of Hoptons Pocoson as follows: (1) beginning near THOMAS BOYKIN's line; (2) adjoining and between the lines of CHARLES HOPTON, DAVID JERNIGAN, THOS. BOYT, and JAMES BARBER, containing in the whole 300 acres, the first tract of 100 acres being a patent bearing date May 23, 1757, and the second tract of 200 acres being a patent bearing date April 9, 1770. ## INTRODUCTION

This volume is the last of the four volumes of land entries for the old Dobbs County area which were issued by the new State Government after the break with Great Britain. It contains those entries which were filed by the entry takers of Wayne County in the Entry Books and sent to the Secretary of State for issuance of grants to the claimants on July 1, 1796.

When the Entry Taker received the entry, he entered it into the Entry Book, numbering each as it was received. In this volume as in all the preceding ones, there is some misnumbering and loss of entries, so a number has been assigned to each entry for easy reference by the researcher. When searching for a reference in the index, the number will be that assigned to the grant abstract, not the page number of the entry or the number originally assigned by the Entry Taker.

In each entry, the date of the entry is given, the claimant making the entry, the number of acres claimed and the bounds of the entry. If a caveat was made against the entry or it was withdrawn or otherwise contested, the date, dissenting landowner, etc are also given.

Wayne County lay in the area of North Carolina which was formed from Johnston County into Dobbs County on April 10, 1759 and named for Arthur Dobbs governor of the state at the time. The first county courthouse was on Walnut Creek in present day Wayne County. It was located at Bizzell's Millpond on Secondary Road 1731 at its junction with Secondary Road 1730 about three miles south of Highway 70 and two miles west of the Lenoir County line. It remained the county courthouse for Dobbs until Wayne was formed, at which time the Dobbs Courthouse was moved to the present city of Kinston, then Kingston, in Lenoir County.

In 1779, William Caswell, Charles Markland, William McKinne Sr., Etheldred Ruffin and Benjamin Cobb were appointed Commissioners to run the dividing line east to west through the middle part of the county to set up a new county on the western side of the line. This county was to be called Wayne in honor of "Mad" Anthony Wayne, one of Washington's most trusted but rash soldiers. The first courts were held at the home of Josiah Sasser on Little River near Pearson's Bridge from 1779 until 1782. After 1782, the courthouse for this county was built on the west side of the Neuse river on the lands of Andrew Bass. But it was not until 1787 that Waynesboro was established on the courthouse site to serve as the county seat. In 1847, the court house was moved to Goldsboro, which had grown up on the Wilmington and Weldon Railroad several miles north of Waynesboro. Goldsboro, named for Matthew T. Goldsborough, civil engineer and surveyor of the Wilmington and Weldon Railroad, continues to be the county seat.

In 1855, Wilson County was formed from parts of Edgecombe, Nash, Johnston and Wayne Counties with the section of Wayne used described as "at the Juniper Swamp; thence the Wayne and Johnston lines north, to a point in a direct line from the Red Hill to Ruffian's bridge; thence a direct line to Ruffin's bridge, diverging north at the house of Jacob Hooks, so as to leave the dwelling house of said Hooks in the county of Wayne; thence from said Ruffin's bridge down Contentnea creek to the Greene County line, . . . ." This line between Wilson and Wayne was settled in 1859 with some little change. This took all the land in the Black Creek area of Wayne County away to form parts of the present Wilson County Townships of Black Creek, Crossroads and Stantonsburg.

One way of obtaining land in Eighteenth Century North Carolina was by land entry. Most entries were made under an act of General Assembly of 1777 in which a land entry system was established within each county.

Under this system, an Entry Taker and Surveyor were appointed and citizens were allowed to enter claims on any land which had no legal owner. Such unseated land was technically the property of the State. A person could claim 640 acres for themselves and 100 acres each for a wife and children. Entries were restricted to only 640 acres in one parcel if adjoining vacant land and 1000 acres if surrounded by claimed lands. The claimant had to provide a description of the land he wished to enter and pay the fees. The Entry Taker entered the same in the Entry Book with each entry dated and numbered. After a set period of time, if no one protested the claim, a warrant was issued ordering the Surveyor to make a survey of the land. Two plats were prepared along with a verbal description and were sent to the Secretary of State. Here they were used to prepare a grant or patent which was then sent to the claimant who registered it and thus became the legal owner.

If the land being entered appeared to be owned by someone already, the owner, to prove his claim, issued a caveat against the entry. Caveat, from the Latin meaning "let him beware", was a formal notice to the Entry Taker to prevent the entry being granted before the dissenting land owner was heard. These disputes were usually settled by juries who could rule to void the entry if the lands was found to be owned in part or whole by another person, or the claimant could voluntarily withdraw the entry.

When the bounds of the land were finally surveyed, the amount of land within the bounds or the bounds themselves could need restating, so that in many entries, there is a difference between the entry and the final survey and grant. The size and shape of many later patents tended to be small or oddly shaped as the availability of land began to dwindle and most patents were made by landowners who discovered gaps in their lines or unclaimed pockets of land adjoining their property.
